***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 28-G in the area bounded by

beginning at the west line of vacated Desplaines Boulevard (south of the south line of Diana Street); South Halsted Street; West 119<sup>th</sup> Street; the alley next east of South Green Street; a line from a point 49.74 feet northeast of West 119<sup>th</sup> Street as measured along the east right-of-way line of the alley next east of South Green Street to a point, 103 feet northwest of the intersection of South Halsted Street and West 119<sup>th</sup> Street as measured along the west line of vacated Desplaines Boulevard to the point of beginning,

to those of a C1-1 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

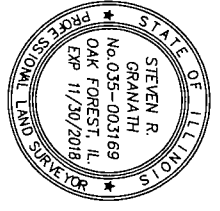
