ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **RM-5 Multi-Unit District**, as shown on Map 5-I in the area bounded by:

West Fullerton Avenue, a line 100 feet east of North Maplewood Avenue, the alley south and parallel to West Fullerton Avenue and a line 125 feet east of North Maplewood Avenue.

To those of **B2-3 Neighborhood Mixed Use District**

SECTION 2. This ordinance takes effect after its passage and approval.

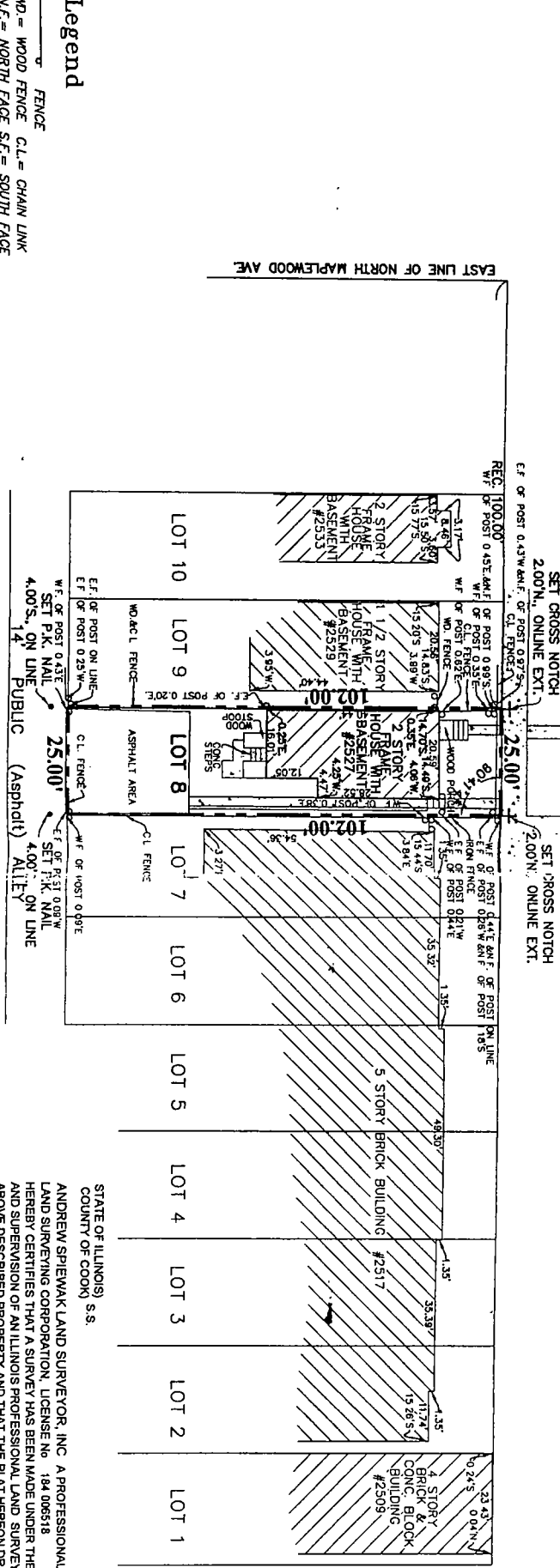

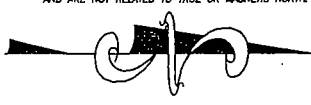
