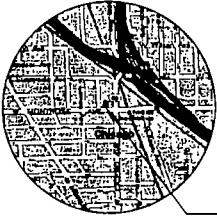

VICINITY MAP

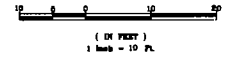

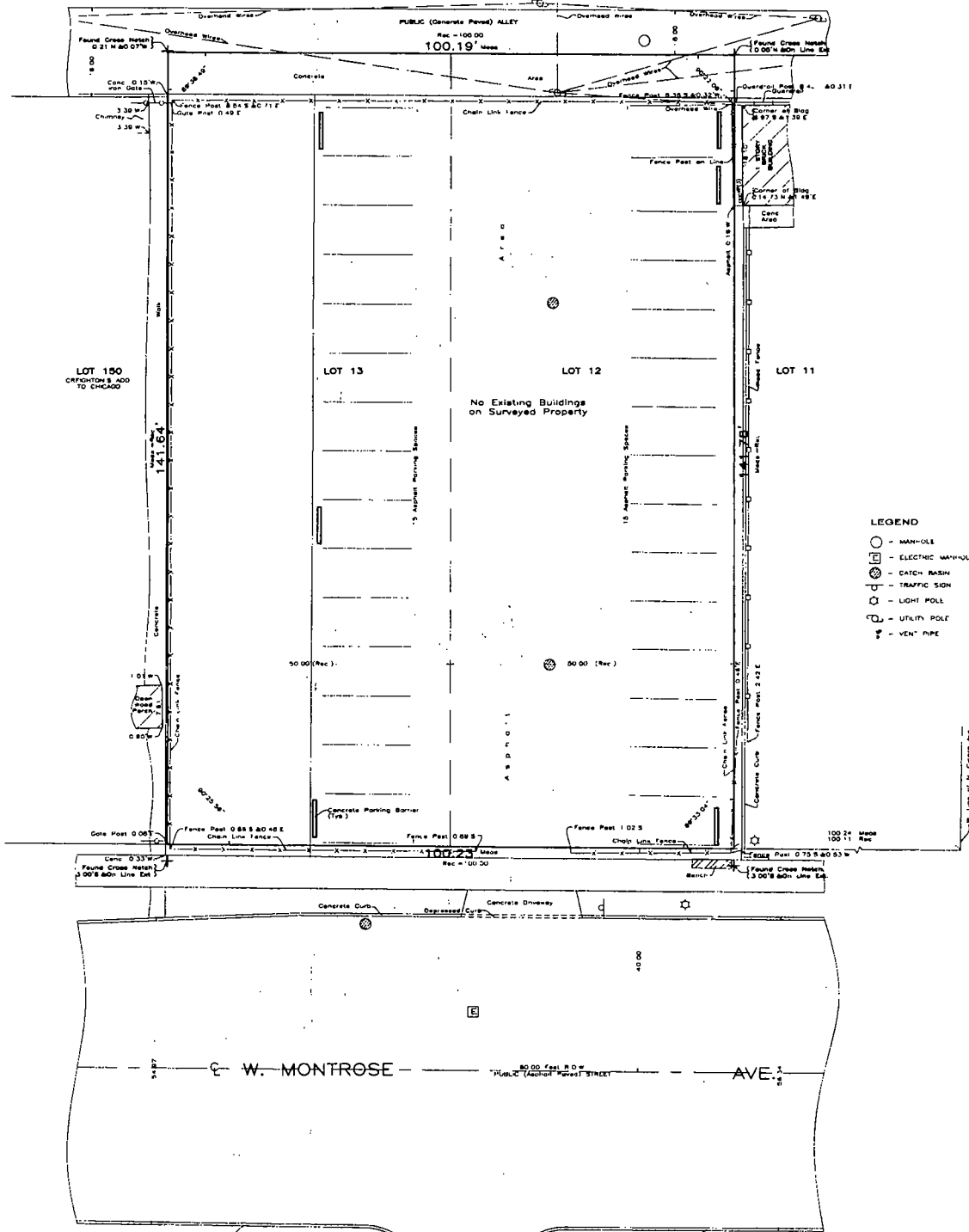


