Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to VICTORY'S BANNER RESTAURANT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Awning(s) projecting over the public right-of-way adjacent to its premises known as 3406 N. Hoyne Ave..

Said Awning(s) at W. Roscoe Avenue measure(s):

One (1) at eleven (11) feet in length, and two (2) feet in width for a total of twenty-two (22) square feet.

Said Awning(s) at N. Hoyne Avenue measure(s):

One (1) at six (6) feet in length, and two (2) feet in width for a total of twelve (12) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114214 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.



Permission and authority are hereby given and granted to CARNICERIA RUIZ INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 3001 N. Kedzie Ave..

Said Awning(s) at Corner of N. Kedzie and W. Wellington measure(s):
One (1) at forty-three (43) feet in length, and two (2) feet in width for a total of eighty-six (86) square feet.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1113583 herein granted the sum of sixty-eight (\$68.00) per annum in advance.
