BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

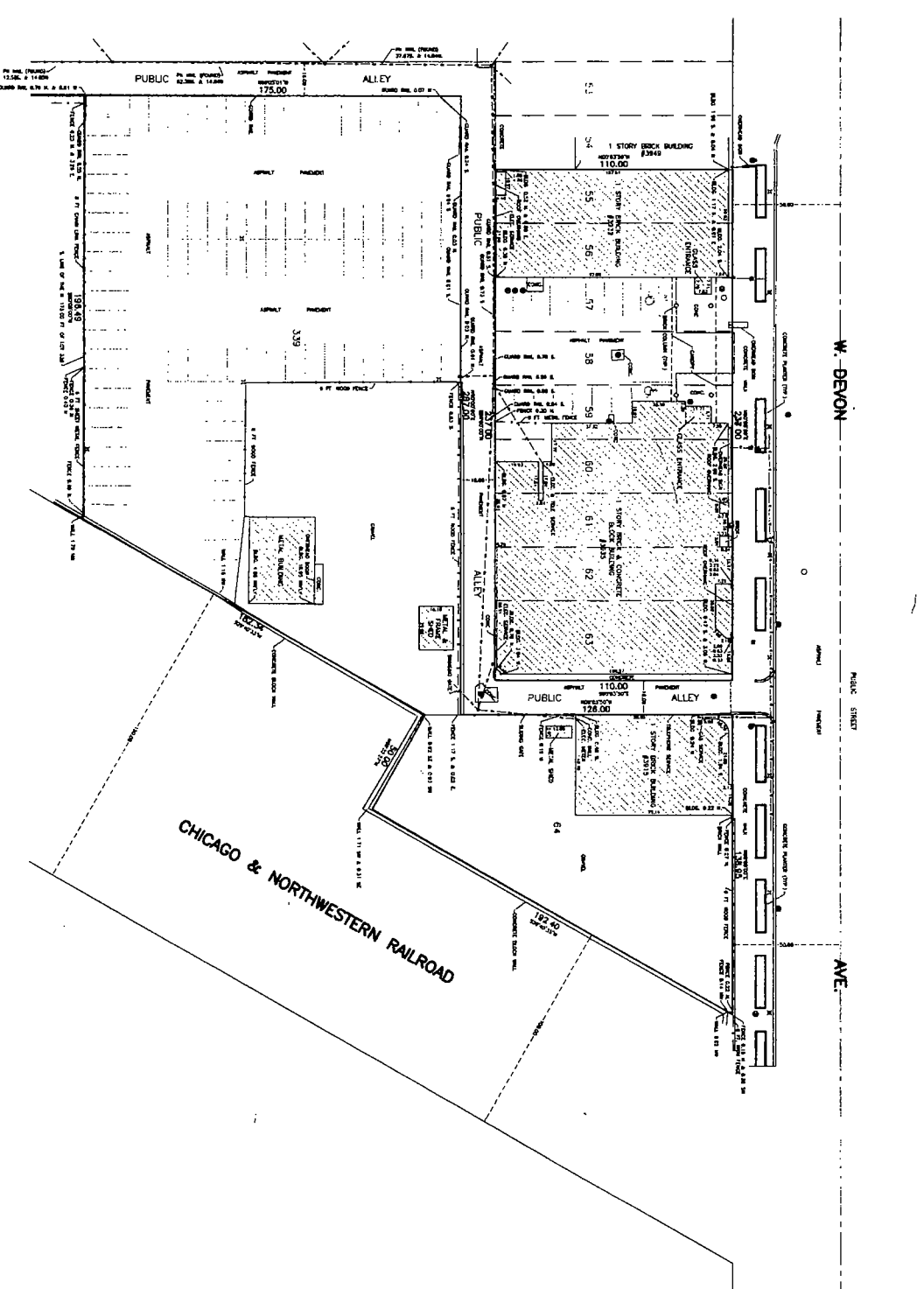
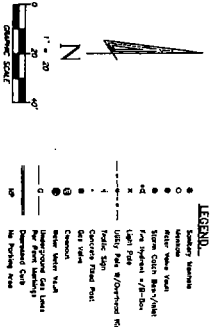

The analysis indicates that the sample is a soluble polymer containing carbon, hydrogen, nitrogen, and oxygen. The molecular weight of the polymer is estimated to be approximately 100,000.

It is expected that these actions will be completed by the end of the quarter, and the project will be formally closed out.
