**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2, Community Shopping District symbols and indications as shown on Map No. 3-G in an area bound by

North Milwaukee Avenue; West Haddon Avenue; the public alley next southwest of and parallel to North Milwaukee Avenue; And a line 25 feet west of and parallel to West Haddon Avenue

to those of a B2-3, Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.

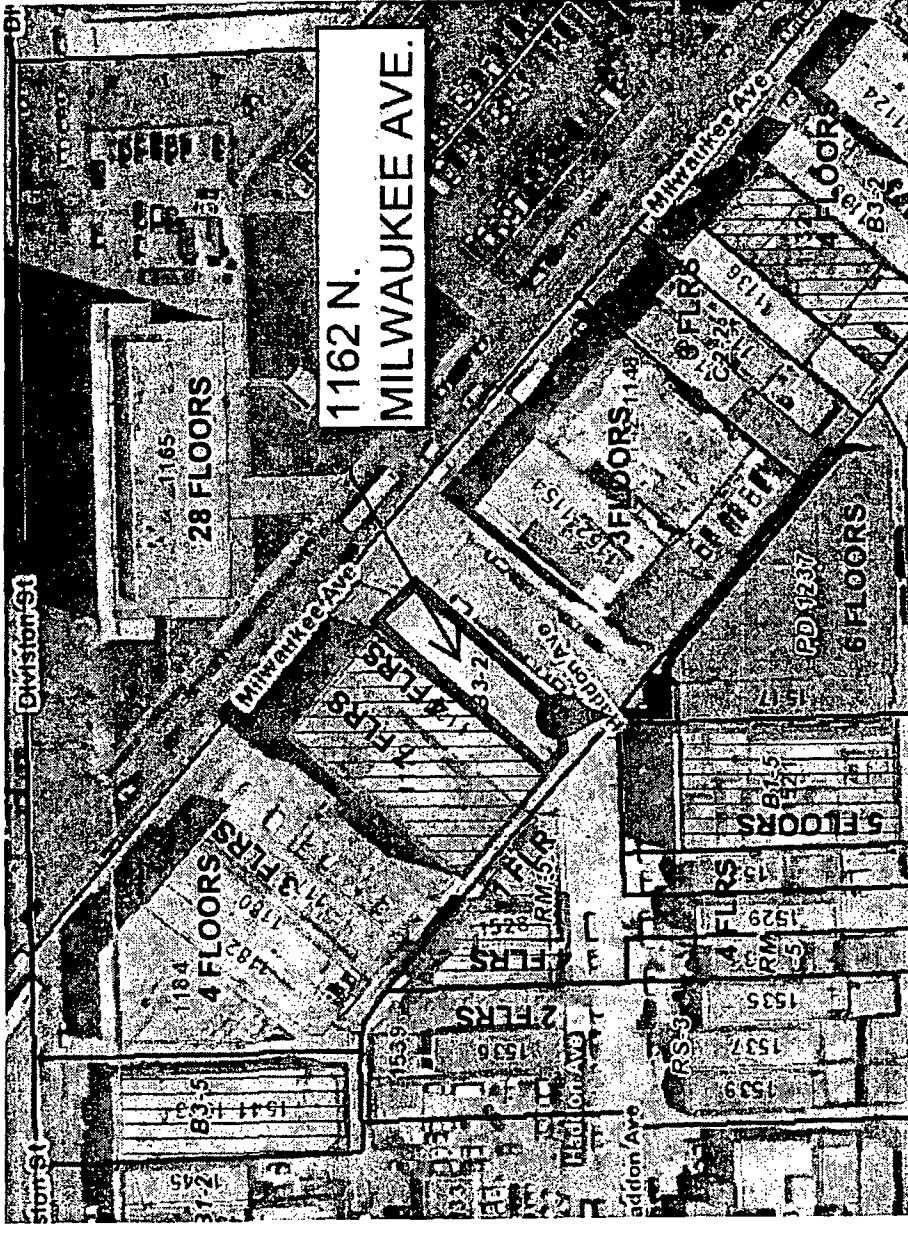

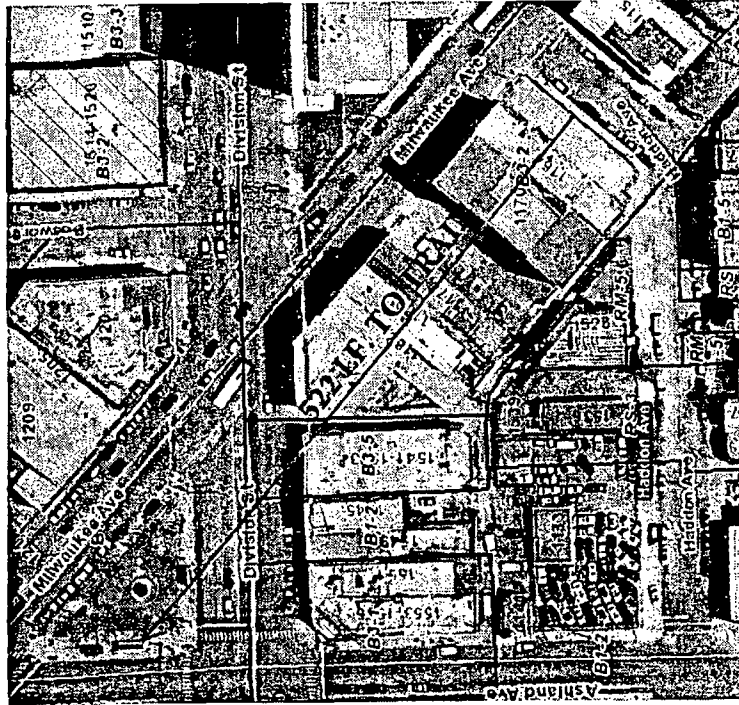

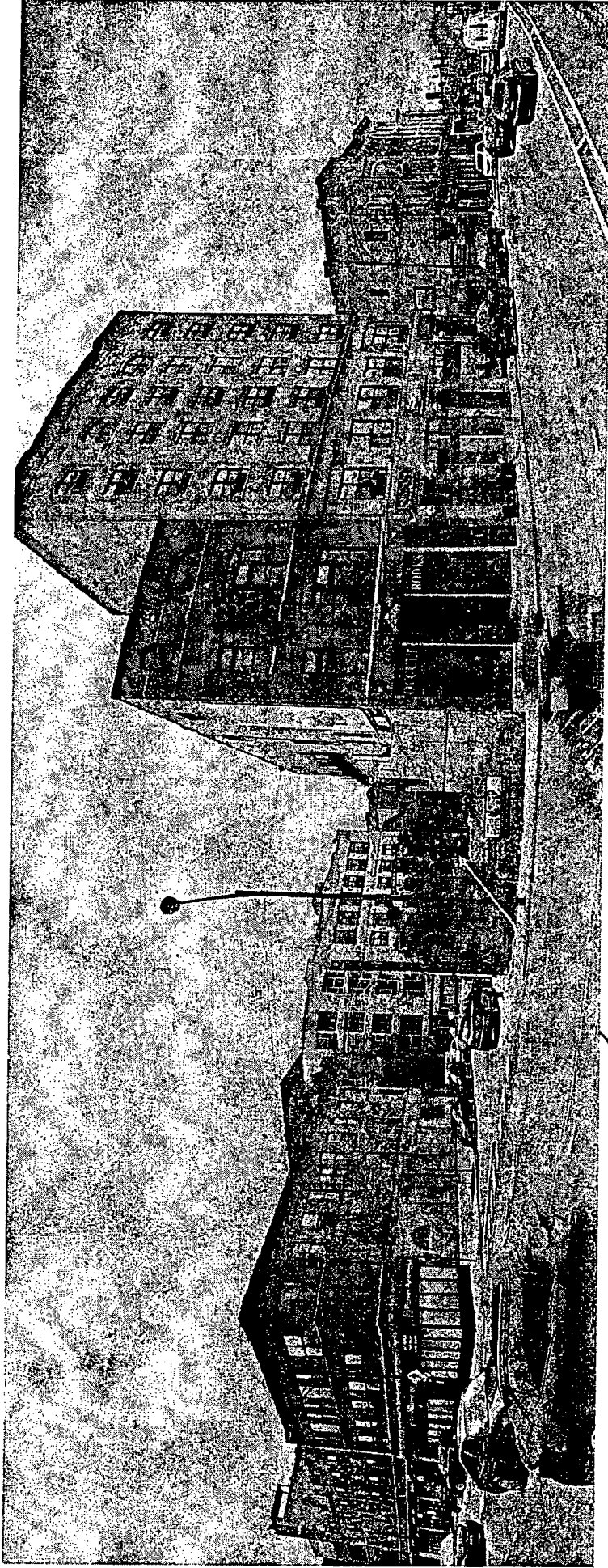

# Zoning map/ neighboring building heights

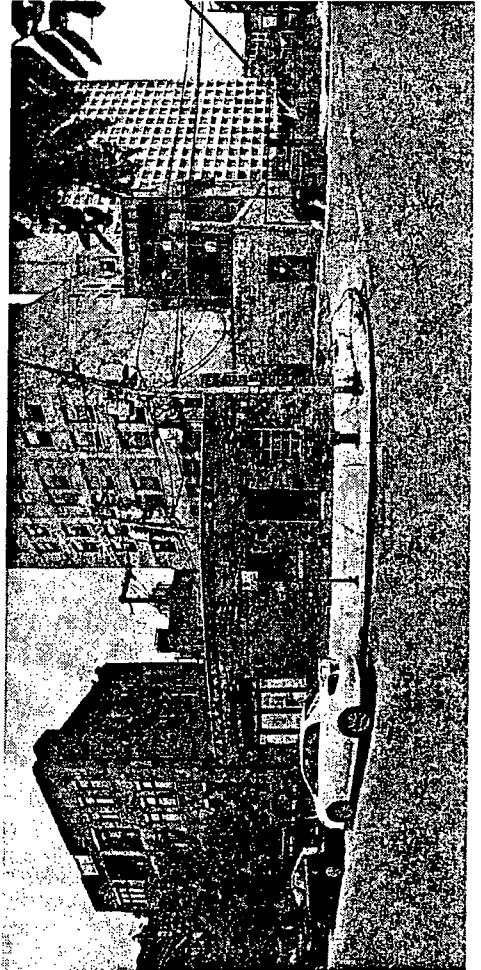

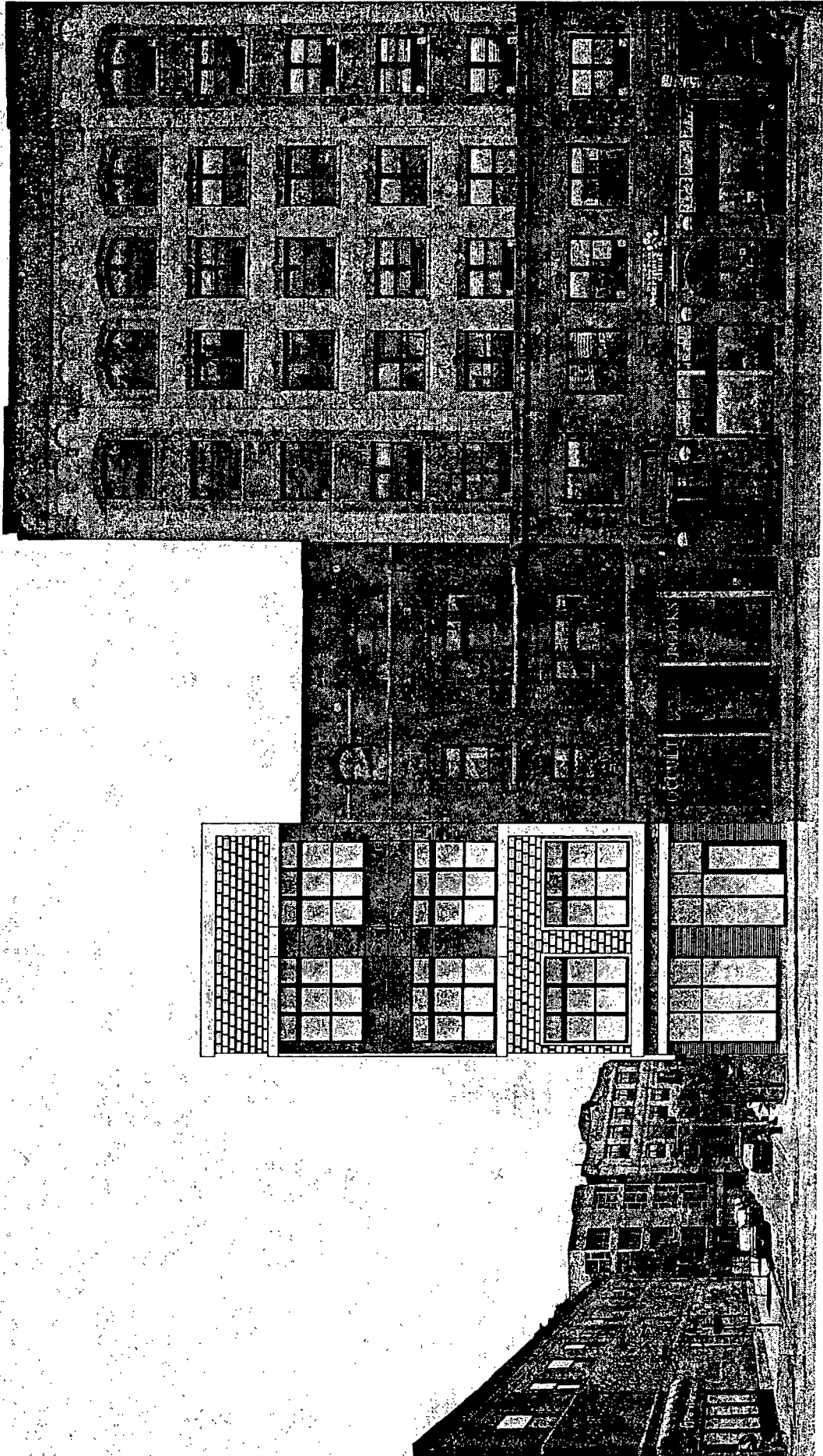

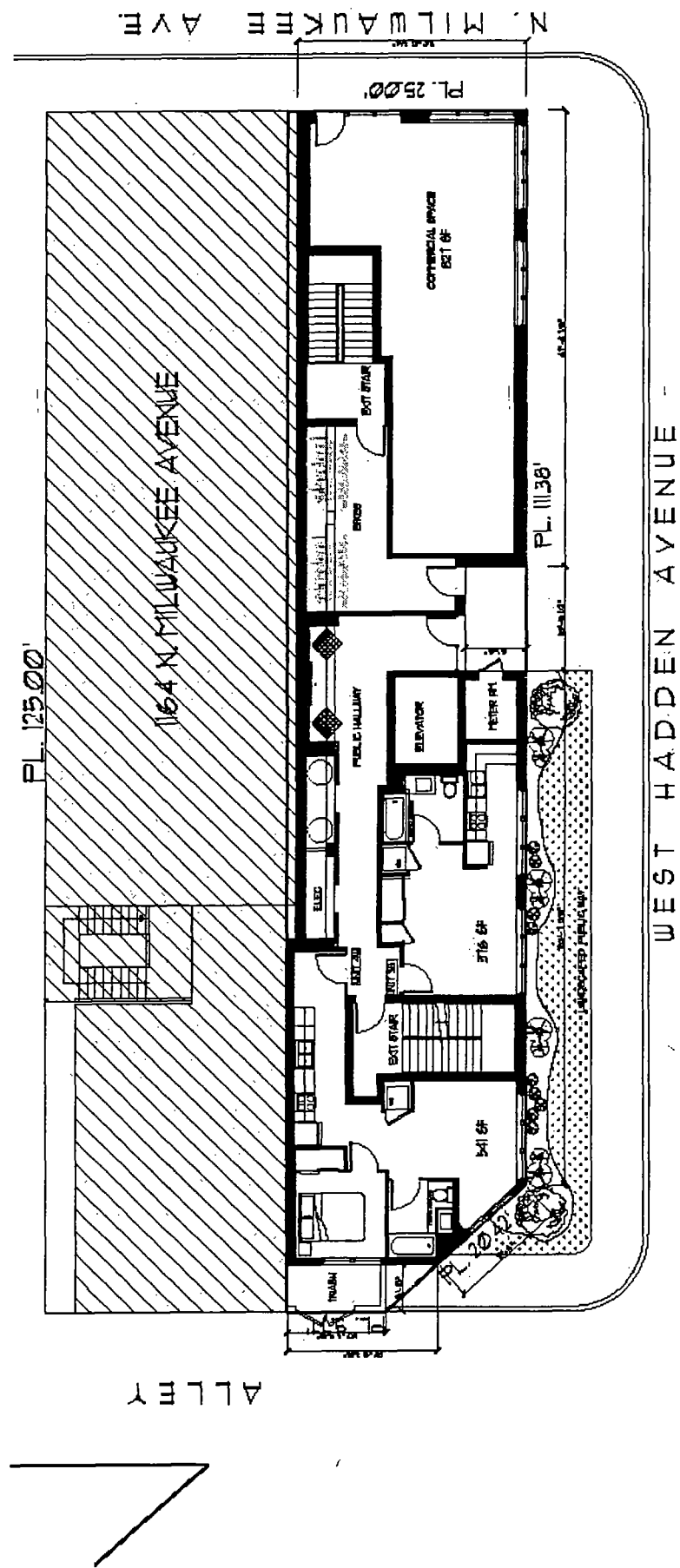

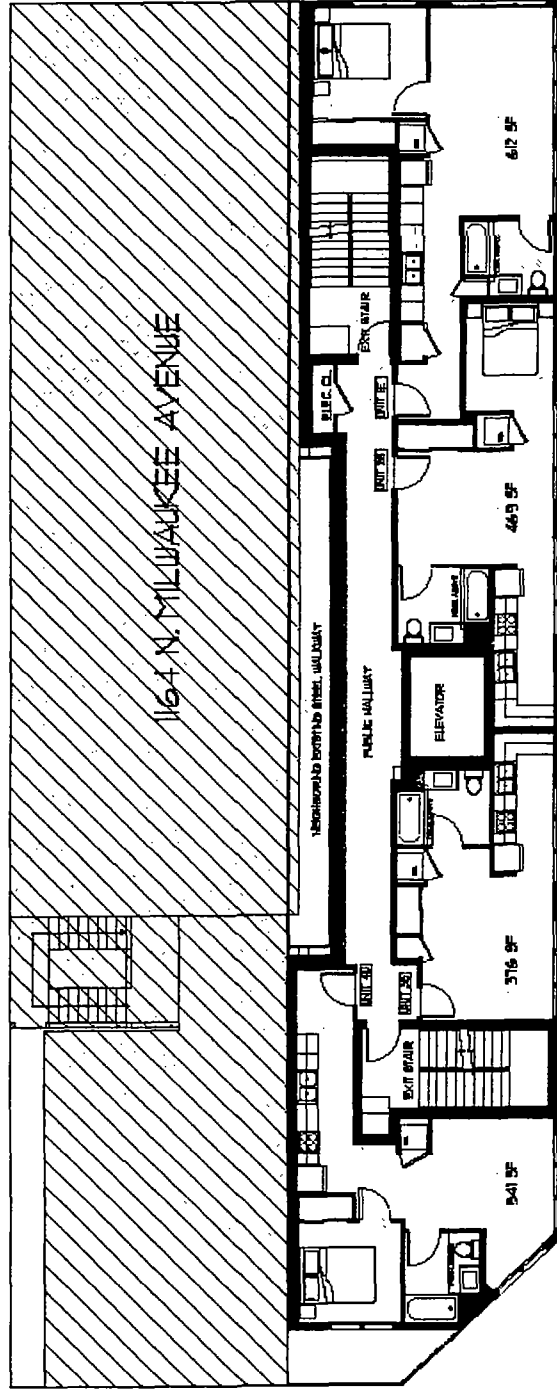


SITE / FIRST FLOOR PLAN

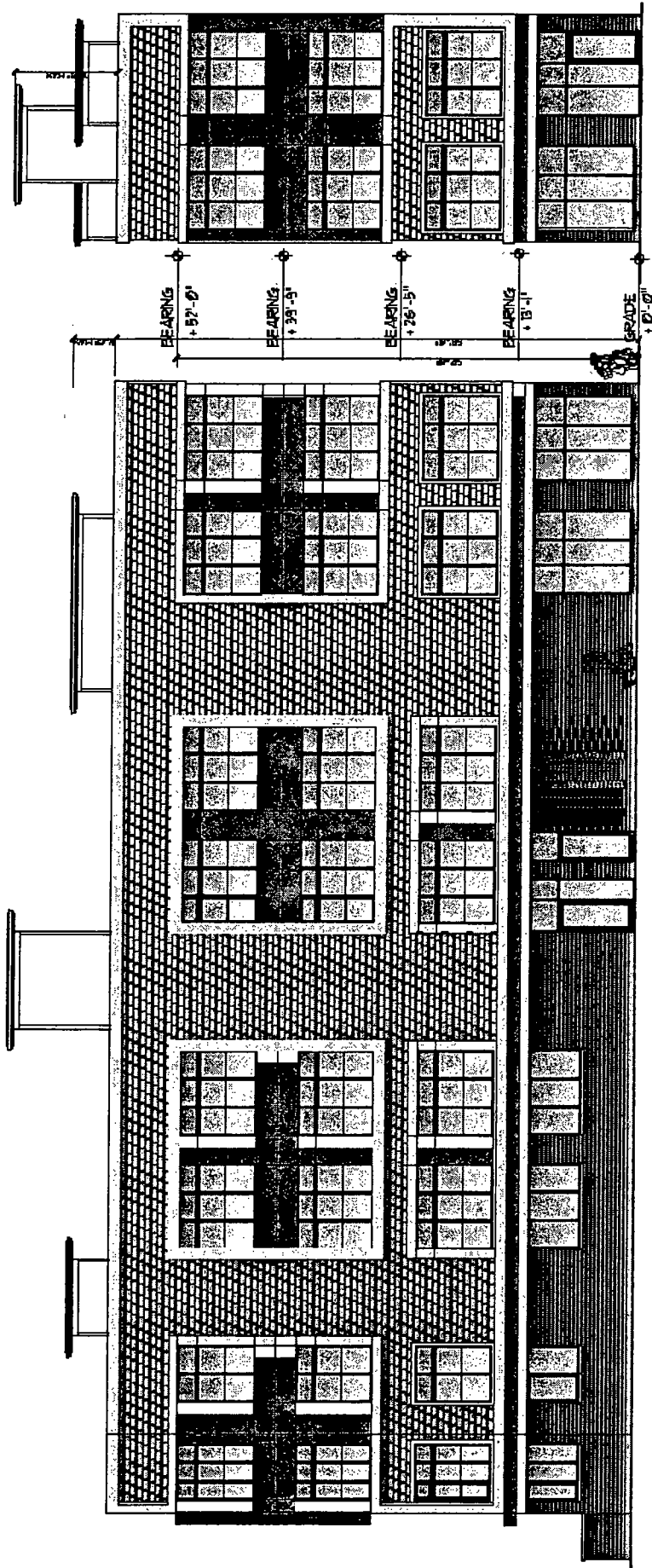

SOUTH SIDE ELEVATION

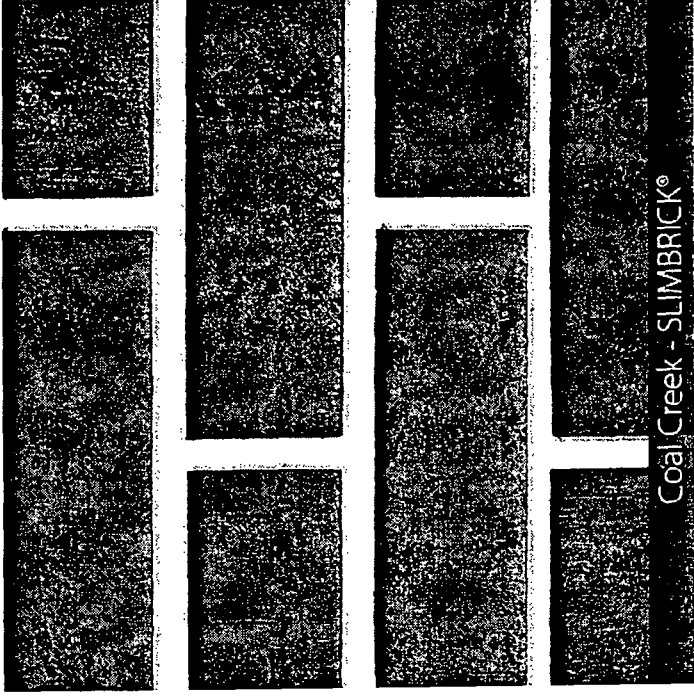
