ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 6-H

A line 50 feet east of and parallel to South Hoyne Avenue; a line 124.03 feet south of and parallel to the 16 foot public alley that is next north of and parallel to West 23rd Street; a line 25 feet east of and parallel to South Hoyne Avenue; a line 124.03 feet north of and parallel to West 23rd Street

to those of a RT 3.5 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



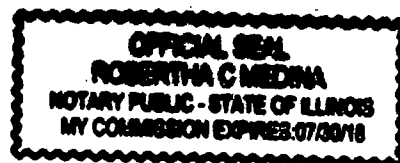

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about **September 11, 2015**, I, the undersigned, filed an application for a change in zoning from a **RS3 Residential Single-Unit (Detached House) District** to a **RT3.5 Residential Two-Flat, Townhouse & Multi-Unit District** on behalf of the **Applicant/Owners, Jaime Guzman and Mayra Garcia Guzman** for the property located at **2056 West 23rd Street Chicago, IL**.
