## ORDINANCE

**WHEREAS**, On February 17, 2009, President Barack Obama signed into law the American Recovery and Reinvestment Act of 2009, pursuant to which the City has received Federal stimulus funding for a variety of important purposes, which were duly appropriated in the Community Development Block Grant - Recovery ("CDBG-R") Ordinance passed by the City Council on October 7, 2009, which ordinance appears at pages 72409 through 72416 of the Journal of Proceedings of that date; and

**WHEREAS**, The City, through its Department of Housing and Economic Development ("DHED"), desires to appropriate an additional \$1,753,000 generated during fiscal year 2012 from DHED's CDBG-R Troubled Building Initiative Distressed Condominium Program, and to use those additional funds in that Program; now, therefore,

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The CDBG-R Ordinance, as amended, is hereby further amended by striking the words and figures and adding the words and figures as indicated in Exhibit A attached hereto.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval.
