Amendment of Section 4-60-023 (43.5) of Municipal Code to disallow additional package goods licenses on portions of W North Ave within the 43rd Ward

SUBSTITUTE ORDINANCE

WHEREAS, An ordinance amending Section 4-60-023 of the Municipal Code by adding a new subsection 4-60-023(43.64) was passed by the City Council on April 18, 2012 and appears at pages 23758-23759 of the Journal of Proceedings of that date ("the April Ordinance"); and

WHEREAS, It was later discovered that the April Ordinance contained a scrivener's error; namely, that subsection 4-60-023(43.64) was not the next available number in this subsection; and

WHEREAS, An ordinance amending Section 4-60-023 of the Municipal Code by adding a new subsection 4-60-023(43.38) was passed by the City Council on July 25, 2012 and bears the identification number, assigned by the City Clerk's office, O2012-4475 ("the July Ordinance"); and

WHEREAS, It was later discovered that the July Ordinance was erroneously drafted so that it applied to Section 4-60-023 instead of Section 4-60-022, and imposed, rather than lifted, a restriction, as the sponsor had intended; and

WHEREAS, It is necessary and advisable to correct the above errors; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 4-60-023 of the Municipal Code is hereby amended by deleting the struck-through language and inserting the underscored language as follows:

(Omitted text is unaffected by this ordinance)

(43.64) (43.5) On the south side of North Avenue, from Sedgwick Street to Larrabee Street.

(Omitted text is unaffected by this ordinance)

SECTION 2. Subsection 4-60-023(43.38) of the Municipal Code is hereby repealed by deleting the struck-through language as follows:

(Omitted text is unaffected by this ordinance)

4-60-023 (43.38) On the west side of Halsted Street, from Webster Avenue to Fullerton Avenue.

(Omitted text is unaffected by this ordinance)

SECTION 3. Subsection 4-60-022(43.38) of the Municipal Code is hereby repealed by deleting the struck-through language as follows:

(Omitted text is unaffected by this ordinance)

4-60-022 (43.38)

On Halsted Street, from Webster Avenue to Fullerton Avenue.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and approval.
