To those of a C1-1, Neighborhood Commercial District

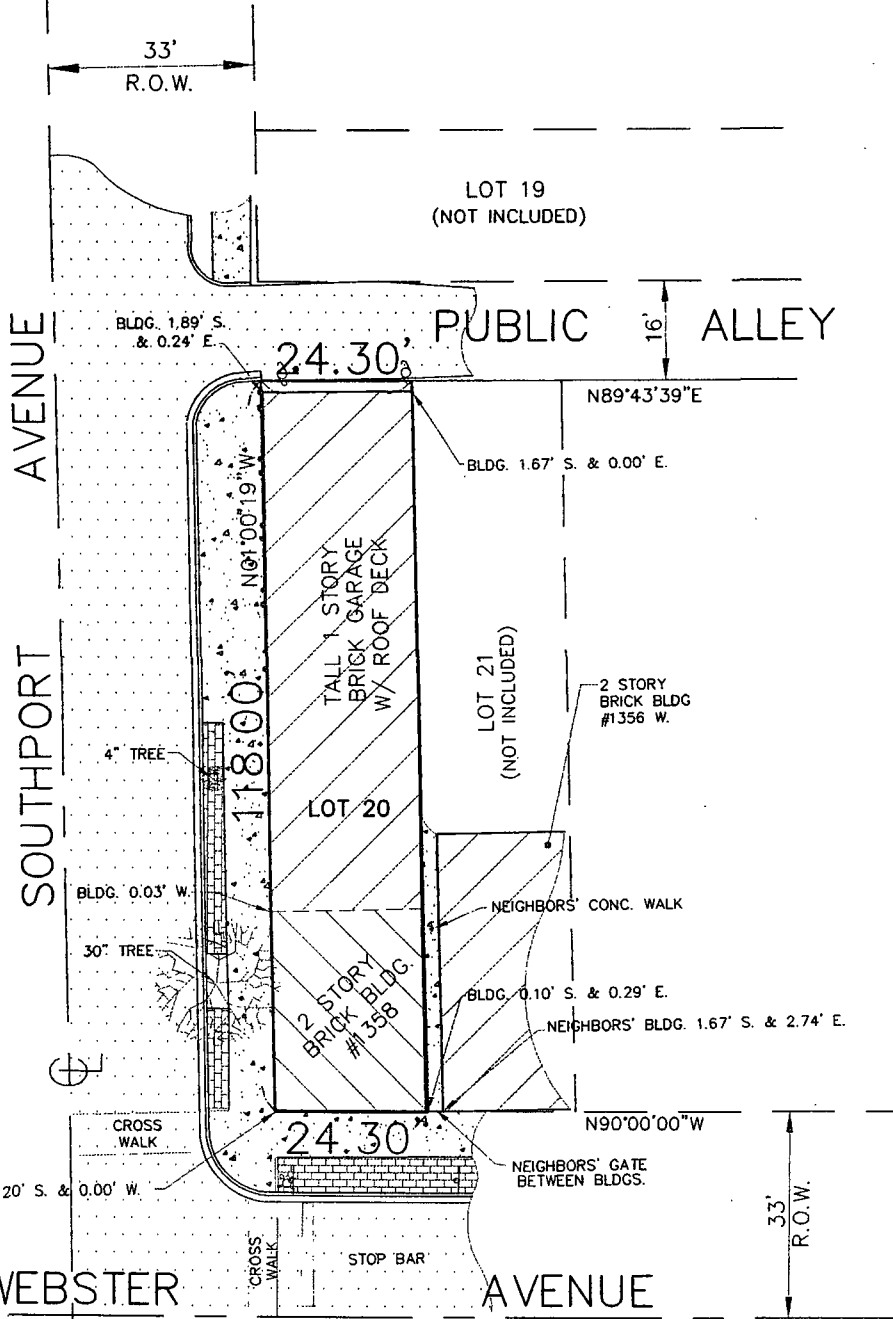
