ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 4-H in the area bounded by

West 19th Street; a line 150 feet west of and parallel to South Wolcott Avenue; the public alley next south of and parallel to West 19th Street; a line 192 feet west of and parallel to South Wolcott Avenue,

to those of a B1-2 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.



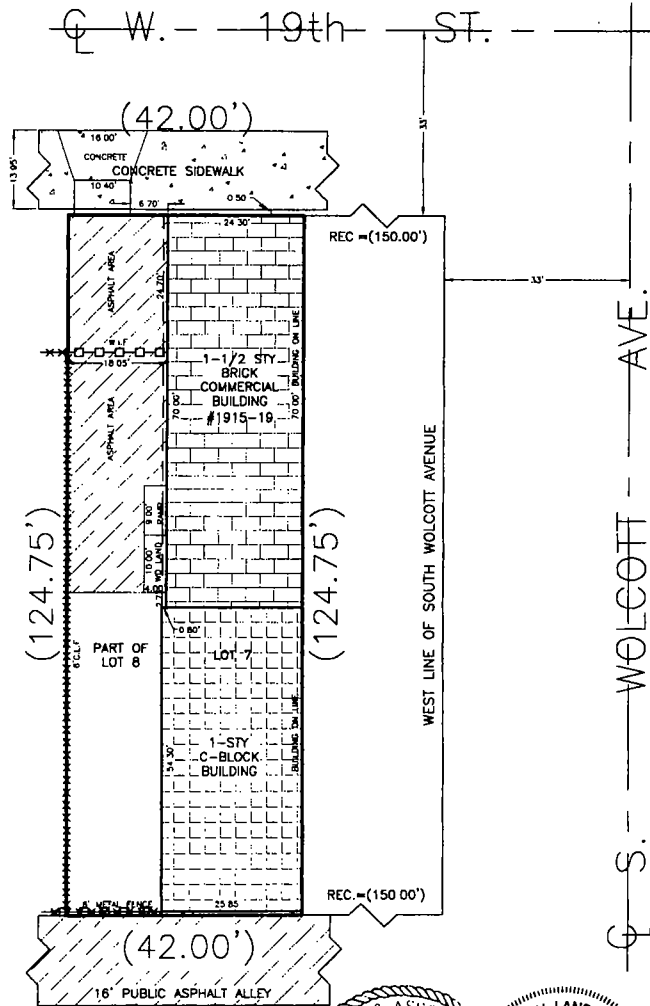

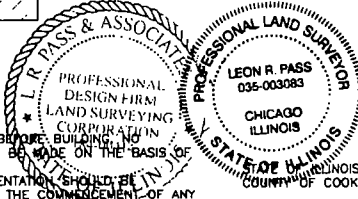
