BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District, as shown on Map 5-I in the area bounded by:

The alley next North of and parallel to West Lyndale Street; A line 150.33 feet West of and parallel to North Western Avenue; West Lyndale Street; and a line 193.65 feet West of and parallel to North Western Avenue.

To those of **RT-4 Residential Two-Flat, Townhouse and Multi-Unit District**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The Application is to change zoning for 2418 West Lyndale Street from RS-3 Residential Single-Unit (Detached House) District to RT-4 Residential Two-Flat, Townhouse and Multi-Unit District. This zoning change is for purposes to allow Applicant to construct a three-story, four (4) dwelling unit building with a basement. There will be a four-car garage at the rear of the property. The footprint of the building shall be approximately be 34 feet 6 inches by 55 feet in size. The building height shall be 35 feet high, as defined by code.
