SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT3.5 Residential Two-Flat, Townhouse and Multi- Unit District symbols and indications as shown on Map No. 9-G in an area bound by:

West Roscoe Street; a line 25 feet east of and parallel to north Greenview Avenue; the alley next south of and parallel to west Roscoe Street; and north Greenview Avenue;

To those of a RM4.5 Residential Multi-Unit District .

SECTION 2. This ordinance takes effect after its passage and due publication.
