ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the RS-3, Residential Single-Unit (Detached House) District designation as shown on Map Number 3-I in the area bounded by:

West August Boulevard; a line 100 feet east of and parallel to North
Washtenaw Avenue; the alley next south of and parallel to West Augusta
Boulevard; and a line 75 feet east of and parallel to North Washtenaw Avenue

to those of a RM-4.5, Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
