ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M3-3, Heavy Industry District symbols as shown on Map 7-H in the area legally described as:

PARCEL A:

A PART OF LOT 1 AND VACATED SNOW STREET IN SNOW ESTATE SUBDIVISION BY SUPERIOR COURT IN PARTITION OF THE EAST HALF OF THE NORTHWEST QUARTER OF SECTION 30, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, AND THE EAST HALF OF THE NORTHEAST QUARTER OF SECTION 25, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, (EXCEPT THE SOUTH 20 ACRES); ALSO THAT PART OF THE SOUTHWEST QUARTER OF SAID SECTION 30, LYING NORTH AND EAST OF THE NORTH BRANCH OF THE CHICAGO RIVER; ALSO LOTS 2, 3, 4, 6, 7, 9 AND 11 IN THE ASSESSOR'S DIVISION OF THAT PART OF THE SOUTHWEST QUARTER OF SAID SECTION 30, LYING BETWEEN THE RAILROAD AND THE RIVER WHICH PART OF LOT 1 AND VACATED STREET ARE MORE PARTICULARLY DESCRIBED AS BEING THOSE PARTS OF SAID LOT AND VACATED STREET WHICH ARE BOUNDED AS FOLLOWS; ON THE NORTHEAST BY THE SOUTHWESTERLY DOCK LINE OF THE NORTH BRANCH OF THE CHICAGO RIVER; ON THE SOUTHWEST BY THE NORTHEASTERLY LINE OF NORTH ELSTON AVENUE; ON THE NORTHWEST BY A LINE 5.08 FEET (MEASURED AT RIGHT ANGLES) SOUTHEASTERLY FROM AND PARALLEL WITH THE NORTHWESTERLY LINE OF VACATED SNOW STREET; AND ON THE SOUTHEAST BY A LINE EXTENDED FROM SAID NORTHERLY LINE OF NORTH ELSTON AVENUE TO SAID NORTH BRANCH OF THE CHICAGO RIVER, WHICH LINE EXTENDS NORTHEASTERLY FROM A POINT ON SAID NORTHEASTERLY LINE OF NORTH ELSTON AVENUE THAT IS 403.79 FEET SOUTHEASTERLY FROM THE POINT OF INTERSECTION OF SAID NORTHEASTERLY STREET LINE WITH THE NORTHWESTERLY LINE OF SAID VACATED SNOW STREET AND PASSES THROUGH A POINT WHICH IS 509.48 FEET (MEASURED AT RIGHT ANGLES) NORTHEASTERLY FROM SAID NORTHEASTERLY LINE OF NORTH ELSTON AVENUE AND 181.41 FEET (MEASURED AT RIGHT ANGLES) WEST FROM THE EAST LINE OF SAID SOUTHWEST QUARTER OF SAID SECTION 30;

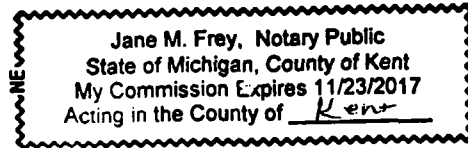

Plan of Development Statements

1. The area delineated herein as Waterway Planned Development No. _____ (“Planned Development”) consists of approximately 324,672 square feet (7.453 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is under the single designated control of the Applicant, Delta Real Estate Holdings, LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for an amendment, modification or change (administrative, legislative or otherwise) to this Planned Development is made, shall be under single ownership or single designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

This Plan of Development consists of Sixteen Statements; a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary, Property Line and Subarea Map; a Subarea A Site Plan; a Subarea B Site Plan; a Subarea A Green Roof Plan; a Landscape Plan; and Building Elevations prepared by

Gensler dated January 17, 2013. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are permitted in Subareas A and B in the area delineated herein as a Waterway Planned Development: vehicle sales and service; motor vehicle repair; vehicle washing and cleaning; vehicle parking and storage; all services related to motor vehicles; and accessory uses.
6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development subject to the review and approval of the Department of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development except as set forth herein. The City acknowledges that there are two lawfully established free-standing off-premise signs located in Subarea B. These signs may remain in use subject to the regulations pertaining to signs in the Zoning Ordinance and Municipal Code.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 171,894 square feet for Subarea A; and a Net Site Area of 152,778 square feet for Subarea B.
9. Upon review and determination ("Part II Review"), and pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim review associated with the site plan review or Part II reviews are conditional until final Part II approval.

11. The Applicant shall comply with the Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation and Fleet and Facility Management and Buildings, pursuant to Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this Planned Development Ordinance may be modified administratively by the Zoning Administrator, pursuant to Section 17-13-0611-A of the Zoning Ordinance, upon written application by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. All new buildings shall be Certified under the Leadership in Energy and Environmental Design ("L.E.E.D.") Green Building Rating System and shall include a green roof which covers a minimum of 50% of each building's net roof area. The building in Subarea A will have a green roof of approximately 28,000 square feet. All buildings constructed in this Planned Development shall conform to the City of Chicago Sustainable Development Policy Matrix in effect on the date of approval of this Planned Development.
15. The Applicant acknowledges the importance of the Chicago River as a resource for both commerce and recreation and also acknowledges the City's goals of improving the appearance, quality and accessibility of the river, as contained in the Waterway planned development guidelines contained in the Zoning Ordinance, and the Chicago River Corridor Design Guidelines and Standards. To further these goals, the Applicant agrees to provide a landscaped 30-foot-wide river setback and continuous riverside trail as indicated on the Site Plan and Landscape Plan. All improvements within the river setback must be substantially completed prior to receipt of a Certificate of Occupancy for the principal building, provided that planting may be delayed, if consistent with good landscape practice, but not longer than one year following receipt of the occupancy certificate.
16. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development Ordinance lapse, the Zoning Administrator shall initiate a Zoning Map Amendment to rezone the property to an M3-3, Heavy Industry District.

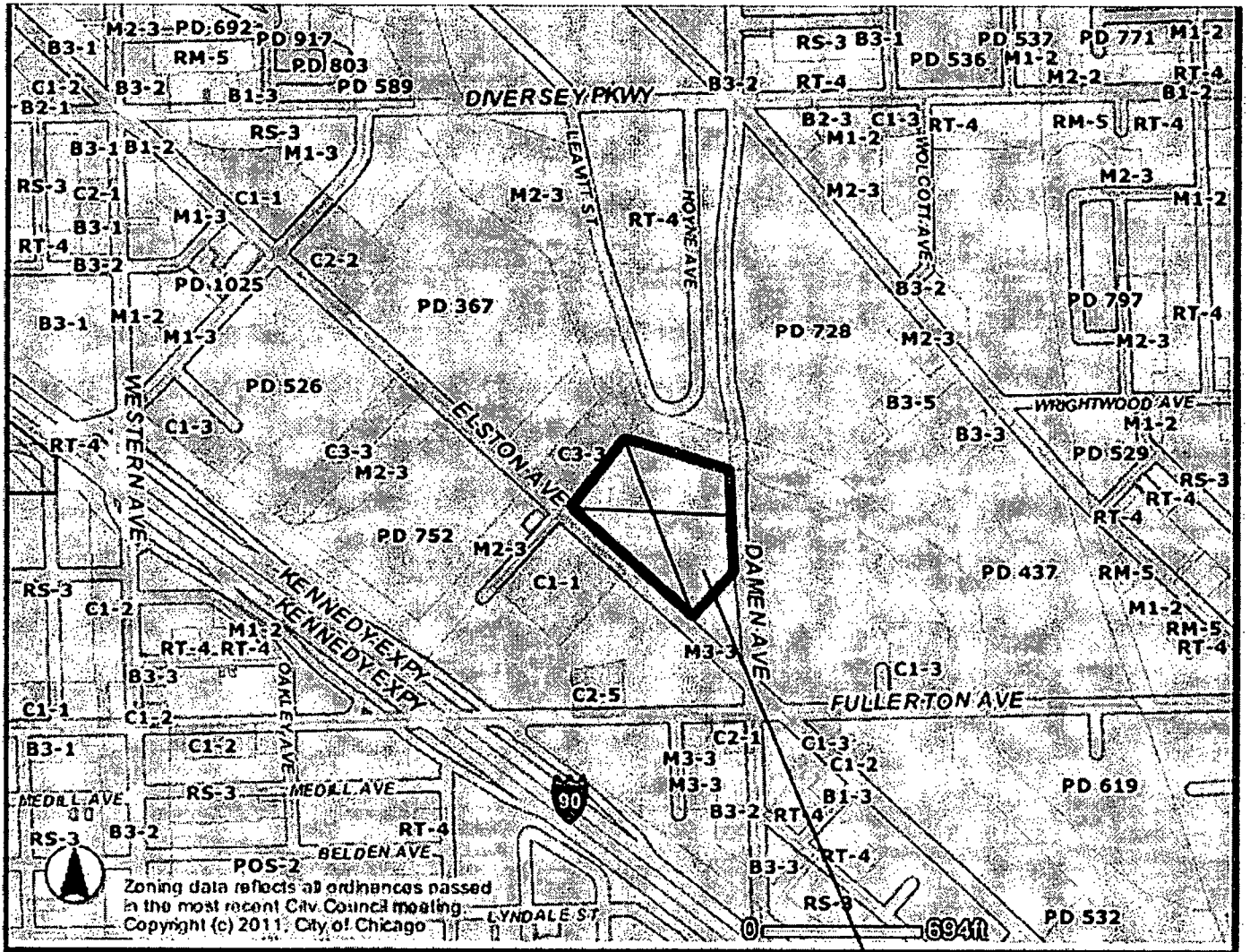

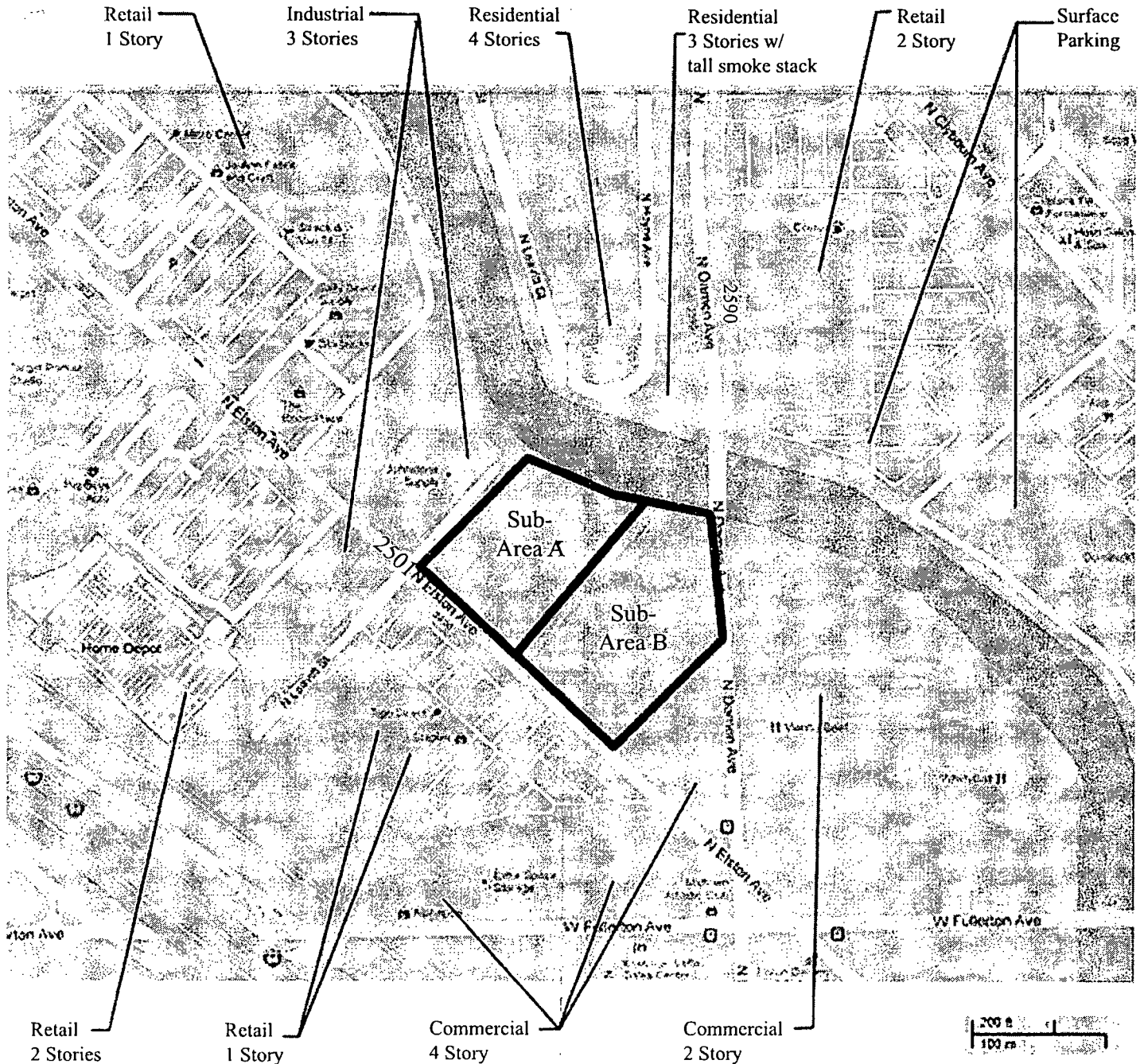

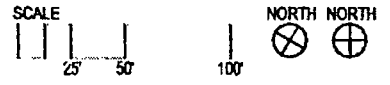
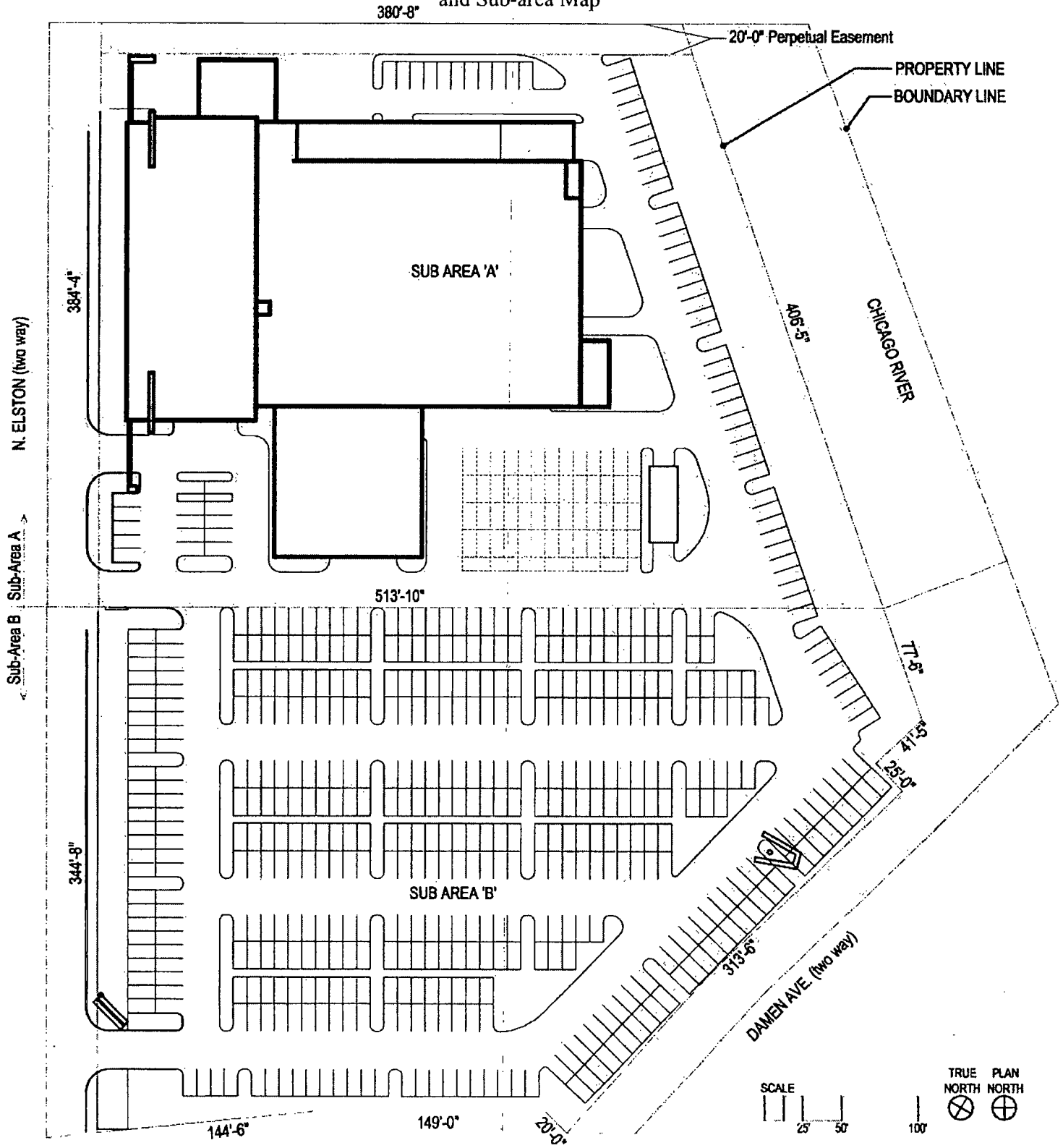

Area Map



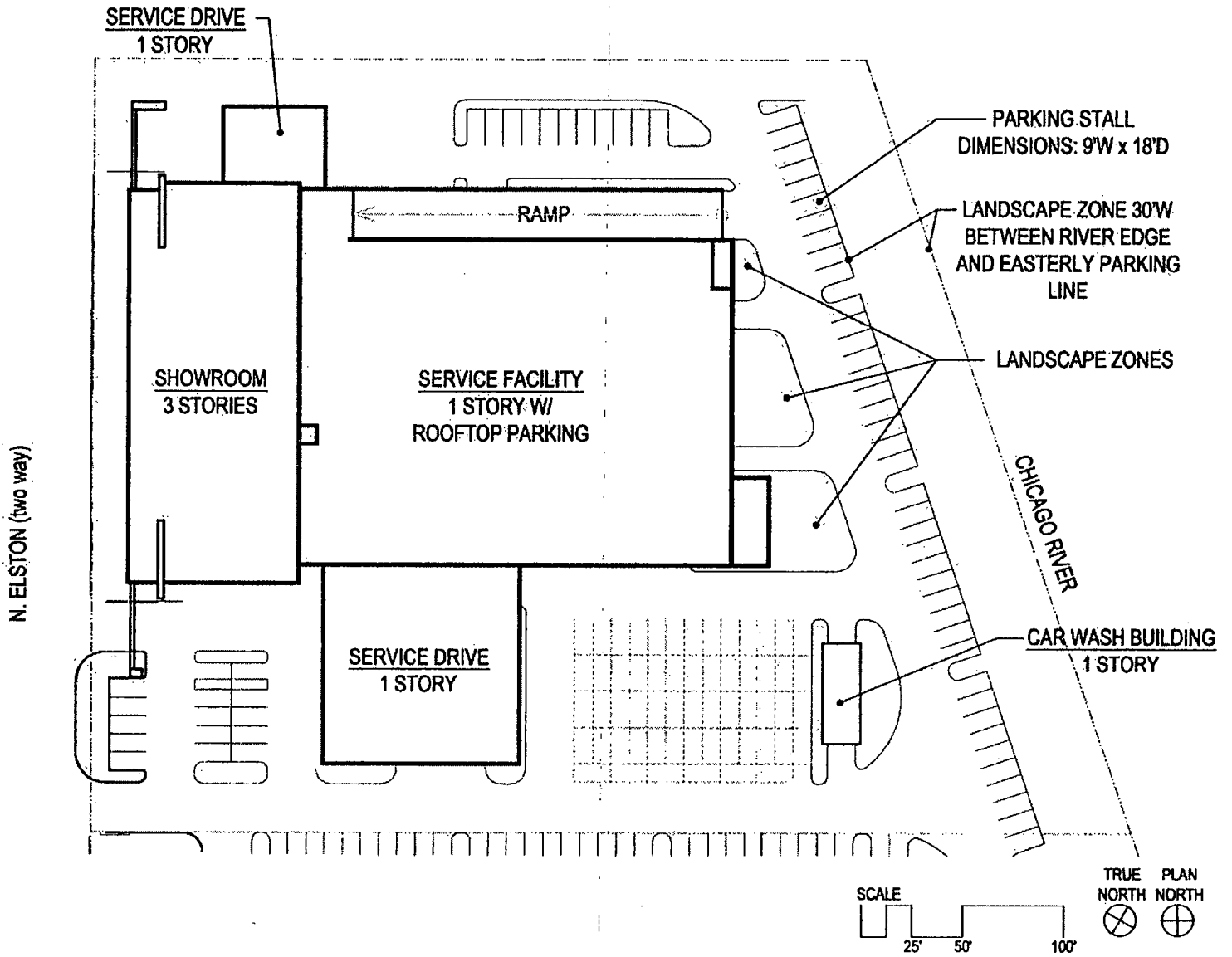

 and Sub-area Map



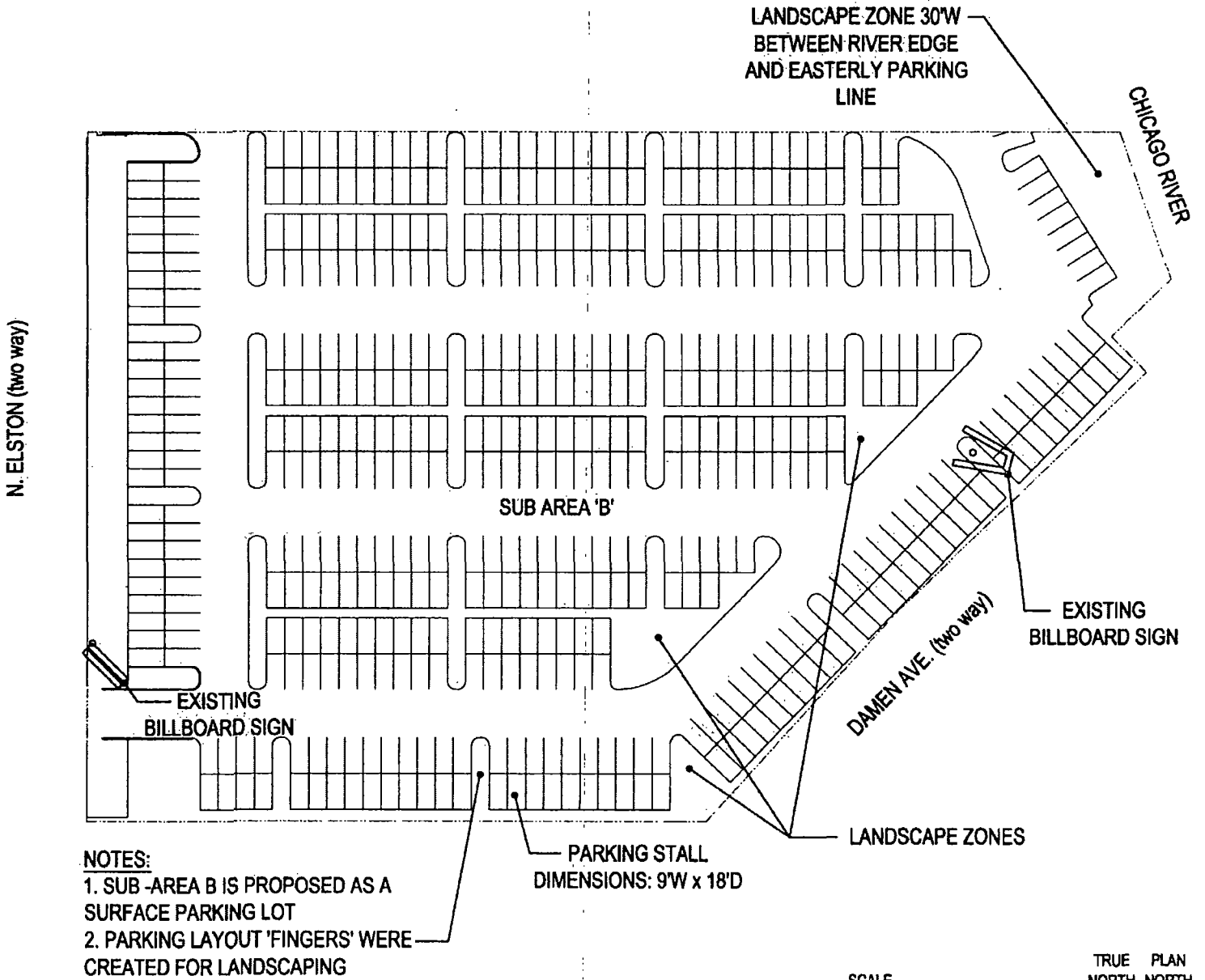

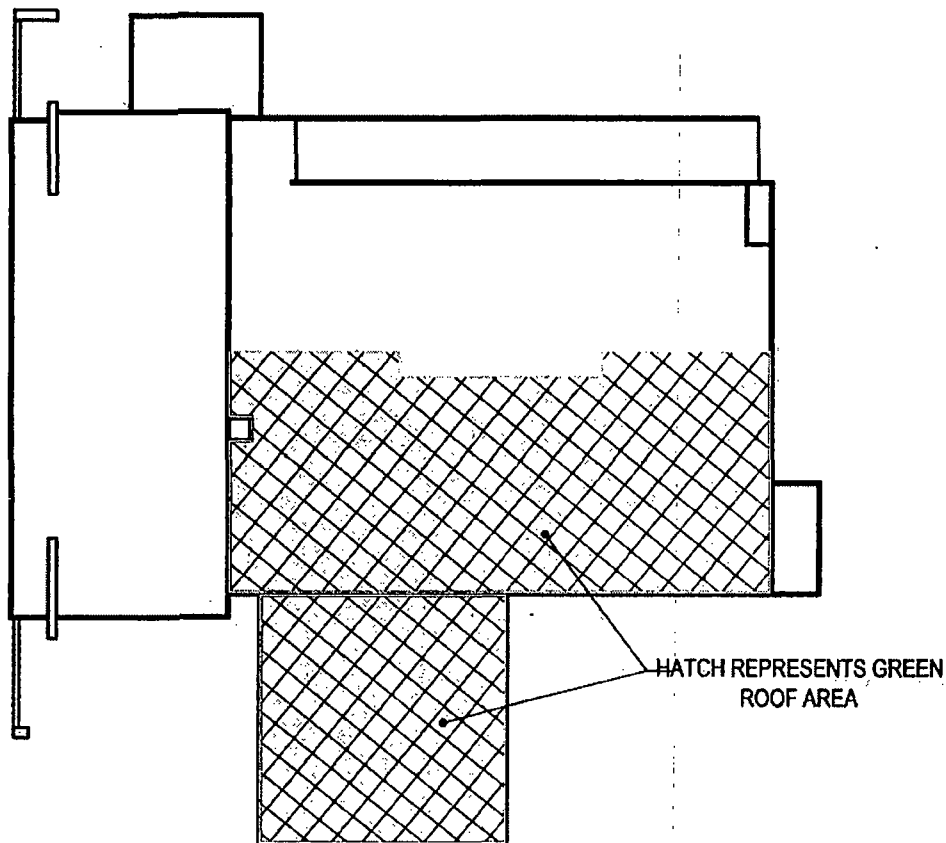

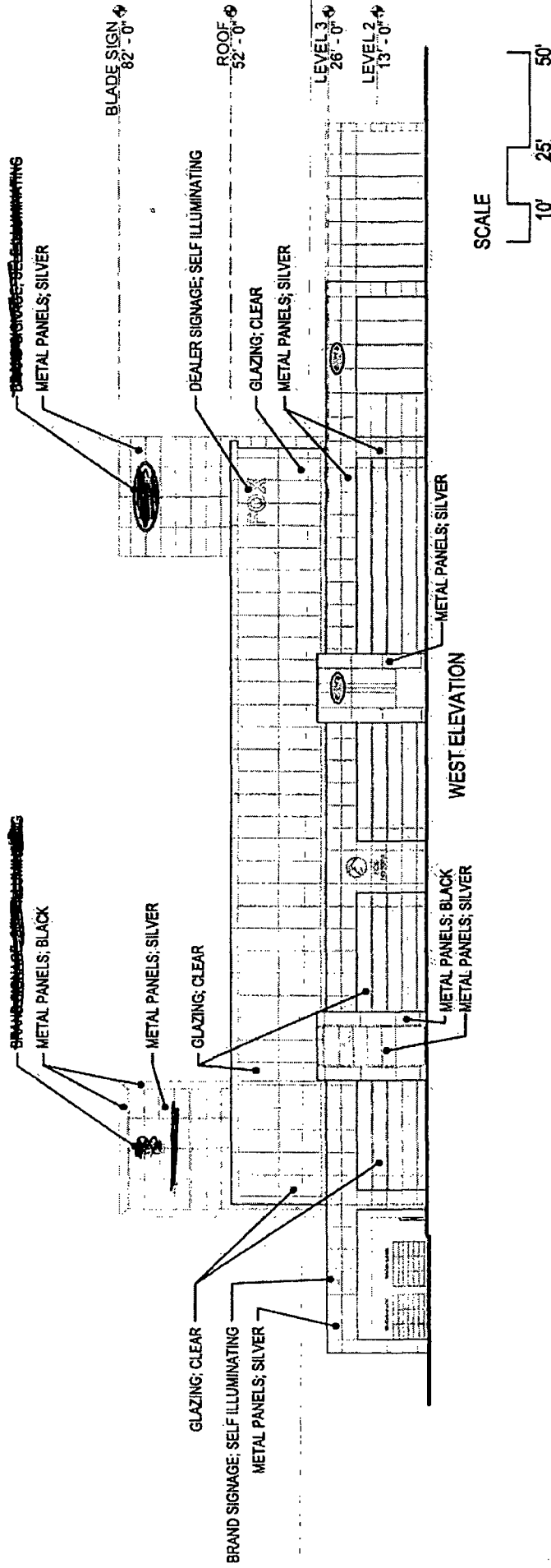

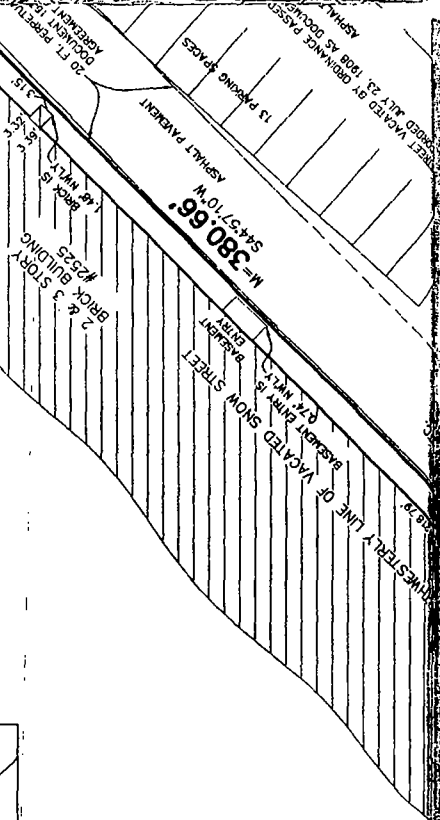
