Permission and authority are hereby given and granted to GILT BAR/DOUGHNUT VAULT upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 228-230 W. Kinzie St.. Said sidewalk cafe area #1 shall be forty-three point nine two (43.92) feet in length and six point two five (6.25) feet in width, area #2 shall be sixty-six point eight three (66.83) feet in length and five point seven five (5.75) feet in width for a total of six hundred fifty-eight point seven seven (658.77) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along W. Kinzie Street, N. Franklin Street. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Sunday 11:00 a.m. to 12:00 midnight  
Compensation: \$724.65  
SEATING CAPACITY: 42




