**ORDINANCE**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols as shown on Map No. 2-M in the area bounded by:**

**West Fillmore Street; South Menard Avenue; a line 70.02 feet next south of and parallel to West Fillmore Street; and the public alley next west of and parallel to South Menard Avenue.**

**To those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**

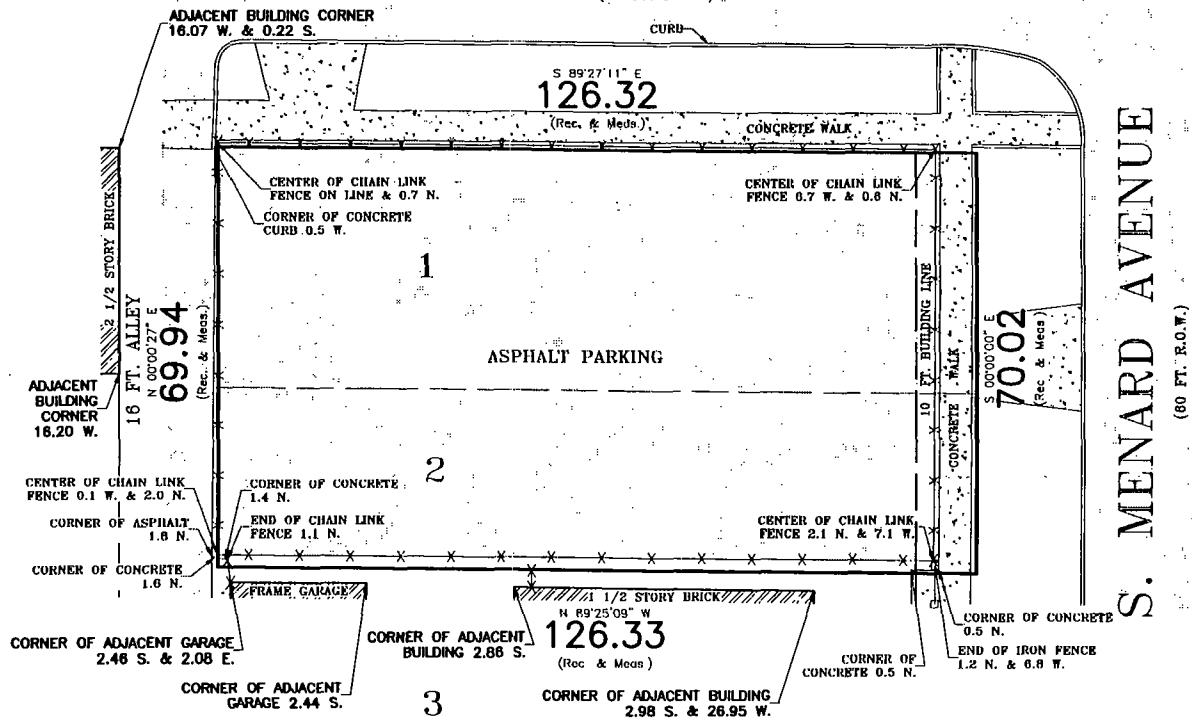

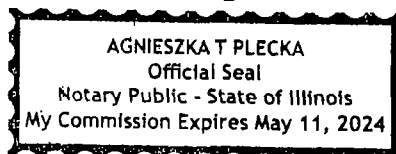

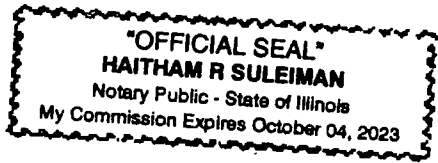
