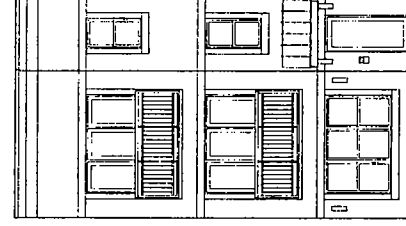

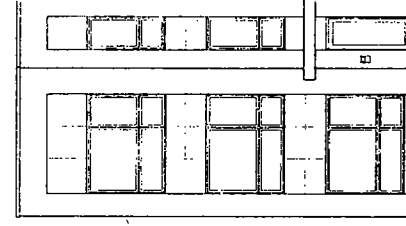

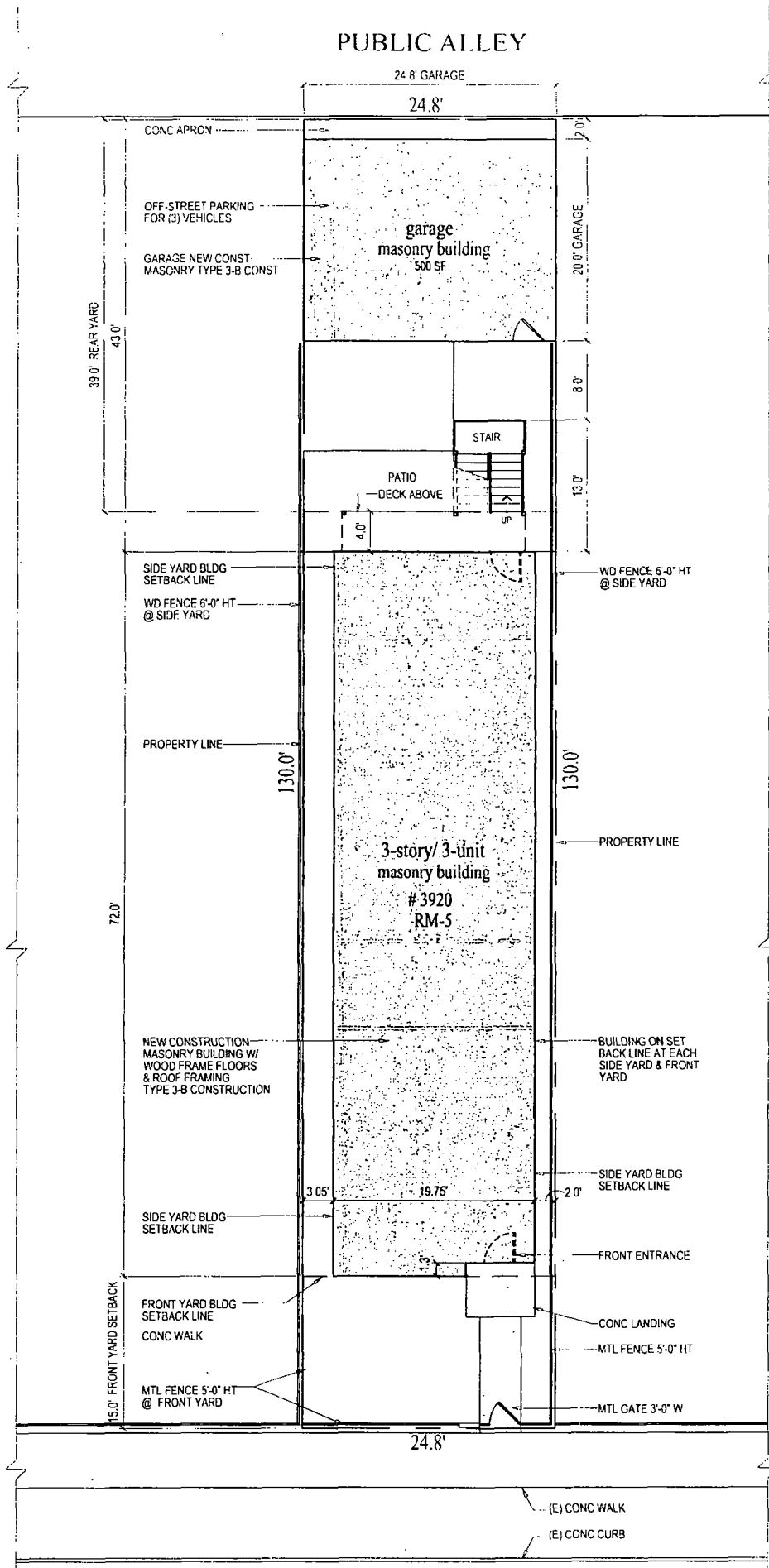

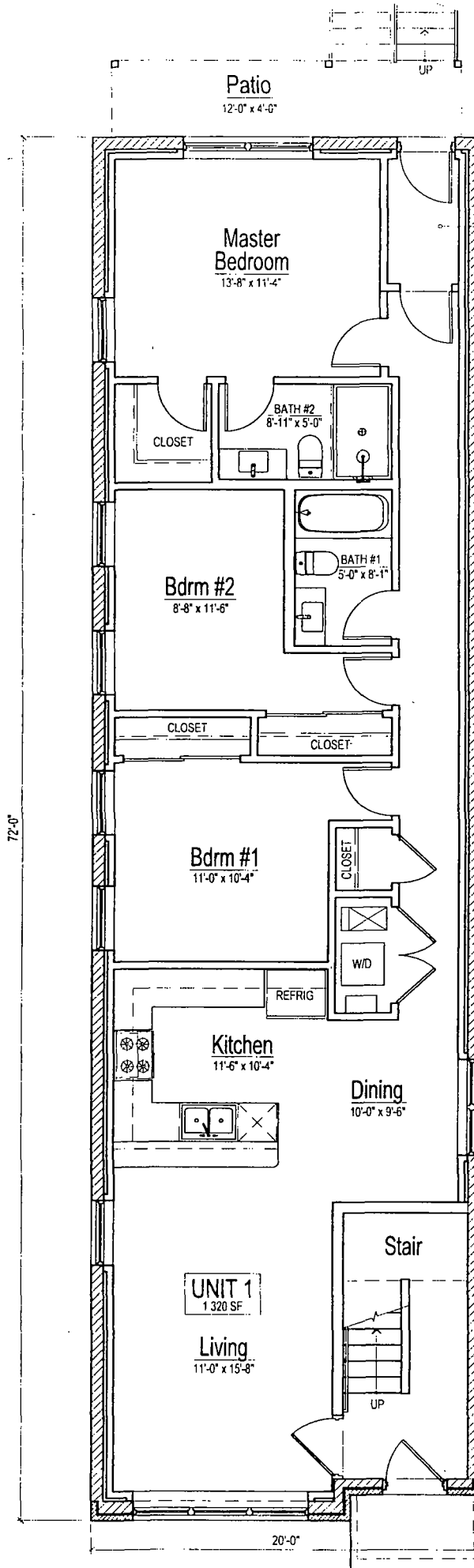

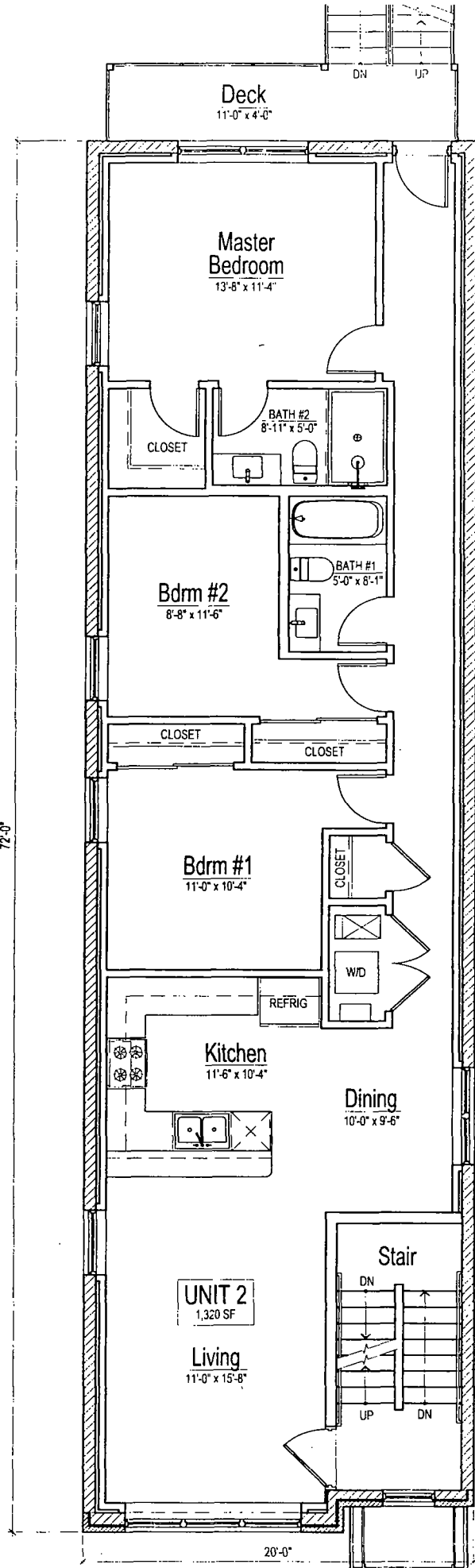

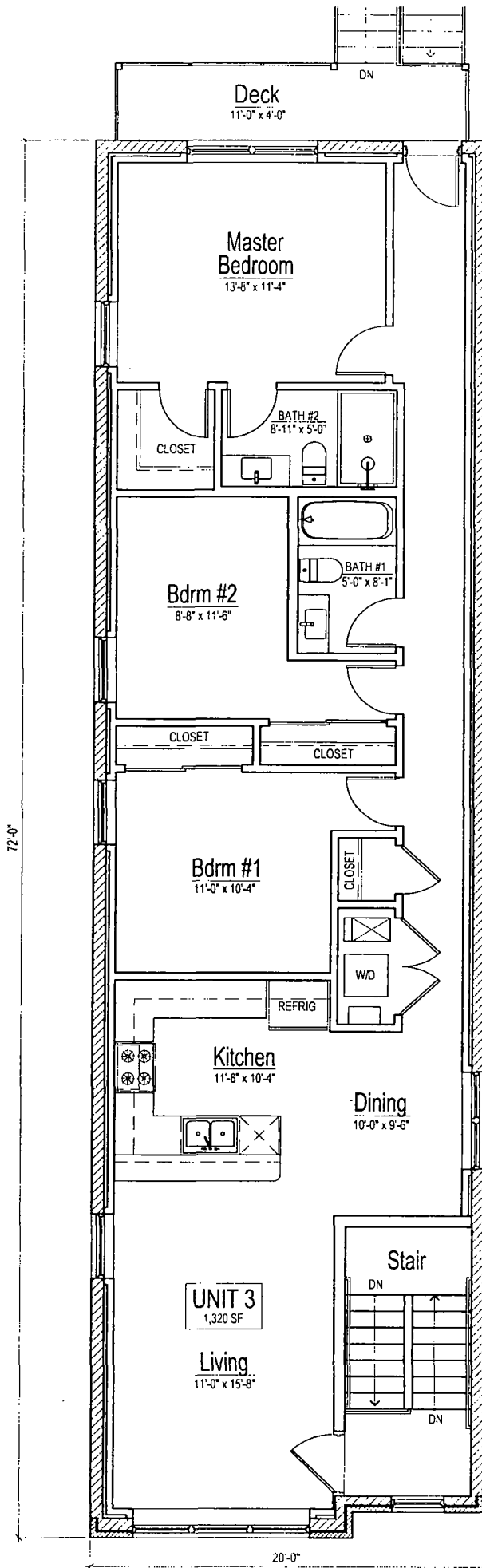

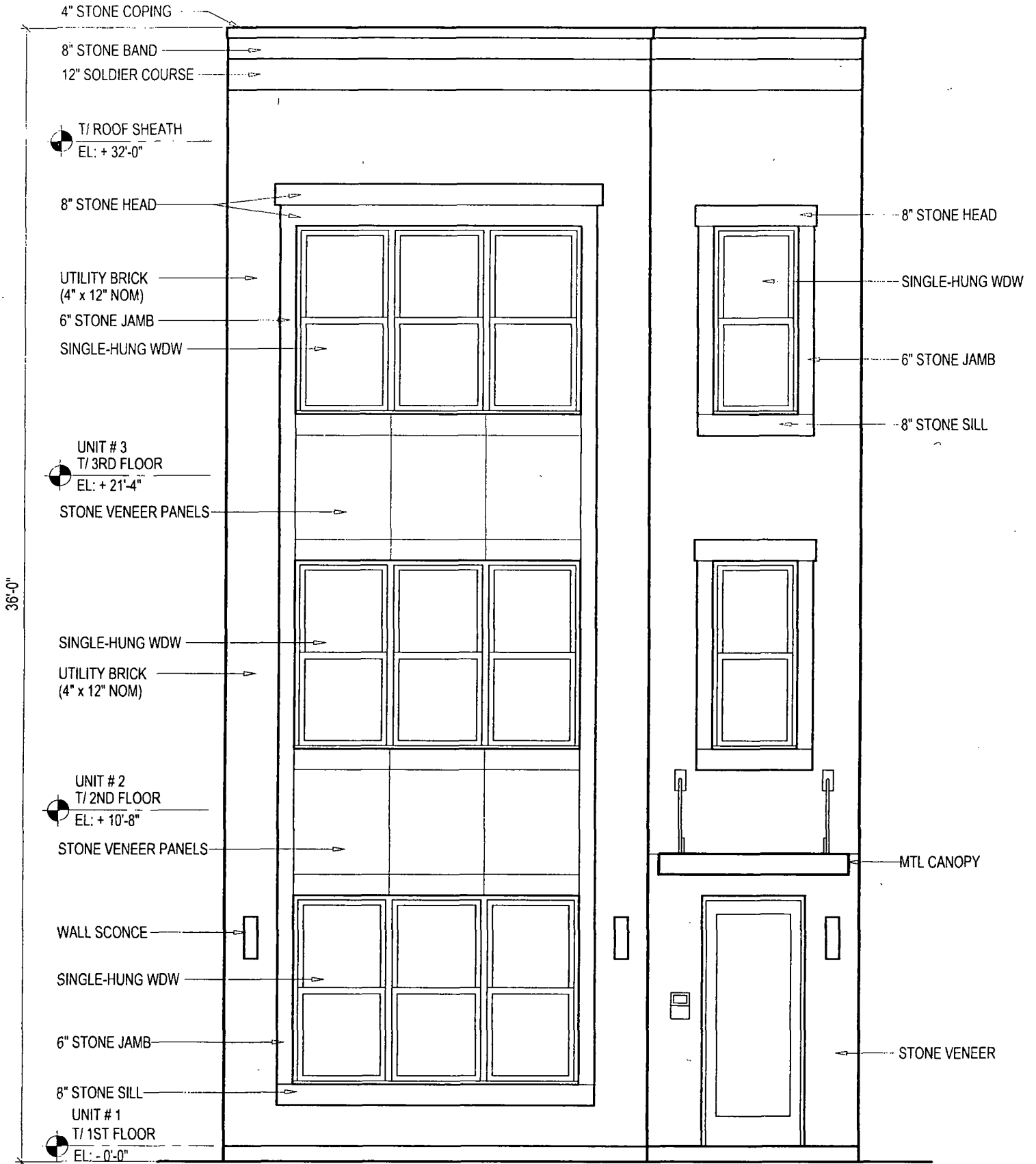


2ND FLOOR PLAN

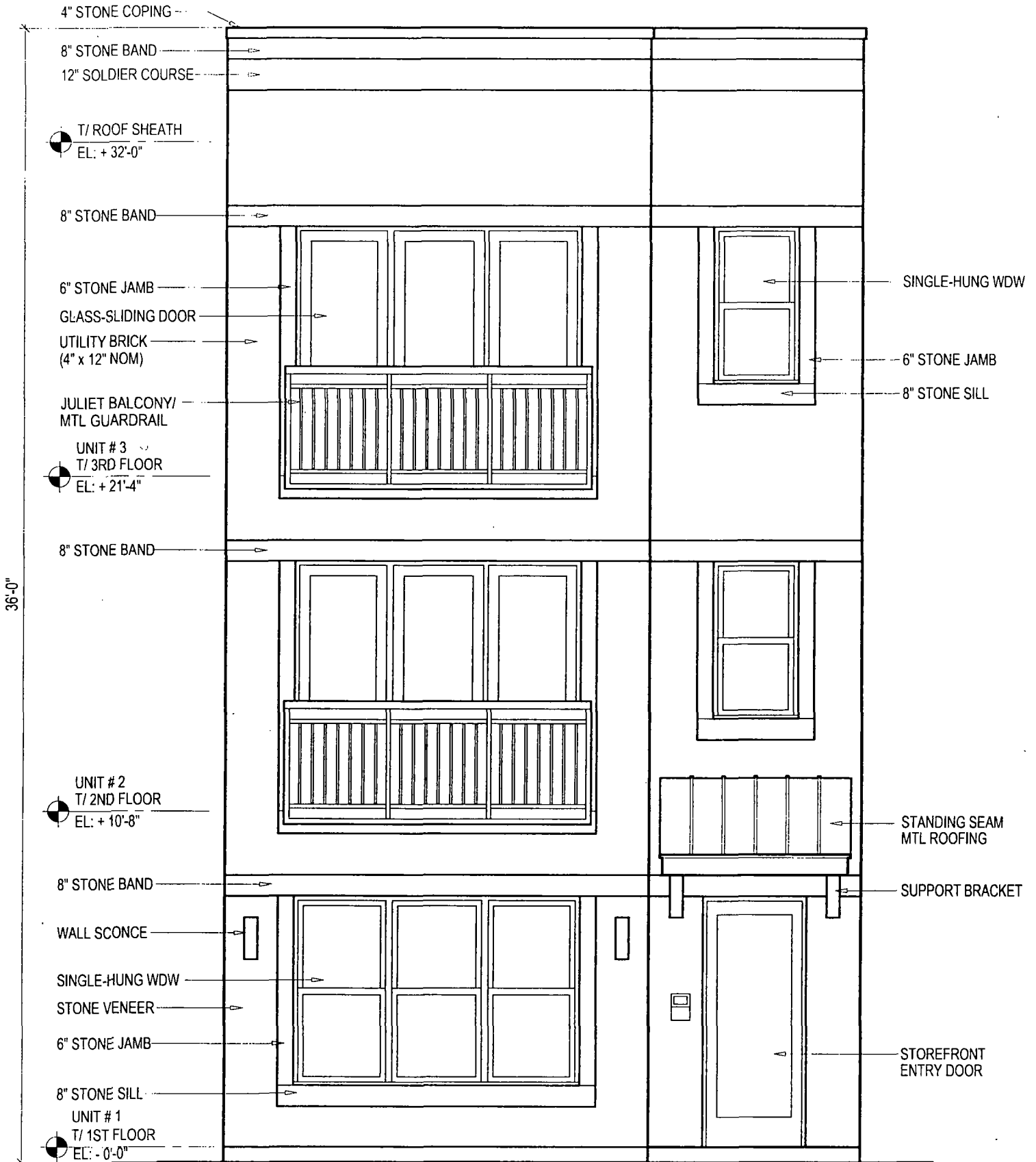
3RD FLOOR PLAN

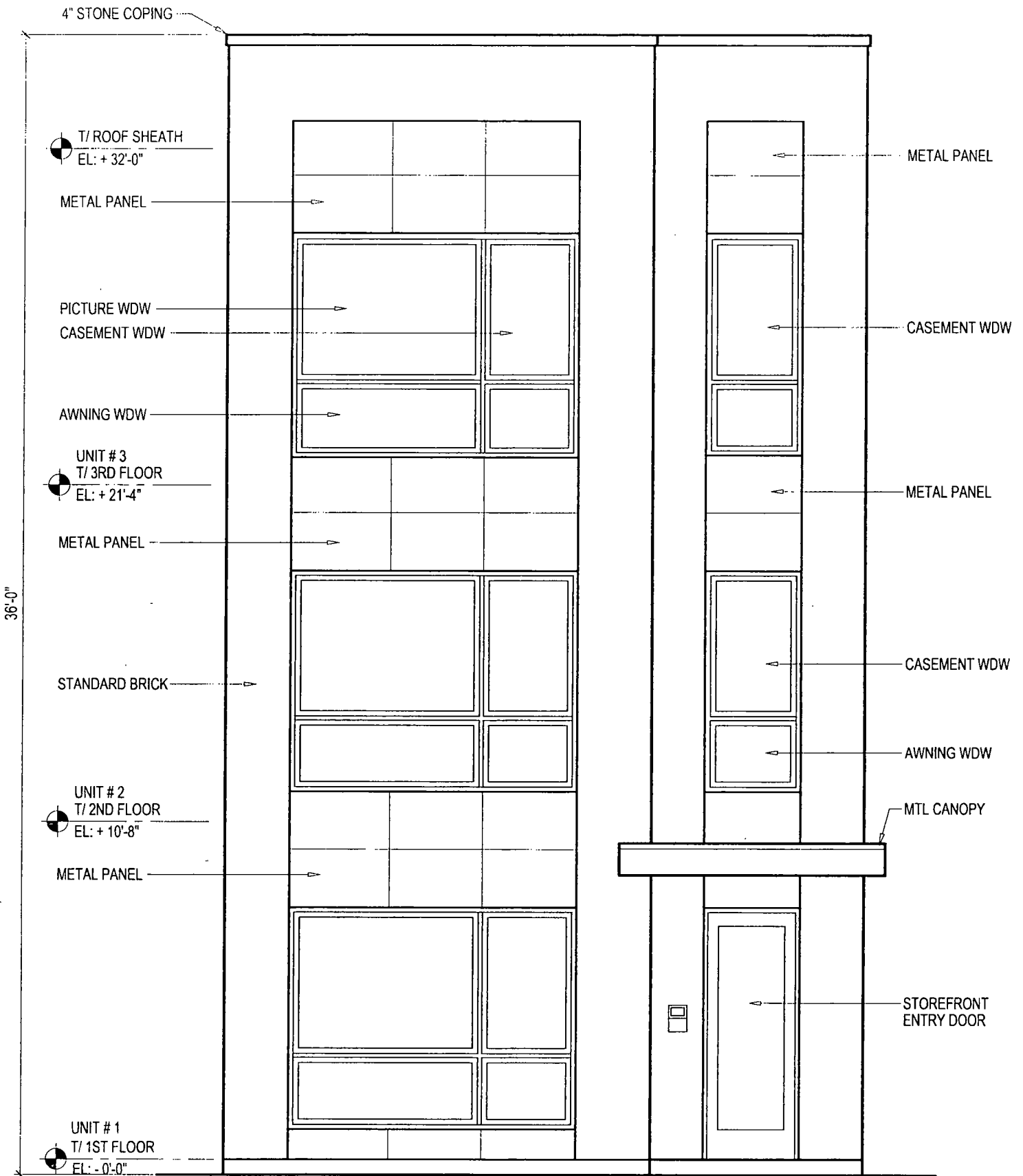

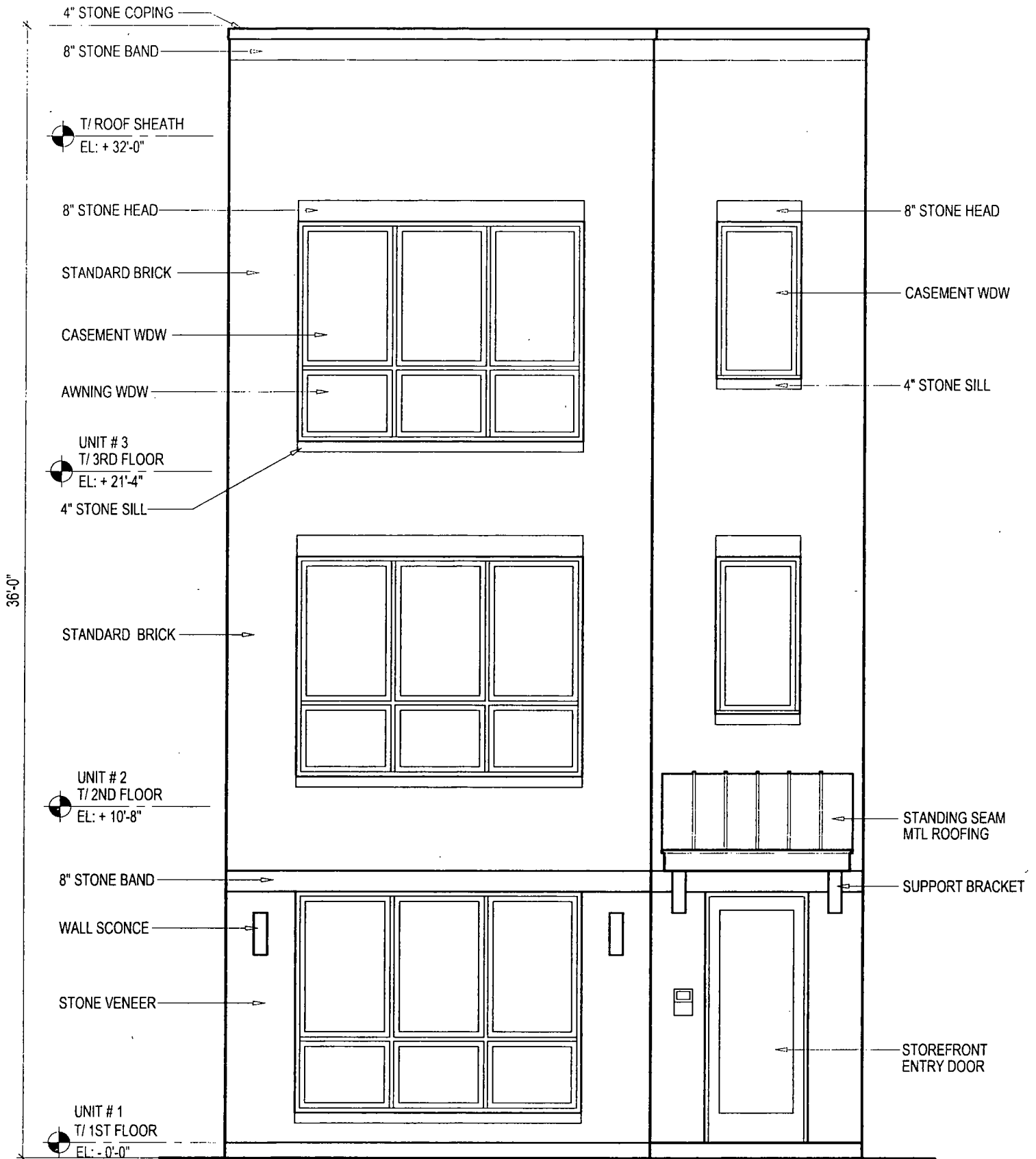
