## Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to HISPANIC HOUSING DEVELOPMENT CORPORATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, underground foundation footing encroaching under the public right-of-way adjacent to its premises known as 2127 W. Lawrence Ave..

Existing underground foundation footing at W. Lawrence measure(s): One (1) at one hundred seventy-eight point six six (178.66) feet in length, and one (1) foot in width for a total of one hundred seventy-eight point six six (178.66) square feet.

Existing underground foundation footing at N. Hamilton measure(s): One (1) at one hundred twenty-two (122) feet in length, and one (1) foot in width for a total of one hundred twentytwo (122) square feet.

Existing underground foundation footing at Public Alley South of West Lawrence. measure(s): One (1) at one hundred seventy-eight point six six (178.66) feet in length, and one (1) foot in width for a total of one hundred seventy-eight point six six (178.66) square feet.

Existing footing are twelve (12) inches at columns and four (4) inches at walls.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1107880 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 04/29/2013.
