## ORDINANCE

**WHEREAS**, the City of Chicago ("City") is a home rule unit of government as defined in Article VII, Section 6(a) of the Illinois Constitution, and as such may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City's Department of Community Development (including any successor department thereto, "DCD") is an executive department of the City established pursuant to Chapter 2-44 of the Municipal Code of Chicago (the "Municipal Code"), and supervises and coordinates the formulation and execution of projects and programs creating safe, decent and affordable housing for residents of the City; and

**WHEREAS**, by an ordinance adopted by the City Council of the City (the "City Council") on March 28, 2001, as amended by ordinances adopted on October 31, 2001, June 19, 2002, December 14, 2005 and November 1, 2006 (collectively, the "CPAN Ordinance"), the City established the Chicago Partnership for Affordable Neighborhoods Program ("CPAN Program"), in order to encourage developers to include owner-occupied affordable housing units in market-rate developments; and

**WHEREAS**, under the CPAN Program, the City agrees to waive certain development fees in exchange for a developer's agreement to construct affordable units in a market-rate development, sell the affordable units for affordable prices, and write-down the difference between the affordable price and the market rate price for a comparable unit in the same development; and

**WHEREAS**, pursuant to the objectives of the CPAN Program, DAGS Desplaines, LLC, an Illinois limited liability company ("Developer"), executed that certain "Chicago Partnership for Affordable Neighborhoods (CPAN) Application" ("CPAN Application"), whereby Developer agreed to sell 24 condominium units (the "Affordable Units") in the 237-unit condominium building located at 659 West Randolph Street and known as R+D659 Condominiums (the "Building") to income-eligible households for affordable prices; and

**WHEREAS**, the Building is included in Residential-Business Planned Development Number 1043 ("PD 1043"), adopted by the City Council on February 7, 2007, and published at pages 98611 to 98631 in the *Journal of Proceedings of the City Council of the City of Chicago* of such date; and

**WHEREAS**, PD 1043 also requires the Developer to provide the Affordable Units in return for the Building's receipt of an affordable housing floor area bonus pursuant to Section 17-4-1004 of the Chicago Zoning Ordinance; and

**WHEREAS**, the Developer constructed the Building and began marketing the Affordable Units in 2007, but has only sold five (5) of the 24 Affordable Units due to the recession and a slowdown in the housing market; and

**WHEREAS**, The Thresholds, an Illinois not-for-profit corporation ("Thresholds"), is a mental health services provider, offering a range of clinical, housing, outreach, education and employment services to people with mental illnesses; and

**WHEREAS**, Thresholds offers a variety of community housing options to its clients, ranging from supervised group homes to independent apartments, and serves approximately 600 people in the Chicagoland area; and

**WHEREAS**, Thresholds has offered to purchase the 19 remaining unsold Affordable Units in the Building for lease to clients for independent living with supportive services, and the Developer desires to sell the units to Thresholds; and

**WHEREAS**, Thresholds is also interested in purchasing one of the five previously sold Affordable Units in the Building (the "Owner-Occupied Unit") for lease to clients for independent living with supportive services; and

**WHEREAS**, Thresholds will perform a thorough assessment of all residents to ensure that each resident has the desire and the supports in place to integrate successfully into the Building; and

**WHEREAS**, Thresholds will assign a staff member to each resident to offer on-site and off-site comprehensive support services tailored to each resident's needs and desires, which may include counseling, skills training, case management, support with medications, appointments and other health and wellness issues, educational advancement, social supports, employment opportunities, and engaging other services as needed; and

**WHEREAS**, the CPAN Ordinance requires developers to sell CPAN units to individuals or households whose annual income does not exceed 100% of the Chicago-area median income ("CPAN Homebuyers"); and

**WHEREAS**, the CPAN Ordinance does not contemplate the sale of CPAN units to non-profit corporations or other organizations, and therefore Thresholds does not qualify as a CPAN Homebuyer; and

**WHEREAS**, the Owner-Occupied Unit is subject to an "Affordable Housing Restrictive Covenant and Agreement, Including Resale, Refinancing and Leasing Covenants, Conditions and Restrictions, and Purchase Option Rights" ("Restrictive Covenant"), which imposes certain resale restrictions and does not permit the sale of the unit to a non-profit corporation or other organization; and

**WHEREAS**, there is a lack of clean, safe, affordable housing for people with disabilities, leading to homelessness and costly and unnecessary institutional care; and

**WHEREAS**, Chicago's Five Year Housing Plan for 2009-2013 identifies the creation and preservation of affordable rental housing for people with disabilities as a top priority; and

**WHEREAS**, it is in the public interest to permit the sale of the 19 unsold Affordable Units and the Owner-Occupied Unit to Thresholds in order to increase the availability of housing options for people with mental disabilities; and

**WHEREAS**, Thresholds has agreed to lease such Affordable Units on a permanent basis (minimum one-year lease terms) to individuals or households whose annual income does not exceed sixty percent (60%) of the Chicago-area median income ("Income-Eligible Tenants"), subject to and in accordance with the terms and conditions of such regulatory agreements, mortgages, assignments or other documents or instruments that evidence, secure or govern the

loan or grant of funds for the purchase and operation of the Affordable Units from the Illinois Housing Development Authority and the Illinois Department of Human Services (collectively, the "State Financing Documents"); now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The above findings and recitals are hereby incorporated by reference and constitute a material part of this ordinance.

**SECTION 2.** The City Council hereby approves the sale of the 19 unsold Affordable Units to Thresholds, or to an entity of which Thresholds is the sole controlling party, for no more than \$125,750.00 per Affordable Unit. The City Council also approves the sale of the Owner-Occupied Unit to Thresholds, or to an entity of which Thresholds is the sole controlling party, for no more than the Maximum Purchase Price (as such term is defined in the Restrictive Covenant), and the release of the Restrictive Covenant encumbering the Owner-Occupied Unit. The sale of such Affordable Units is subject to the condition that, at the time of purchase, Thresholds shall execute, deliver and record an affordable housing covenant or lien ("Affordable Housing Covenant") in a form approved by DCD and the Corporation Counsel. Notwithstanding the foregoing, the Commissioner of DCD (the "Commissioner"), may elect not to record said Affordable Housing Covenant if the Commissioner determines, in his or her sole discretion, that the affordability requirements imposed upon the Affordable Units by the State Financing Documents achieve the City's affordable housing objectives. The sale of the Affordable Units to Thresholds as aforesaid shall satisfy Developer's affordable housing obligations with respect to the Building.

**SECTION 3.** The Commissioner or a designee of the Commissioner is each hereby authorized to negotiate, execute and deliver any documents as may be necessary or appropriate to implement the provisions of this ordinance, subject to the approval of the Corporation Counsel.

**SECTION 4.** If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

**SECTION 5.** All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

**SECTION 6.** This ordinance shall be in full force and effect immediately upon its passage and approval.
