A line 98.72 feet south of and parallel to West 73<sup>rd</sup> Street;

South Halsted Street;

a line 148.72 feet south of and parallel to West 73<sup>rd</sup> Street;

and the alley next west of and parallel to South Halsted Street

to those of a M1-1 Limited Manufacturing/Business Park District

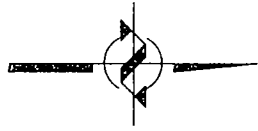

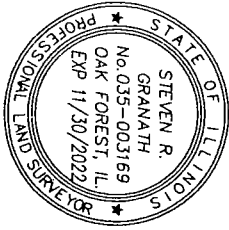

of



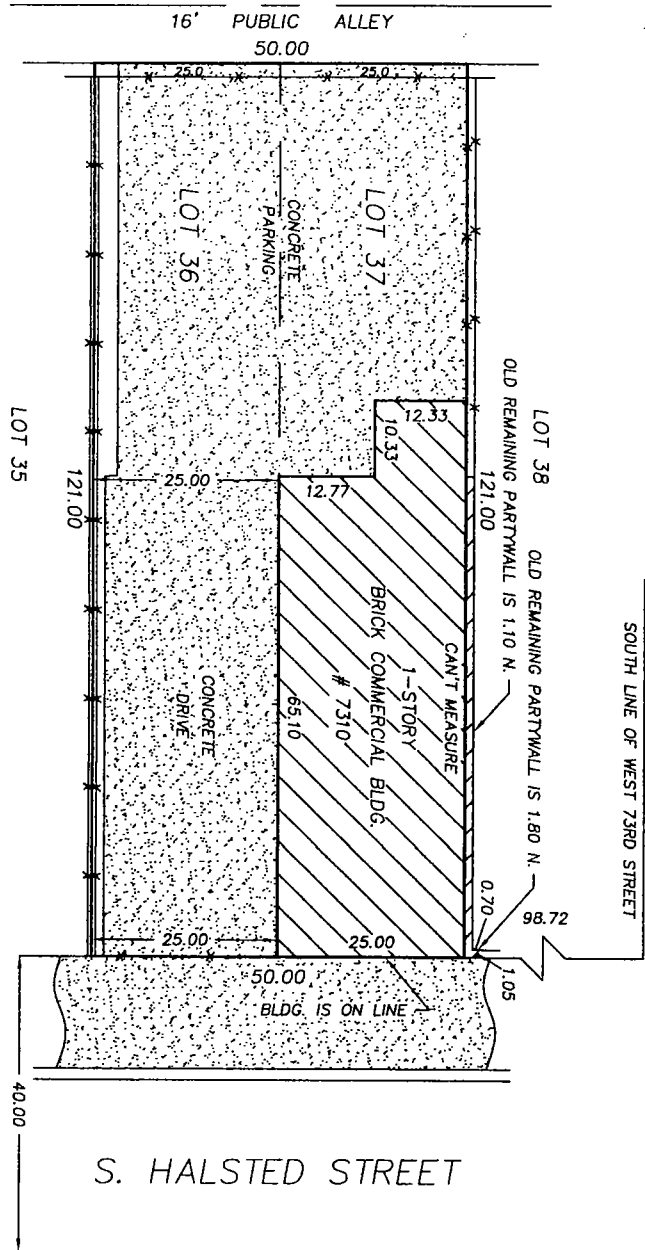
