ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited manufacturing/Business Park District symbols and indications as shown on Map No. 26 -A in the area bounded by:

A line 72.50 feet north of and parallel to east 108th street; the alley next east of and parallel to South Burley Avenue; East 108th Street; And South Burley Avenue

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

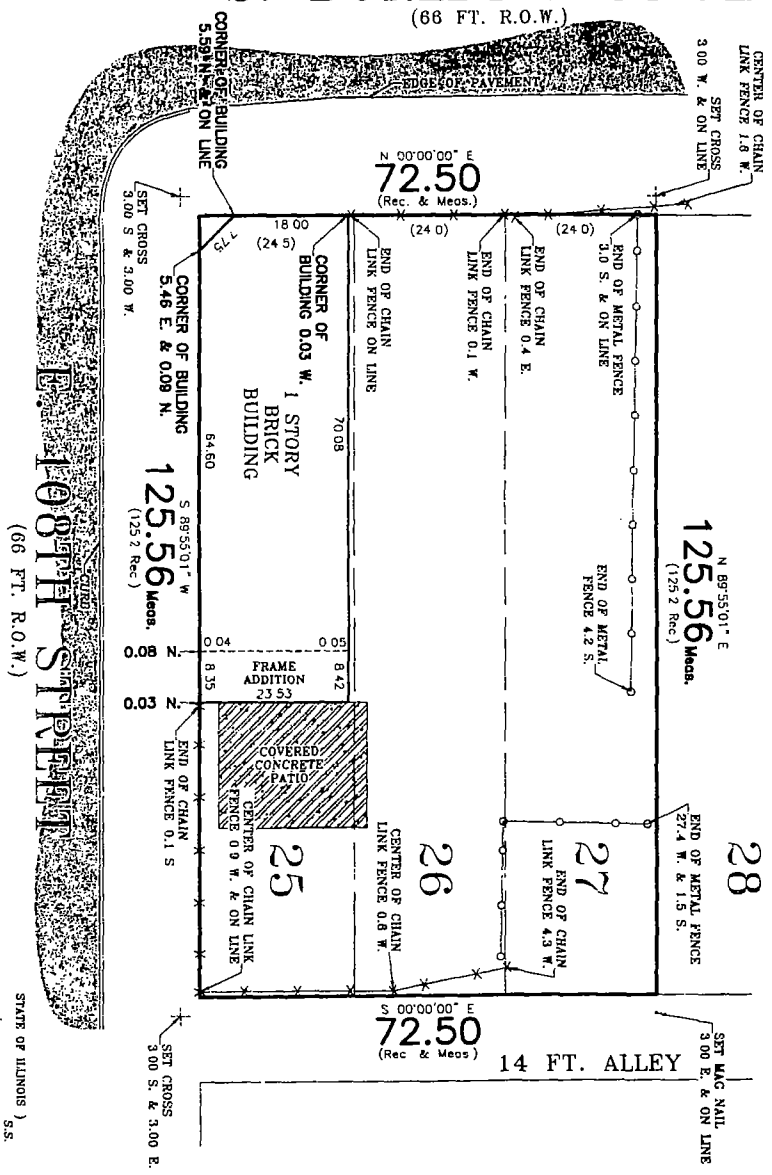
