**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No.2-K in the area bounded by

West Harrison Street; a line 475.65 feet east of and parallel to South Kilpatrick Avenue; the 16 foot east-west public alley just south of and parallel to West Harrison Street; a line 425.65 feet east of and parallel to South Kilpatrick Avenue

to those of C1-2 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance takes effect after its passage and approval

## Narrative

The applicant/owner seeks a Zoning Amendment for the lots located at 4613 - 4617 West Harrison Street in Chicago. The applicant/owner seeks an Amendment to the Chicago Zoning Ordinance to change the zoning to a C1-2 Neighborhood Commercial District designation to allow for all uses permitted in a C1-2 Neighborhood Commercial District.

A proposed retail store will occupy the existing one-story, 1,626.25 square foot, 13.67 foot tall building located at 4617 West Harrison Street. The eastern portion of the zoning lot will have three (3) parking spaces.

- **proposed land use**

The proposed use of the land is to allow for all uses permitted in a C1-2 Neighborhood Commercial District.

- **the project's floor area ratio**

Floor Area Ratio will be .289.

- **the project's density (lot area per dwelling)**

The project's density is zero.

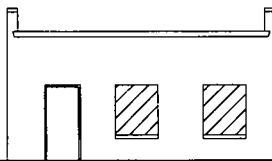

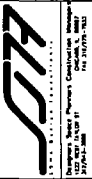
① PROPOSED NORTH ELEVATION
