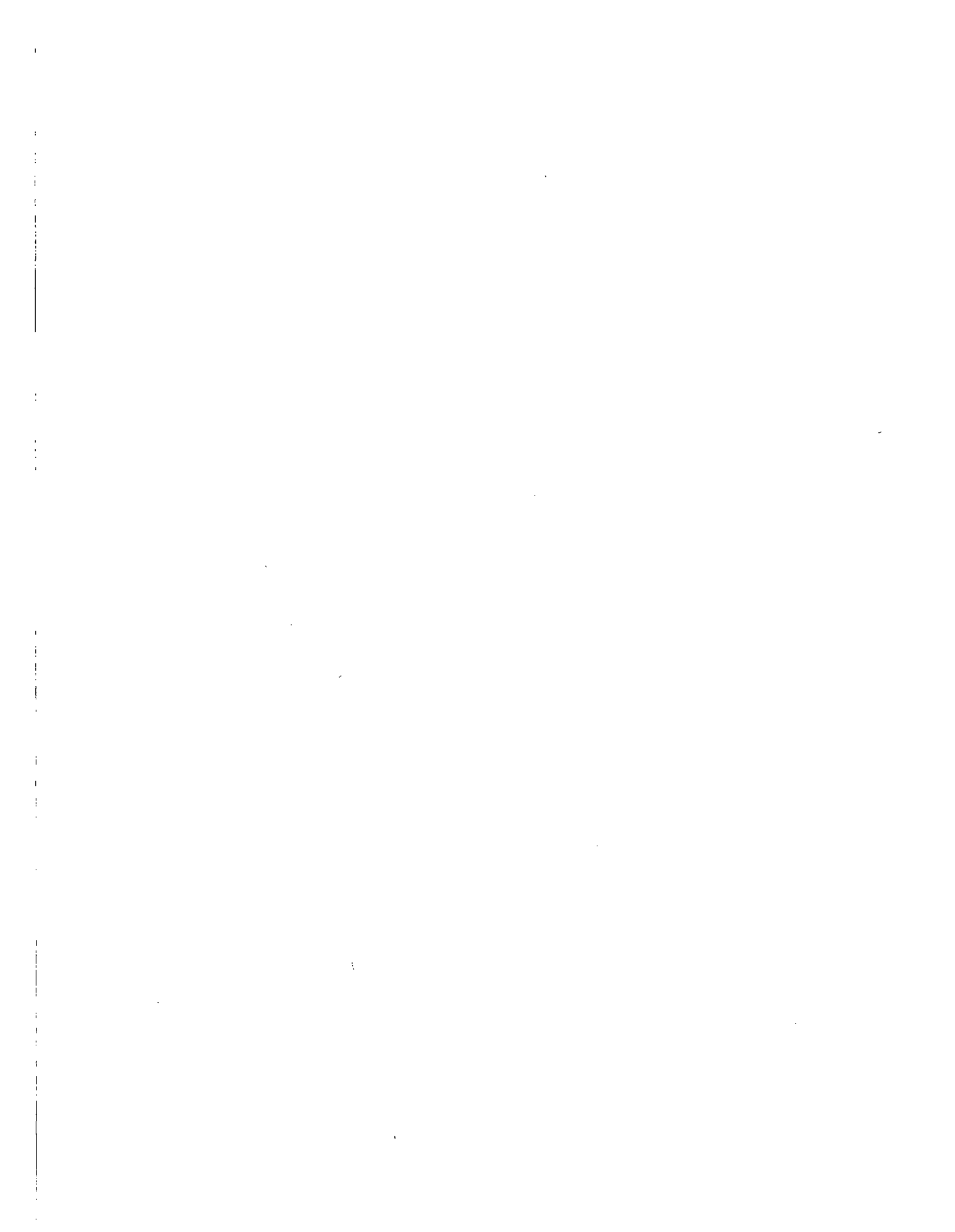

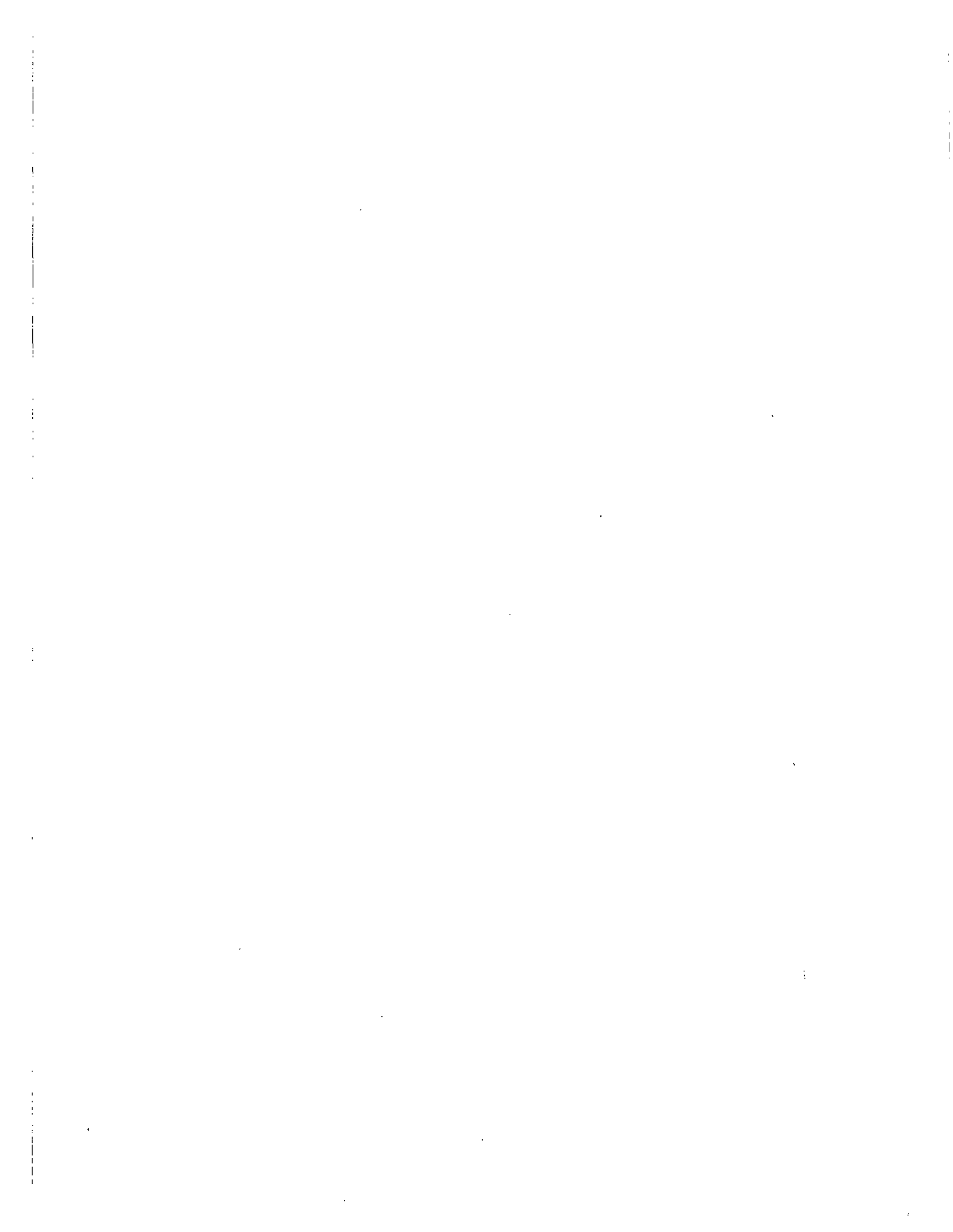
I have reappointed Harriet Johnson as a member of the Chicago Housing Authority Board of Commissioners for a term effective immediately and expiring July 7, 2019.
