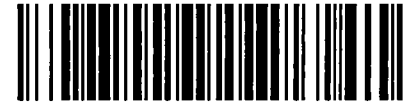

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 7-J in the area bounded by

The southwest boundary line of the Kennedy Expressway, a line 347 feet north of and parallel to West Barry Avenue; the public alley next east of and parallel to North Sawyer Avenue;;

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

FOR THE PROPOSED REZONING

3140 NORTH KEDZIE AVENUE**

The Application to change zoning for 3140 North Kedzie Avenue from B3-1, Community Shopping District to B2-3, Neighborhood Mixed-Use District. The Applicant intends to construct a three story, seven (7) dwelling unit building with basement and garage. The footprint of the building will be 51 feet 10 inches by 70 feet 5 inches in size. The building height shall be 36 feet high, as defined by Code.

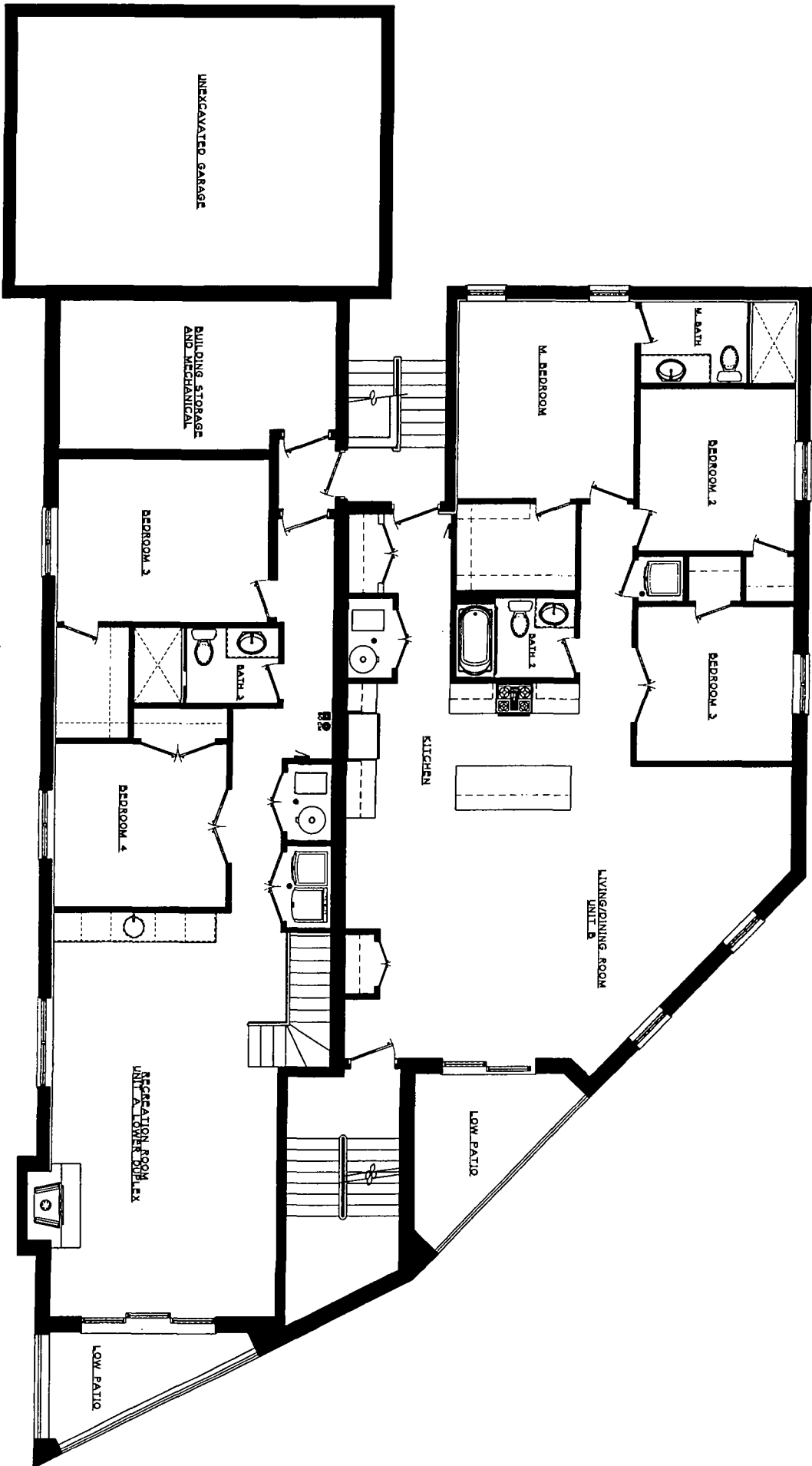

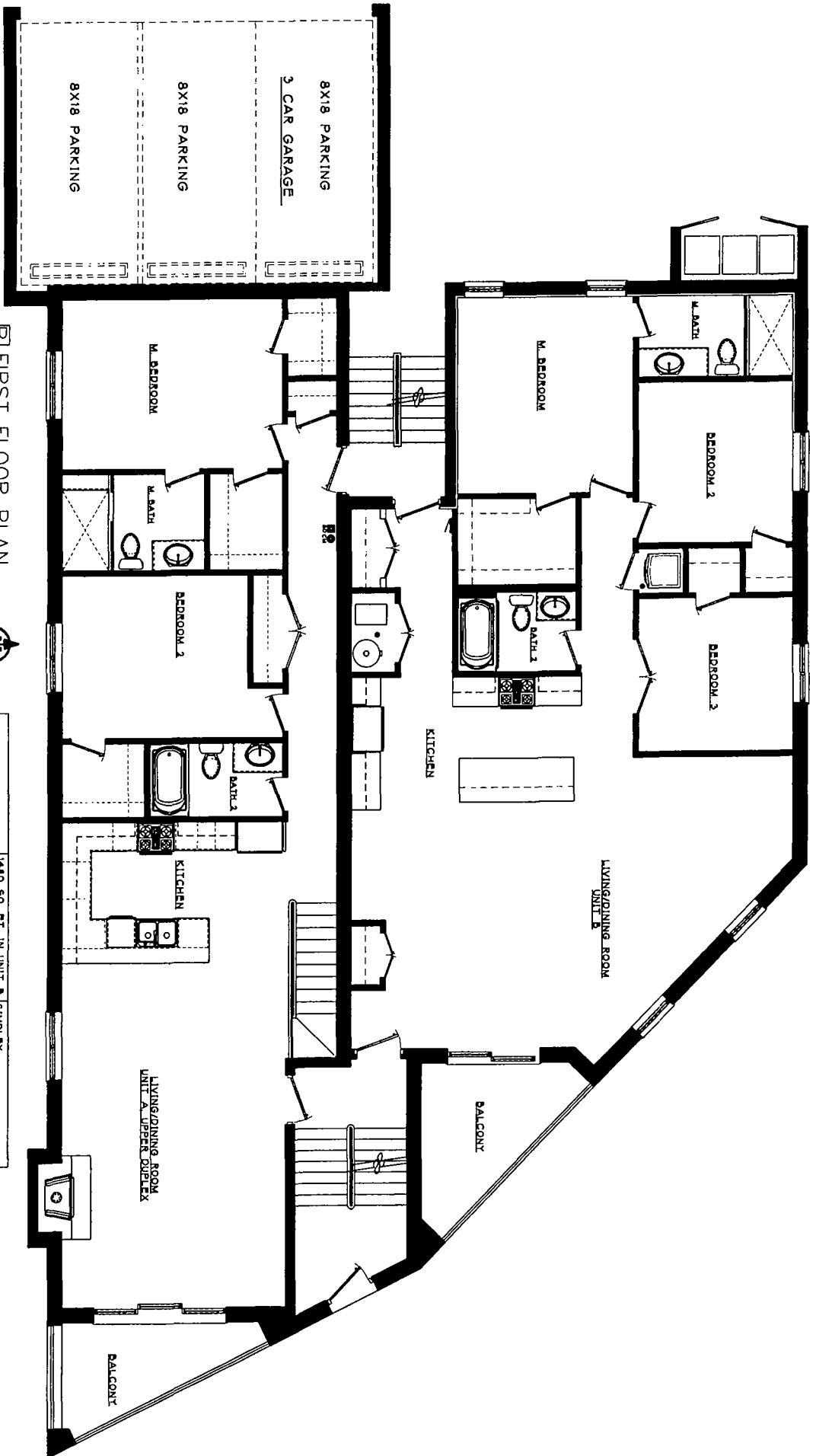

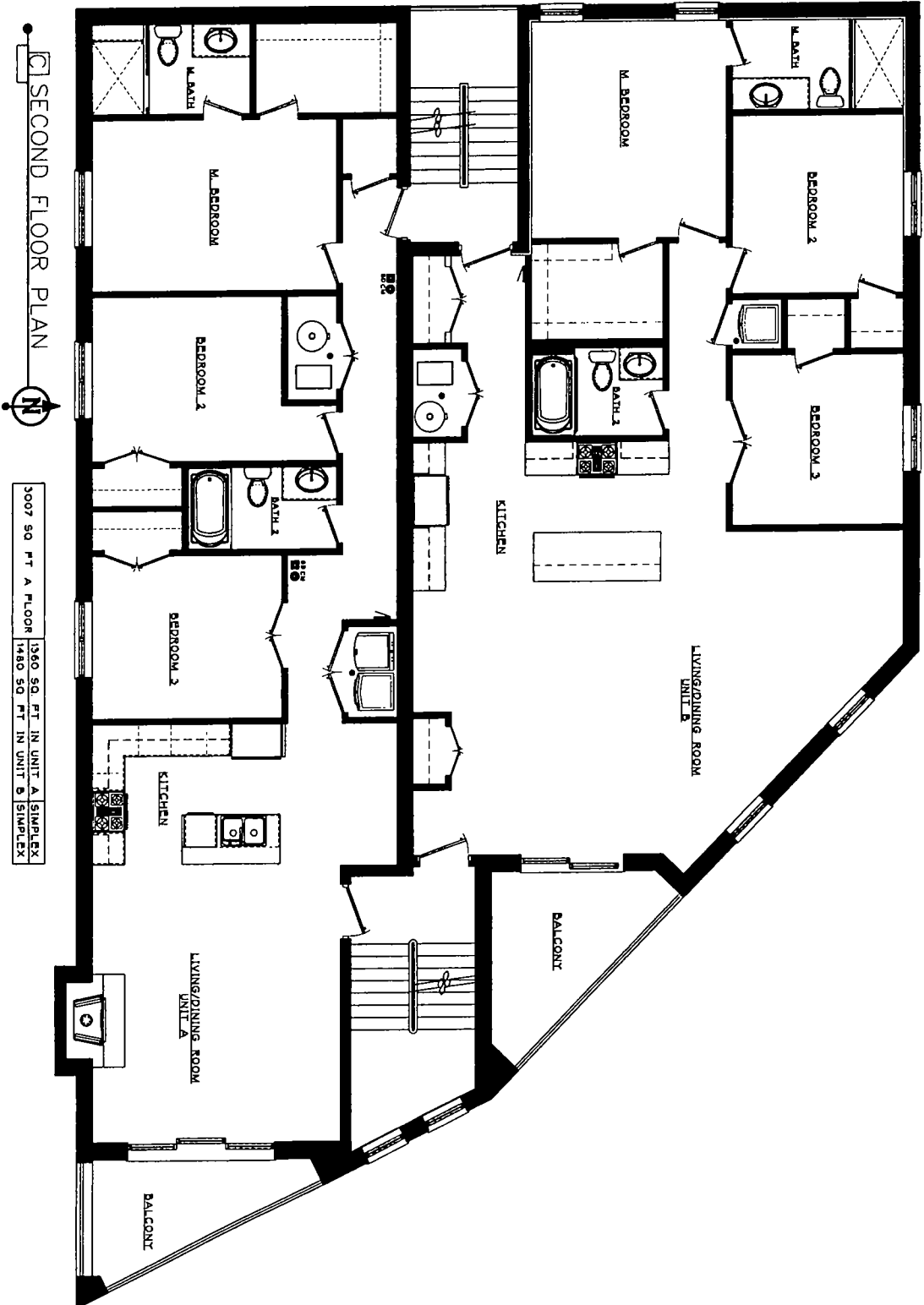


FIRST FLOOR PLAN



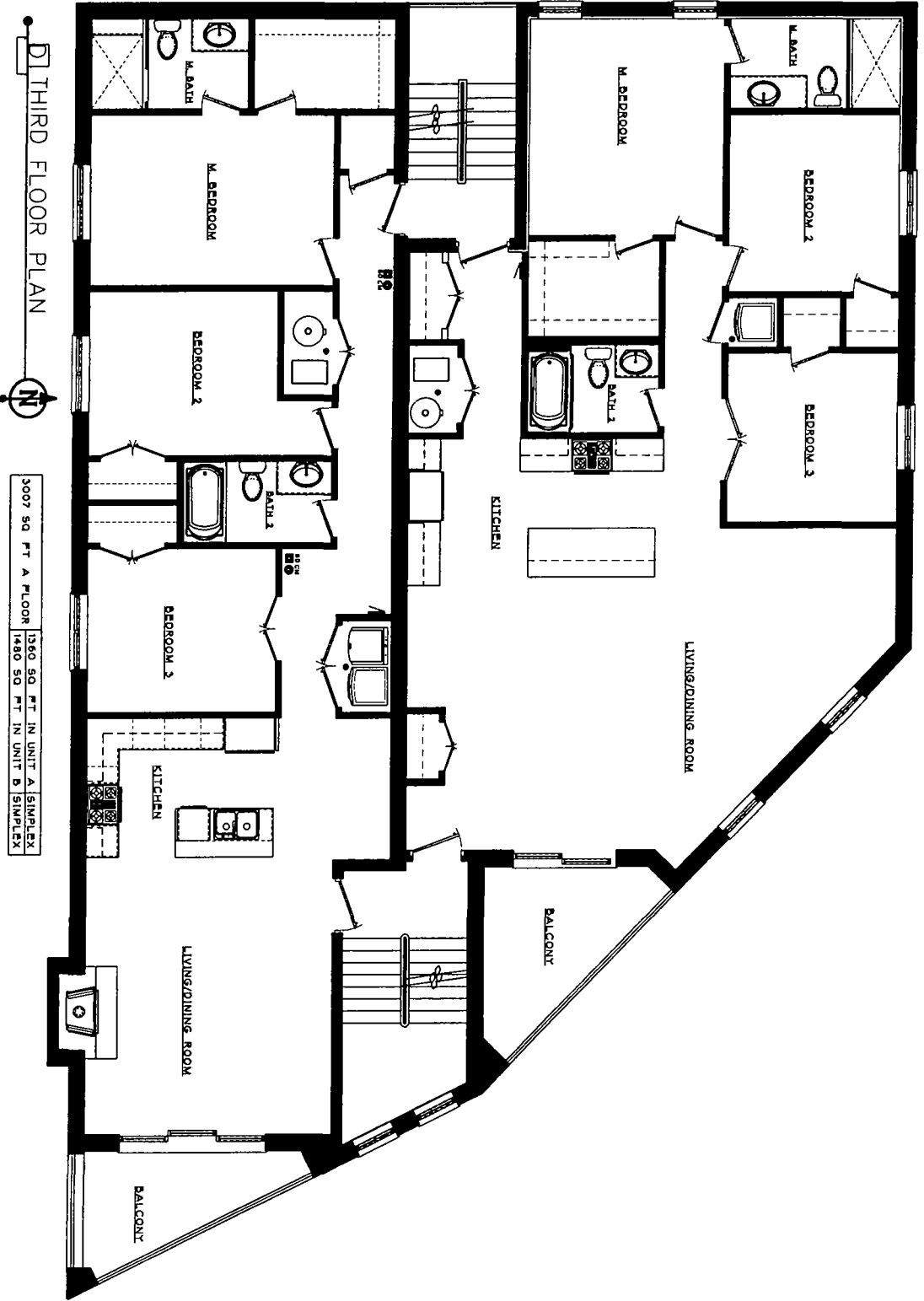

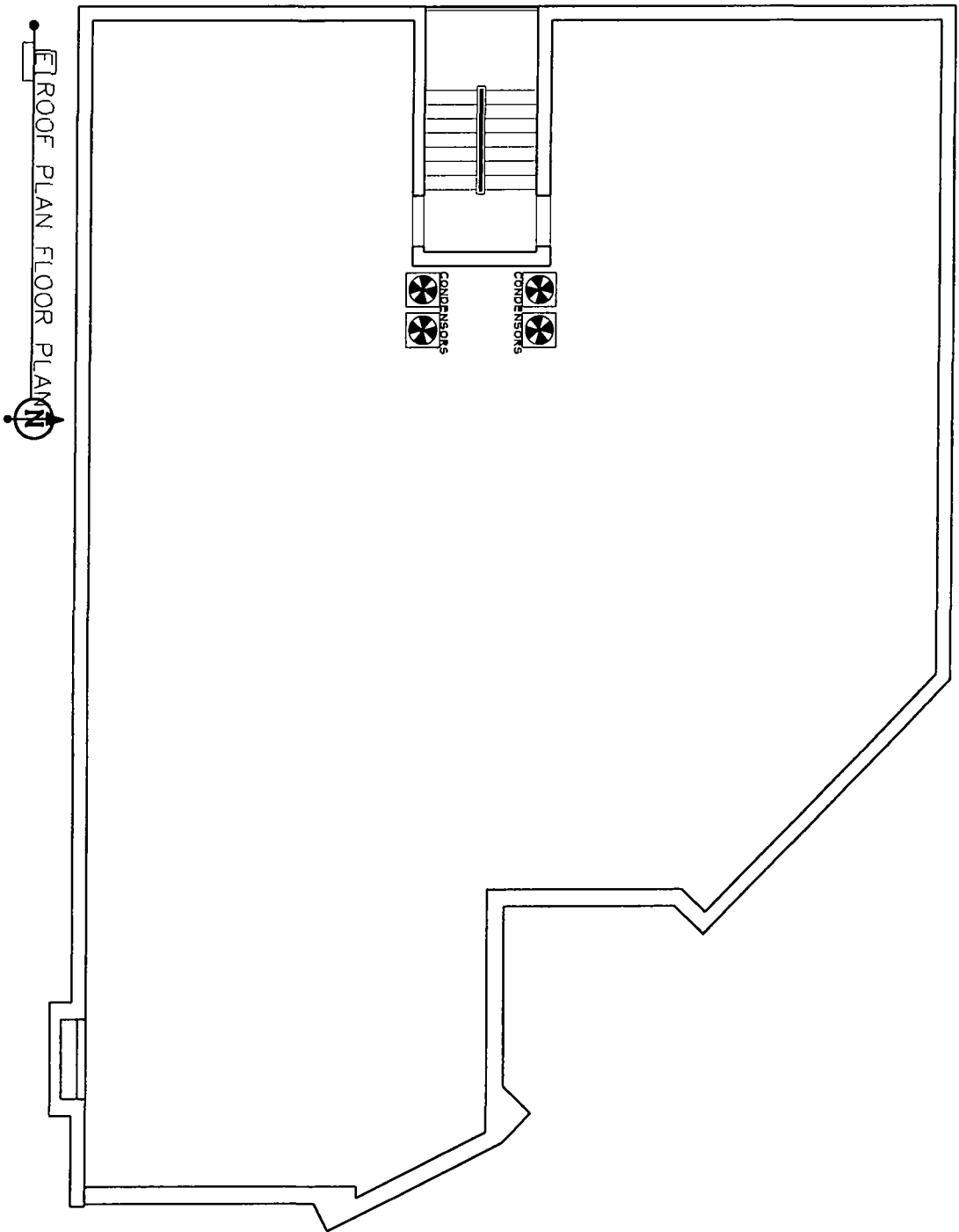

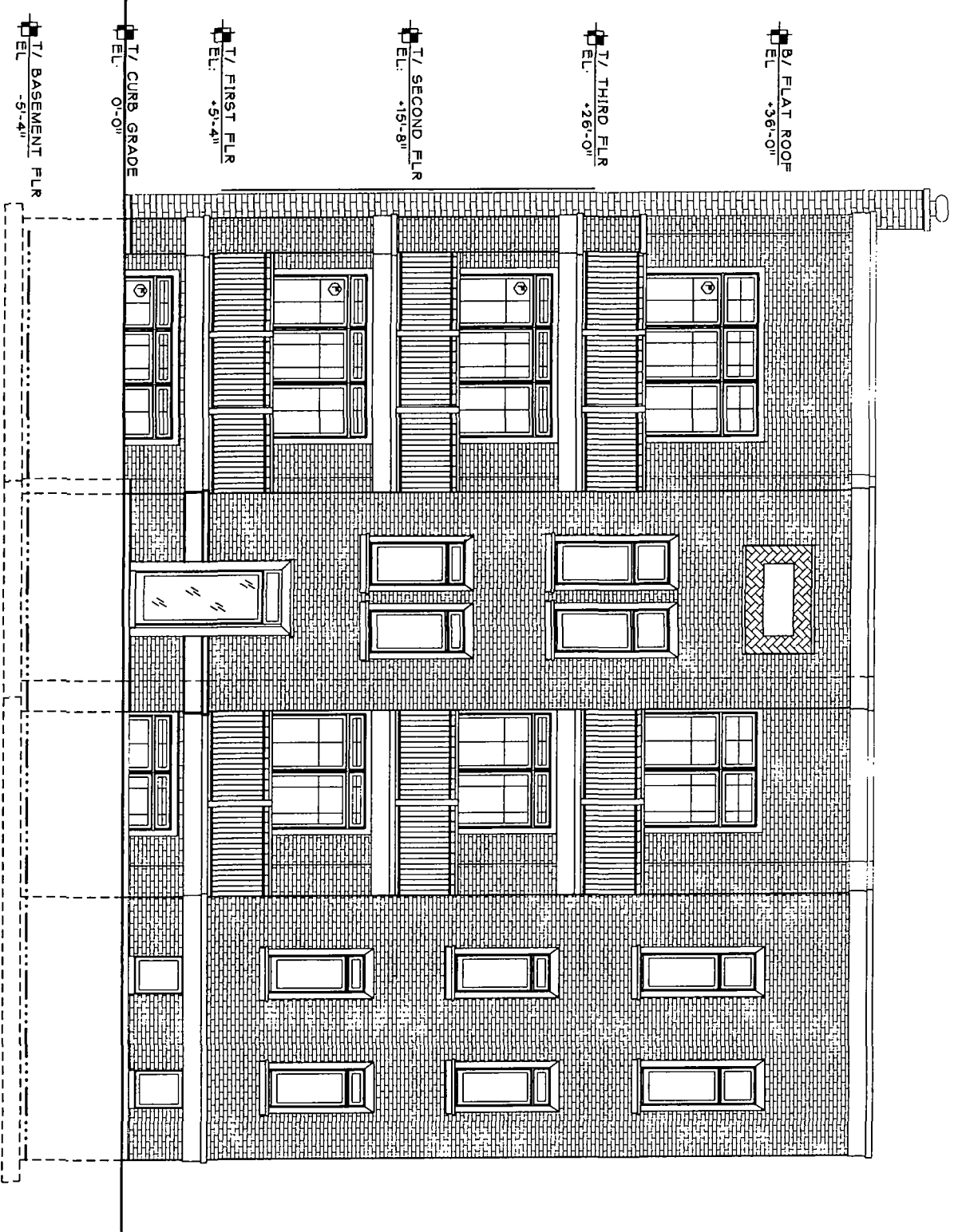

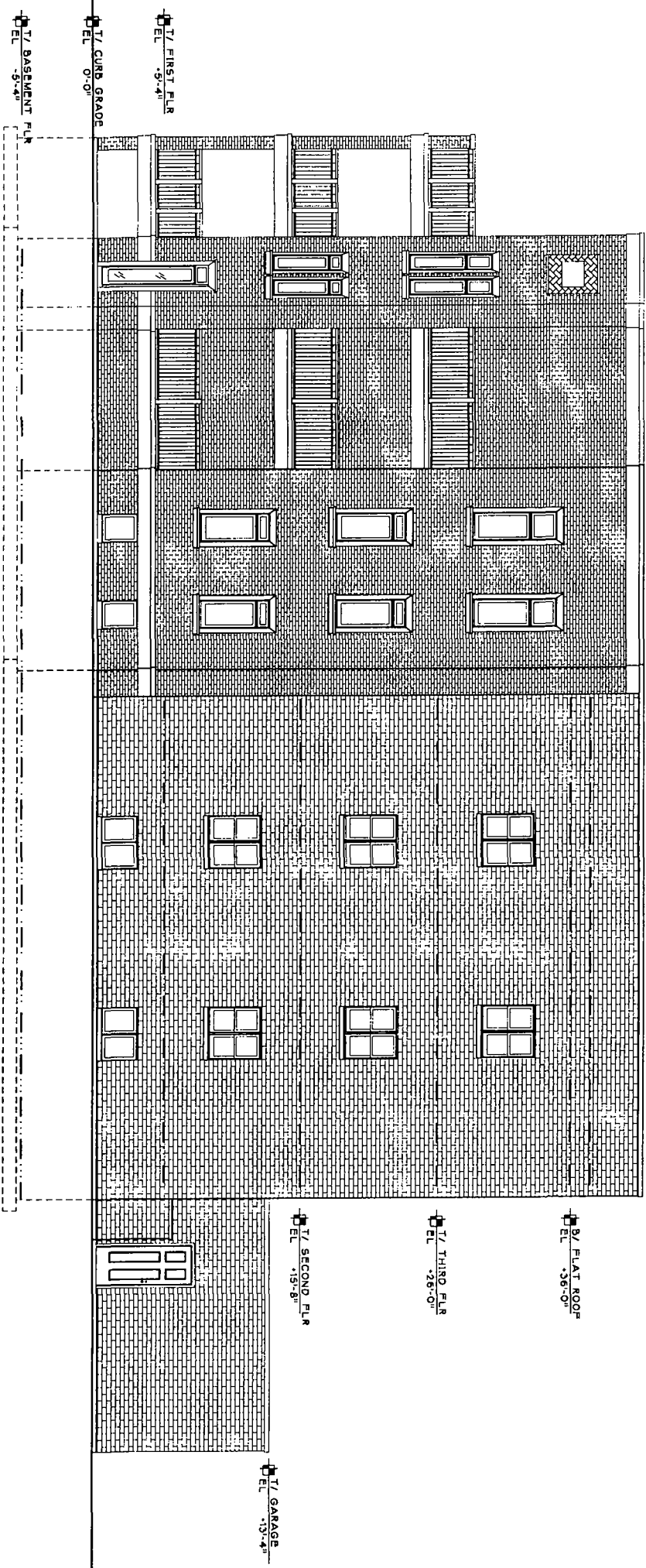

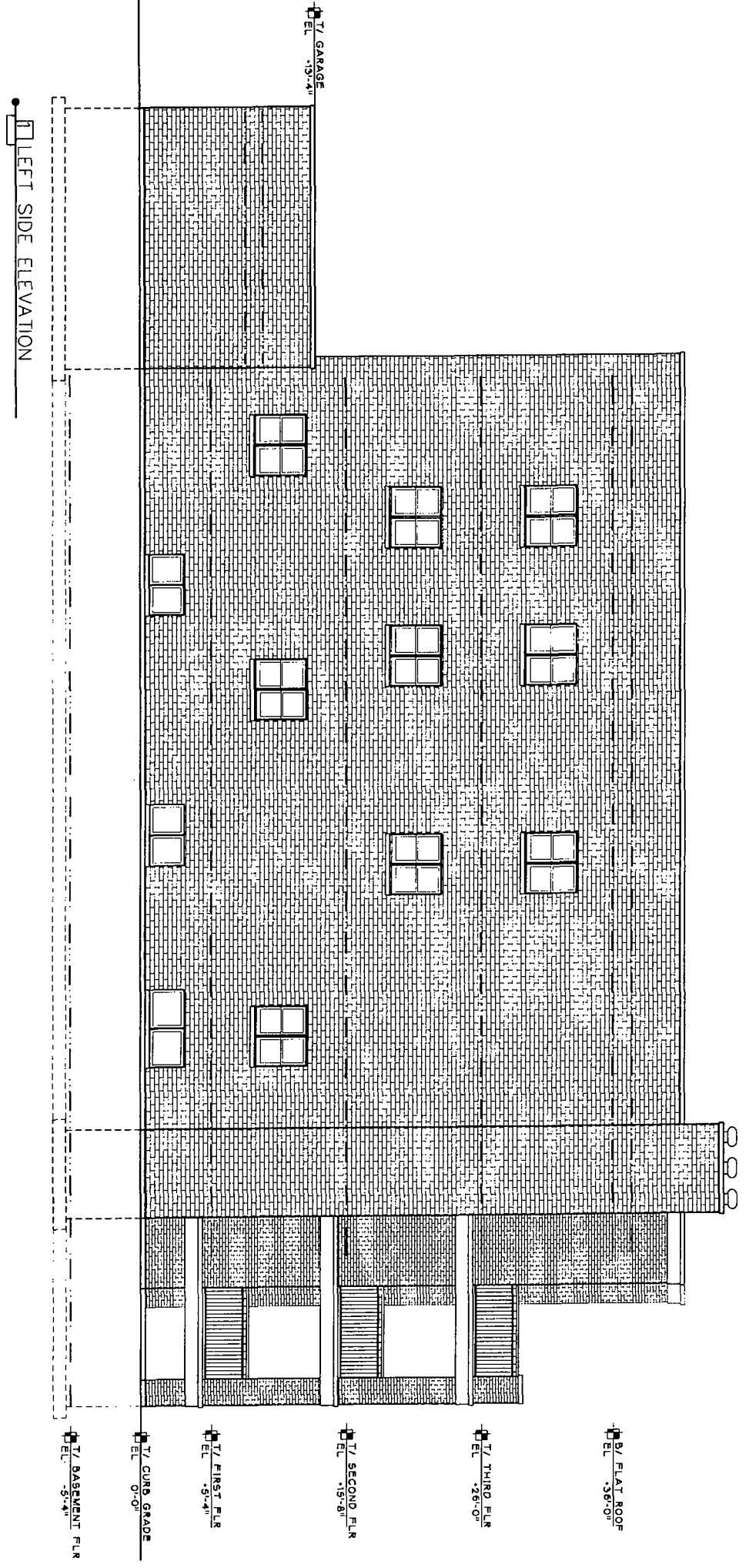
