ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District Symbols as shown on Map No. 3-M in the area bounded by:

The alley next north of and parallel to west Chicago Avenue; a line 350 feet east of and parallel to north Austin Blvd; West Chicago Avenue; and a line 325 feet east of and parallel to North Austin Blvd.

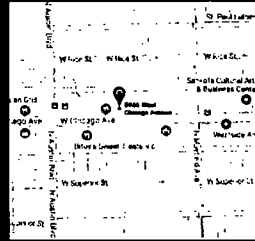
To those of a B3-2 Community Shopping District.
