ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B1-1, Neighborhood Shopping District symbols as shown on Map No. 3-I in the area bounded by:

A public alley next North of and parallel to West Division Avenue; a line 325.10 feet East of and parallel to North Washtenaw Avenue; West Division Avenue; a line 300 feet East of and parallel to North Washtenaw Avenue.

To those of a B1-2, Neighborhood Shopping District

SECTION 2. This Ordinance takes effect after its passage and approval.
