ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current C1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 1-G in the area bounded by:

a line 100.55 feet north of and parallel to West Lake Street; a line 150.82 east of and parallel to north Carpenter Street; West Lake Street; and a line 125. 64 feet east of and parallel to North Carpenter Street

to those of a DX-3 Downtown Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

1010 West Lake Street TYPE I REGULATIONS

Narrative: The subject property is improved with a three-story mixed-use building with 1,278.00 square feet of ground commercial space, 264.00 square feet of ground floor office/storage space, and one residential dwelling duplex unit above the ground floor. The Applicant proposes to rezone the property from a C1-1 Neighborhood Commercial District to a DX-3 Downtown Mixed-Use District to construct a 649.00 square foot expansion to the third floor of the residential dwelling duplex unit. 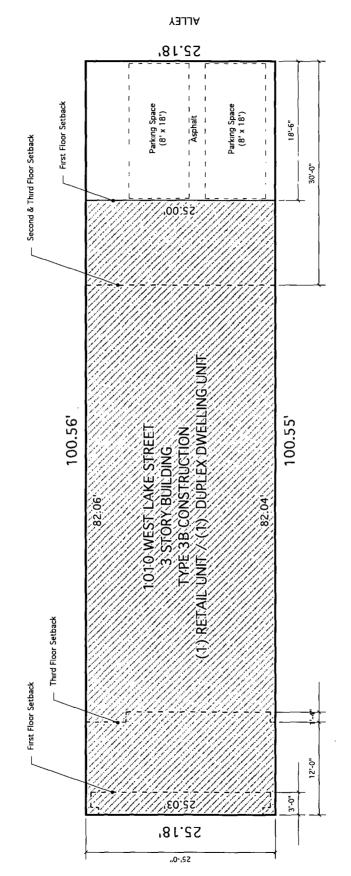

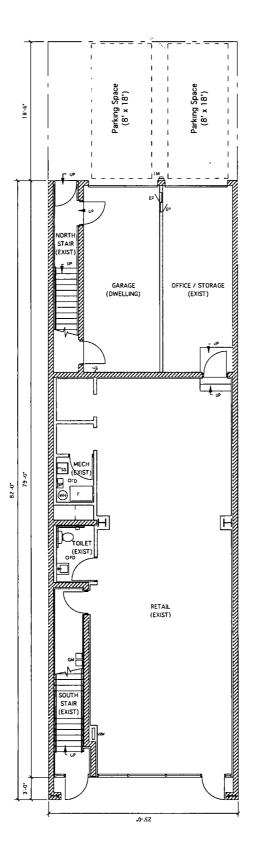

SITE PLAN 1010 West Lake Street Chicago, IL 60607

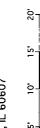

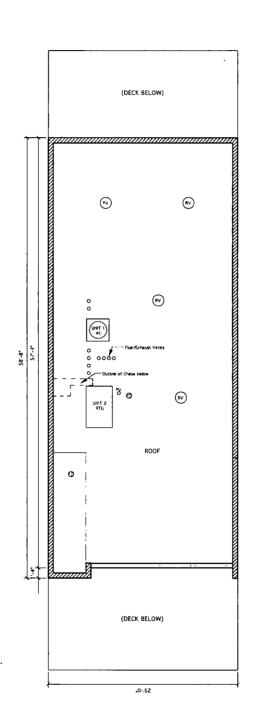








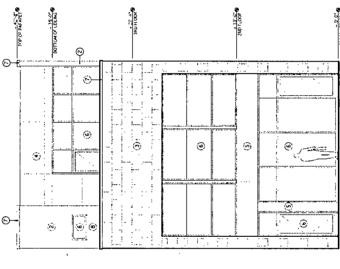








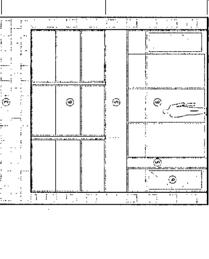




FRONT ELEVATION - SOUTH
