WHEREAS, Elmer E. Mied was an active and vital member of his community. The beloved husband of the late Olga (nee Mayer); loving father of Larry (Gail); cherished grandfather of Laura (Charlie) Kaemerer, Erica (Skyler) Clark and Jessica (Erik) Canzona; great-grandfather of Cassie and Cameron; fond brother of Lorraine (the late Lloyd) Sisson (Wes Kaetzel), Dorothy (the late Lee) Giernoth, and the late Arthur Mied; dear uncle of Carol (Jim) Littwin, Janet Mays and many other nieces and nephews; special friend of Joe and Betty Ferina, Elmer E. WHEREAS, Elmer E. Mied was born at Hirsch and Kostner Avenues in Chicago and moved about five miles north in his 88 years; and

WHEREAS, Elmer E. Mied attended Noble School and Austin High School before volunteering for service in the United States Army in February, 1943; and

WHEREAS, Elmer E. Mied served in the United States Army during World War II; and

WHEREAS, Elmer E. Mied had served the United States Army in the New Guinea, the Northern Solomon Islands and the Philippine Islands Campaigns; and

WHEREAS, Elmer E. Mied also fought on Guadalcanal, Munda, Mindanao, and numerous other Philippine and Northern Solomon Islands; and

WHEREAS, Elmer E. Mied will be deeply missed, but the memory of his character, intelligence and compassion will on in those who knew and loved him; now, therefore.
