BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1:

The ordinance passed by the City Council of the City of Chicago for **THE LITTLE BEET TABLE** on **02/22/2017**, and printed upon page **43827** of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words "Said sidewalk cafe area #1 shall be thirty-four point three three (34.33) feet in length and six point five (6.5) feet in width, area #2 shall be forty-one point four two (41.42) feet in length and six point seven five (6.75) feet in width for a total of five hundred two point seven three (502.73) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along E Chestnut St. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday thru Thursday 11:30 am until 9:30 pm

Friday and Saturday 11:30 am until 10:00 pm

Compensation: \$1,156.28

SEATING CAPACITY: 22 "

and inserting in their place the words

"Said sidewalk cafe area #1 shall be thirty-five point zero eight (35.08) feet in length and six point five (6.5) feet in width, area #2 shall be forty-one point four two (41.42) feet in length and six point seven five (6.75) feet in width for a total of five hundred seven point six one (507.61) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along E Chestnut St. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday thru Thursday 11:30 am until 9:30 pm

Friday and Saturday 11:30 am until 10:00 pm

Compensation: \$1,167.49
