Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Chicago Department of Transportation or its assigners, is hereby authorized and directed to approve an alley dedication and an alley opening legally described as

SECTION 2. The dedication is accepted upon the express condition that it be constructed according to the current version of the Chicago Department of Transportation *Regulations for Opening, Repair and Construction in the Public Way* and its appendices, and as agreed to by the applicants in the attached Duty to Build Agreements (Exhibits C, D), hereby made a part of this ordinance.


SECTION 3. The dedication herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, RAA Development LLC and/or Ridgeway Acquisition LLC, or their agent(s), shall deposit in the City Treasury of the City of Chicago, a sum sufficient to defray the costs of removing paving and curb returns, and constructing sidewalk and curb at the entrance to that part of the alley hereby dedicated; and constructing the new alley to be dedicated, in accordance with current Department of Transportation Construction Guidelines for construction of public way.

SECTION 4. The dedication and opening herein provided for are made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the applicant shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the attached plats approved by the Department of Transportation / Superintendent of Maps


SECTION 5. This ordinance shall take effect and be in force from and after its passage. This dedication and opening shall take effect and be in force from and after the recording of the respective plats.
