CW 600 WEST CHICAGO, LLC

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CW 600 WEST CHICAGO, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Pedestrian Walkway(s) projecting on the public right-of-way adjacent to its premises known as 600 W. Chicago Ave..

Said Pedestrian Walkway(s) at River Level under Chicago Avenue Bridge measure(s):
One (1) at seventy-six (76) feet in length, and twelve (12) feet in width for a total of nine hundred twelve (912) square feet. Existing pedestrian walkway beneath the Chicago Avenue bridge connect with the 600 West river walk to the river walk of One River Place.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1108248 herein granted the sum of five thousand eight hundred five (\$5,805.00) per annum in advance.

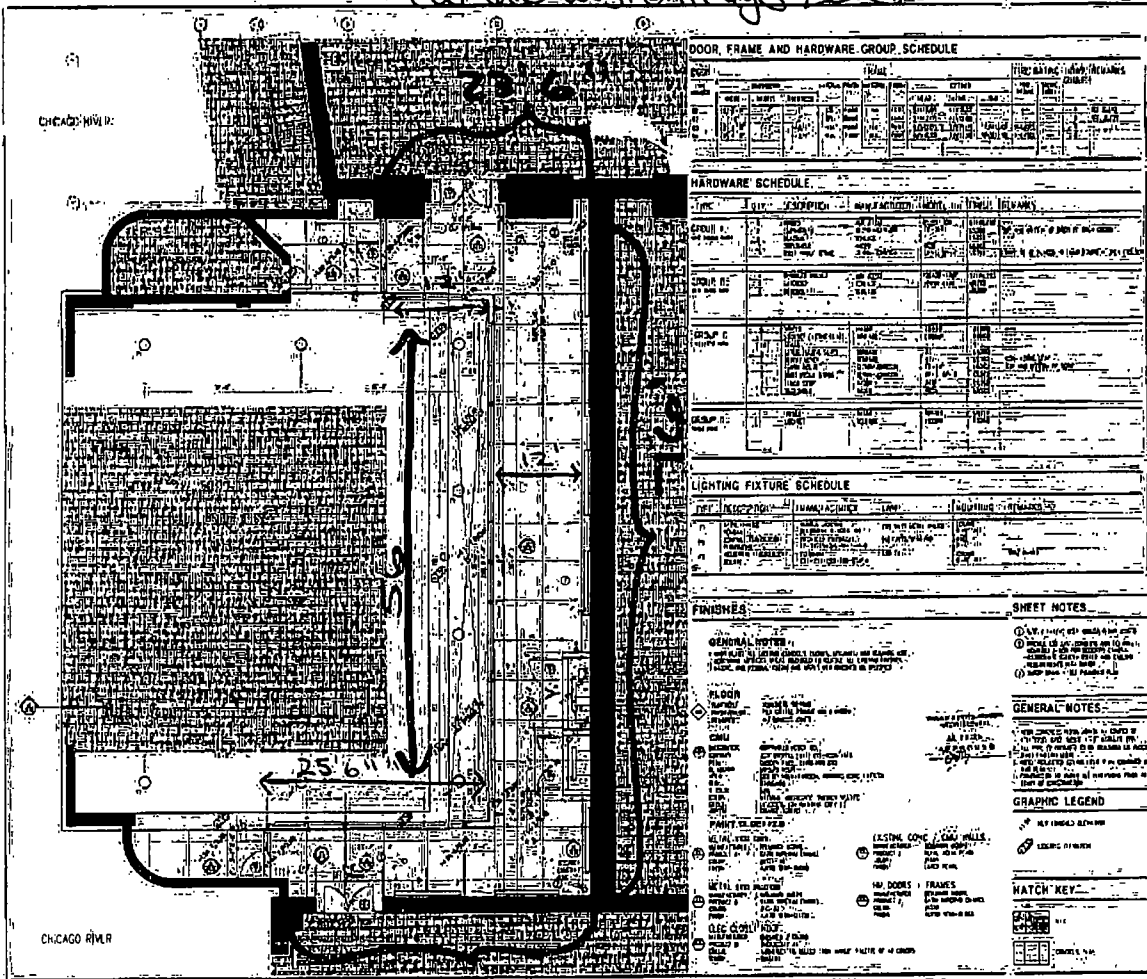
A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
