ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-3.5, Residential Two-Flat Townhouse and Multi-Unit District symbols and indications as shown on Map No. 7-G in the area bounded

West Addison Street; North Lakewood Avenue; the east-west, public alley next north of and parallel West Addison Street; and a line 33.01 east of and parallel to North Lakewood Avenue

to those of a B2-3, Neighborhood Mixed-Use District.

Section 2. This ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 11, 2013 the undersigned will file an application for a change in zoning from RT-3.5, Residential Two-Flat Townhouse and Multi-Unit District to B2-3, Neighborhood Mixed-Use District for the property located at 3607-09 North Lakewood, Chicago, Illinois.

The Applicant intends to renovate the existing 3-story building providing a total of six (6) residential units, (1) commercial unit on the ground floor, and four (4) surface parking spaces. The purpose of this application is to legally establish one of the six existing residential units. The existing frame parking garage will be removed and four (4) surface parking spaces established.

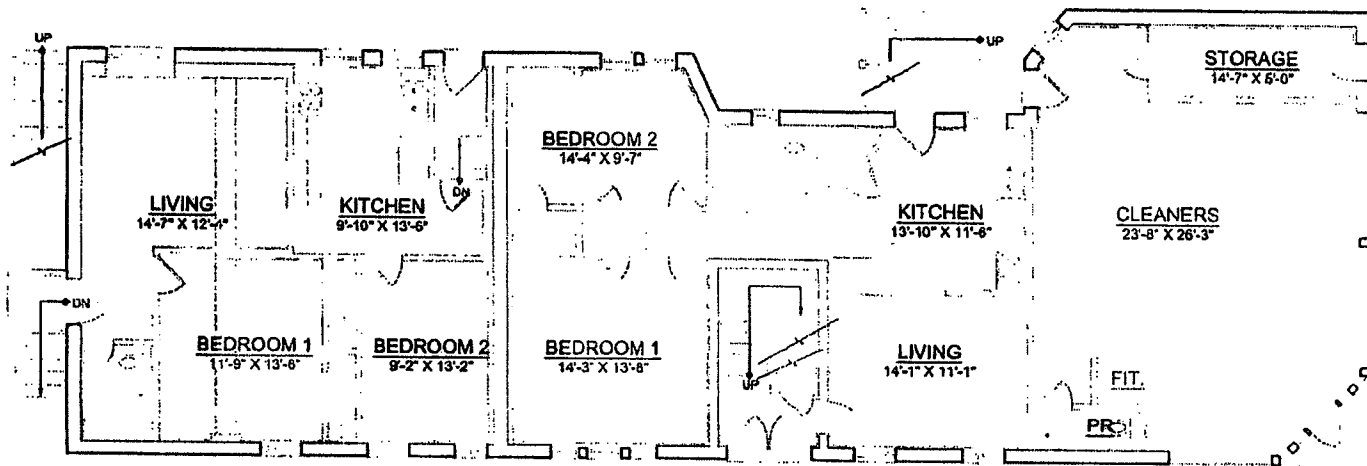

FIRST FLOOR PLAN

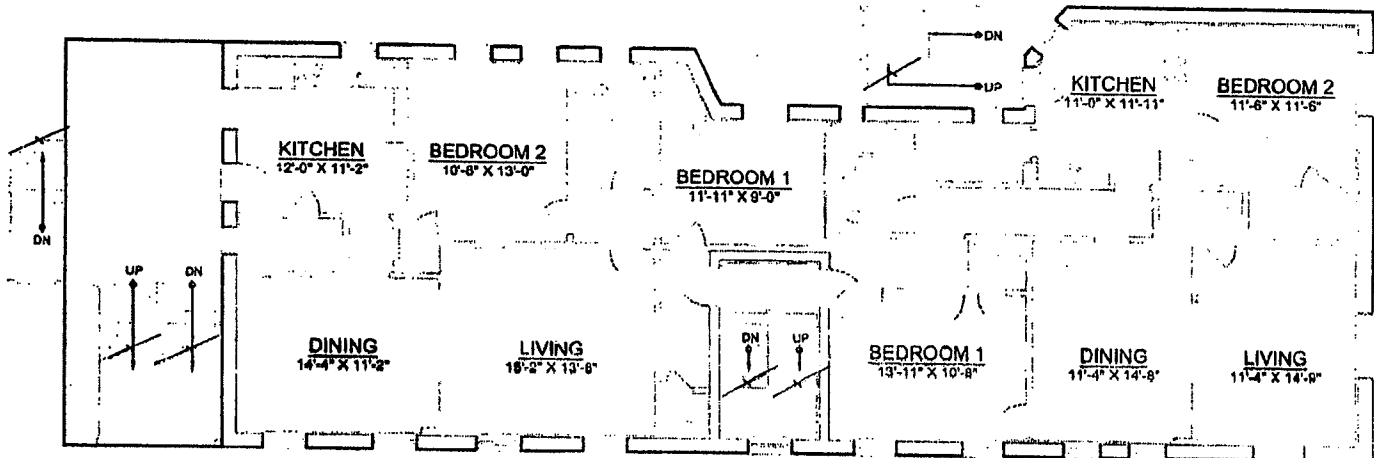

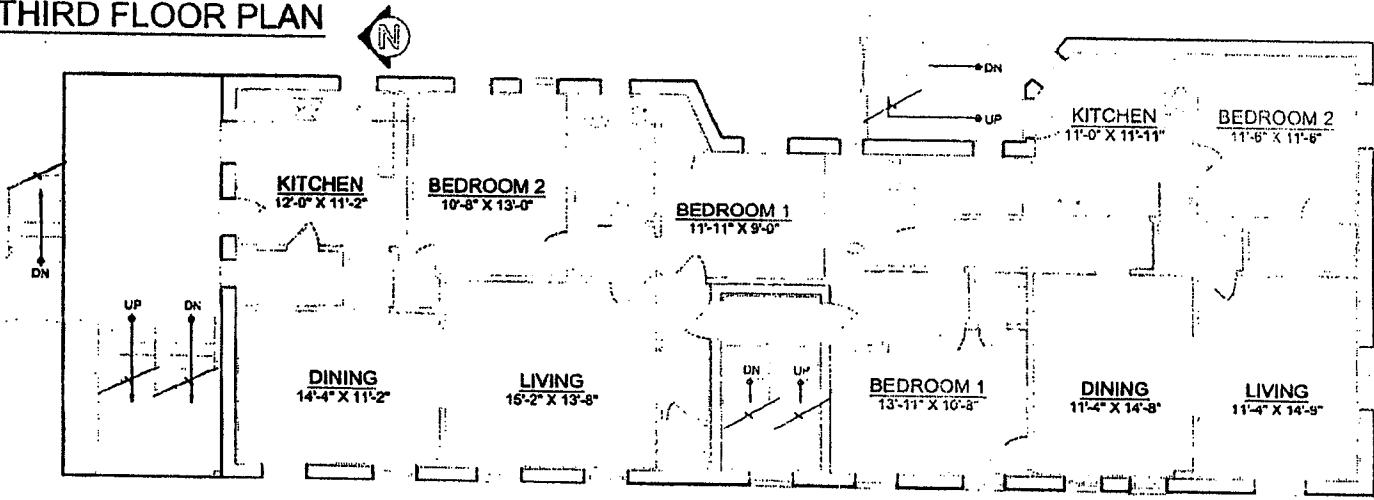

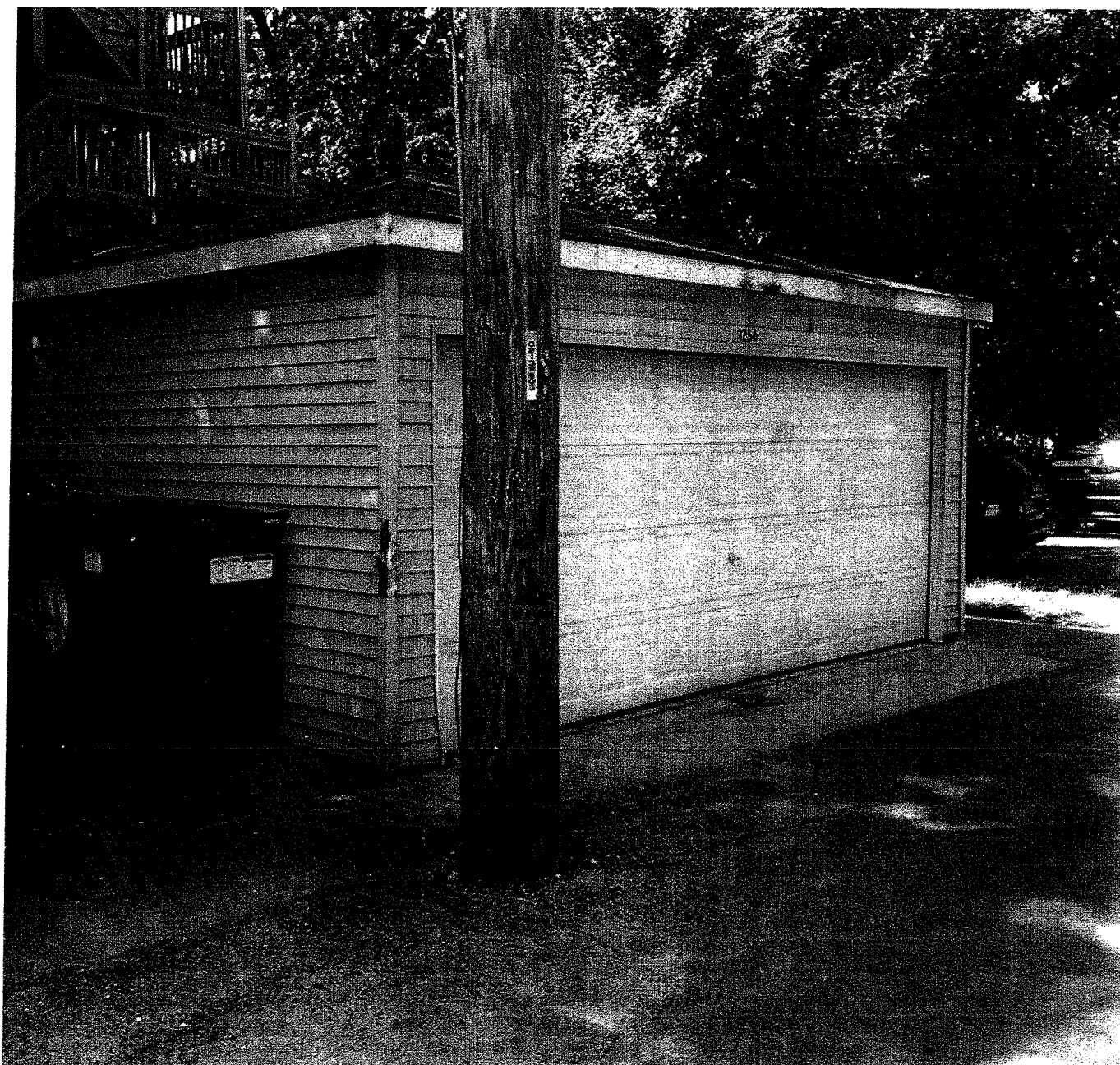
