Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SILVER TOWER CHICAGO, CONDOMINIUM ASSOCIATION LLC upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Retaining Wall(s) on the public right-of-way adjacent to its premises known as 303 W OHIO ST.

Said Retaining Wall(s) at W. OHIO ST. measure(s):

One (1) at forty-seven point three (47.3) feet in length and one (1) feet in width for a total of forty-seven point three (47.3) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1588724 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


