ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-G in the area bounded by

the alley next north of and parallel to West Walton Street; the alley next southwest of and parallel to North Milwaukee Avenue; West Walton Street; and North Noble Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

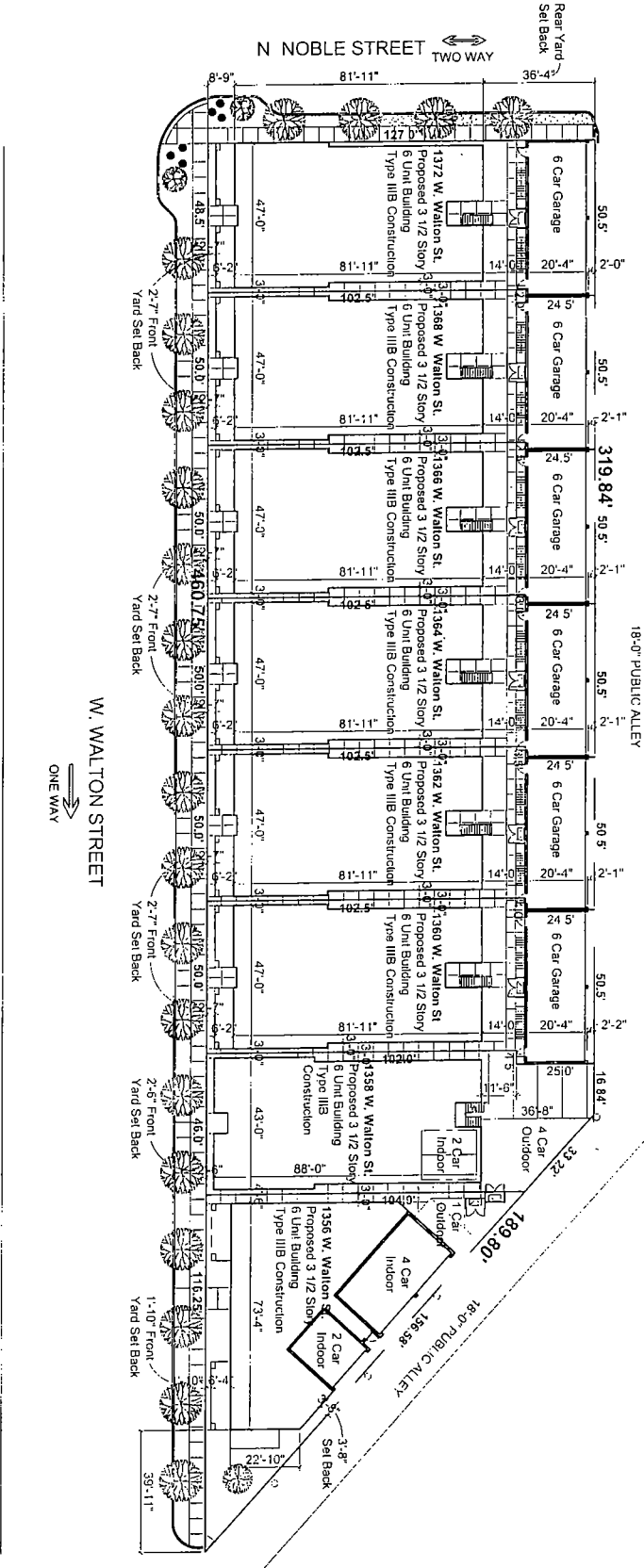
Proposed Land Use: The Applicant is seeking a zoning change in order to permit the construction of eight (8) new three-and-half-story residential buildings, at the subject site. Seven (7) of the new buildings will contain a total of six (6) dwelling units and the eighth building will contain a total of five (5) dwelling units – for a total of forty-seven (47) dwelling units, at the site, in its entirety. Each new proposed building will have its frontage on Walton Street, with on-site parking, for six (6) vehicles, located at the rear of each building, and one (1) additional ‘guest parking space’ – for a total of forty-nine (49) off-street parking spaces, on the site. 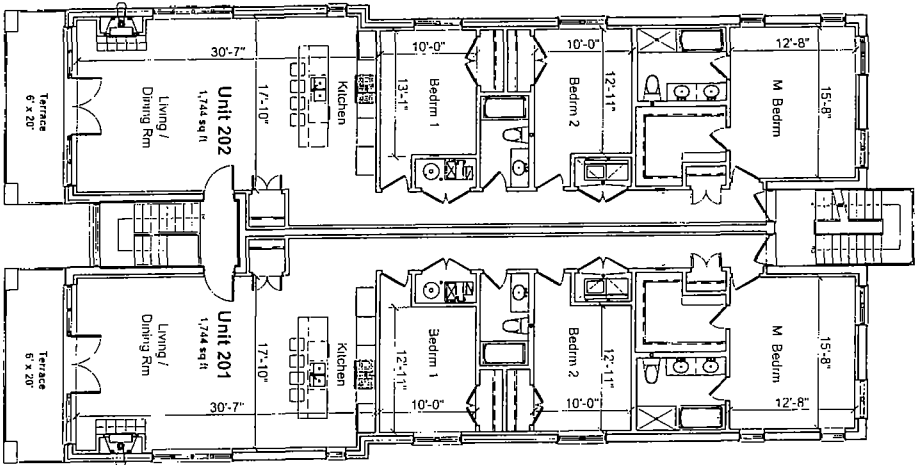

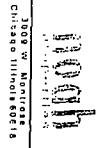
Walton Street Typical 6 Flat Elevations

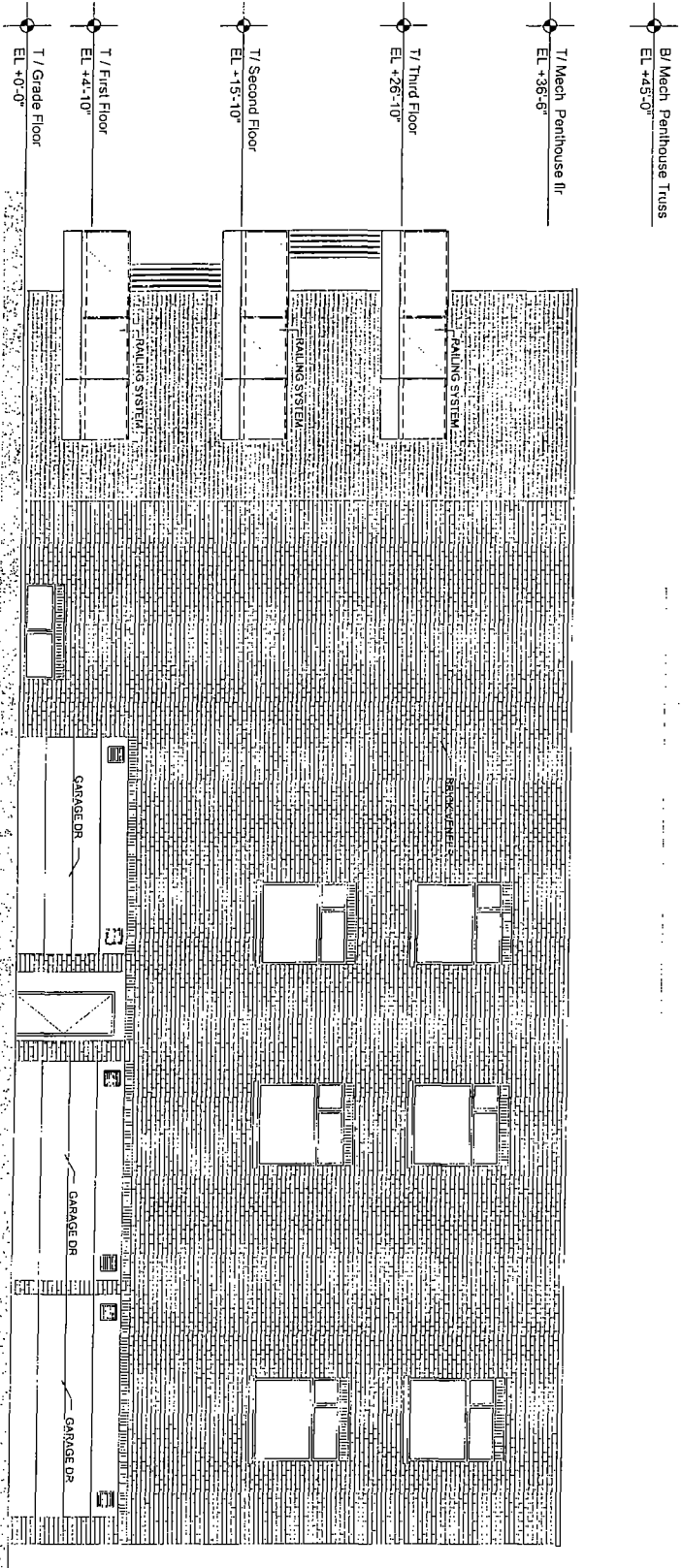

1356 Walton North Elevation

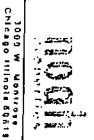
