ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 6-J in the area bounded by

South Drake Avenue; West 25th Street; the public alley immediately east of and parallel to South Drake Avenue; and a line 30 feet south of West 25th Street,

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.



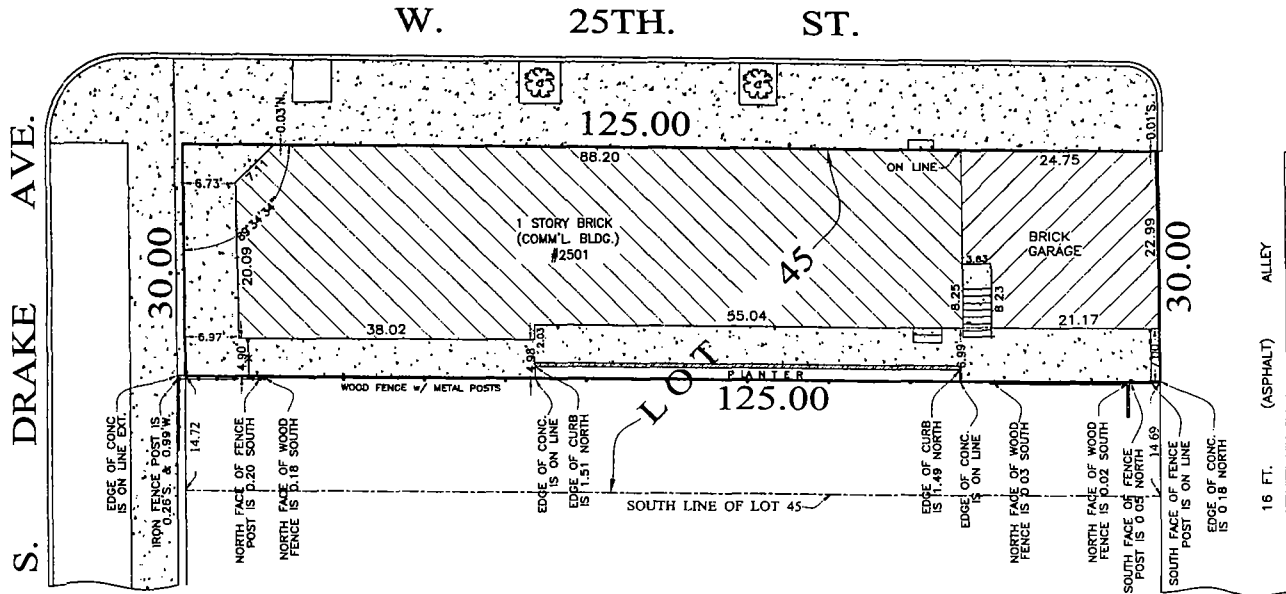
