ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 3H in the area bounded by:

The public alley perpendicular to North Ashland Avenue and north of and parallel to North Chicago Avenue; a line perpendicular to West Chicago Avenue and 106' west of and parallel to North Ashland Avenue; West Chicago Avenue; and a line perpendicular to West Chicago Avenue and 153' west of and parallel to North Ashland Avenue.

To those of a B3-2 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
