
The applicant intends to use the subject property for the addition of one dwelling unit to be added to the basement of the existing building. This will increase the number of dwelling units from 18 to 19.

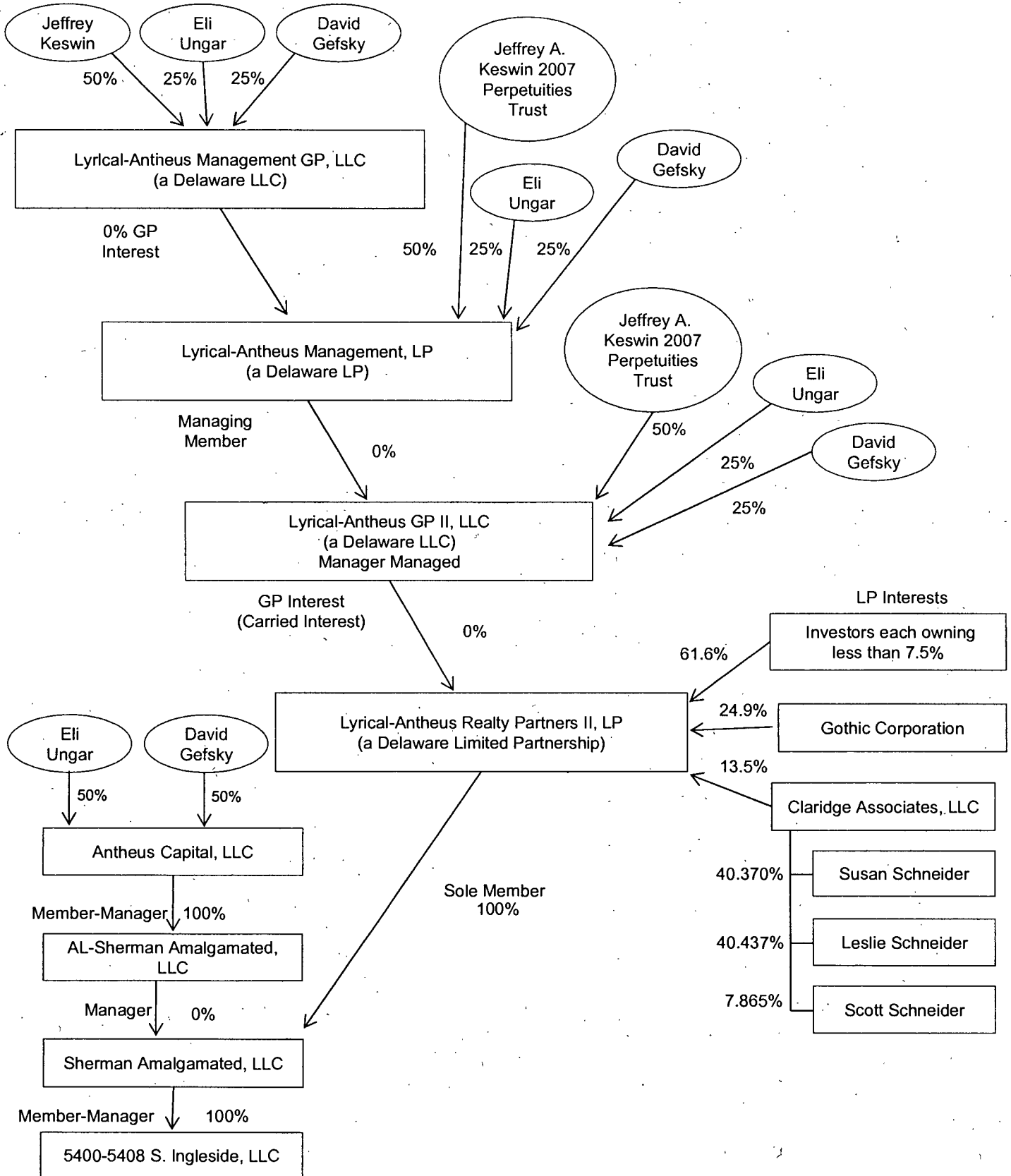


