ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the Industrial Planned Development Number 1151 District, M1-1 Limited Manufacturing/Business Park District and M2-2 Light Industry District symbols and indications as shown on Map No. 9-I in the area bounded by

a line 323.03 feet north of and parallel to West Roscoe Street; the west line of the North Branch of the Chicago River; West Roscoe Street; a line 349 feet east of and parallel to North California Avenue; a line 378 feet north of and parallel to West Melrose Street; a line 300 feet east of and parallel to North California Street; a line 128 feet north of and parallel to West Melrose Street; the alley next east of and parallel to North California Avenue; West Melrose Street; North California Avenue; a line 267 feet north of and parallel to West Roscoe Street; and a line 275.79 feet east of and parallel to North California Avenue,




If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded or void), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City. 
