2858 S SPRINGFIELD CORP

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 2858 S SPRINGFIELD CORP, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Light Fixture(s) projecting over the public right-of-way adjacent to its premises known as 2858 S. Springfield Ave..

Said Light Fixture(s) at S. Springfield Avenue measure(s):

One (1) at one (1) foot in length, point six six (.66) feet in width and twelve point zero eight (12.08) feet above grade level.

One (1) at one (1) foot in length, point eight three (.83) feet in width and eleven point seven five (11.75) feet above grade level.

One (1) at one (1) foot in length, point six six (.66) feet in width and twelve point three three (12.33) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1137694 herein granted the sum of eighty-five (\$85.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

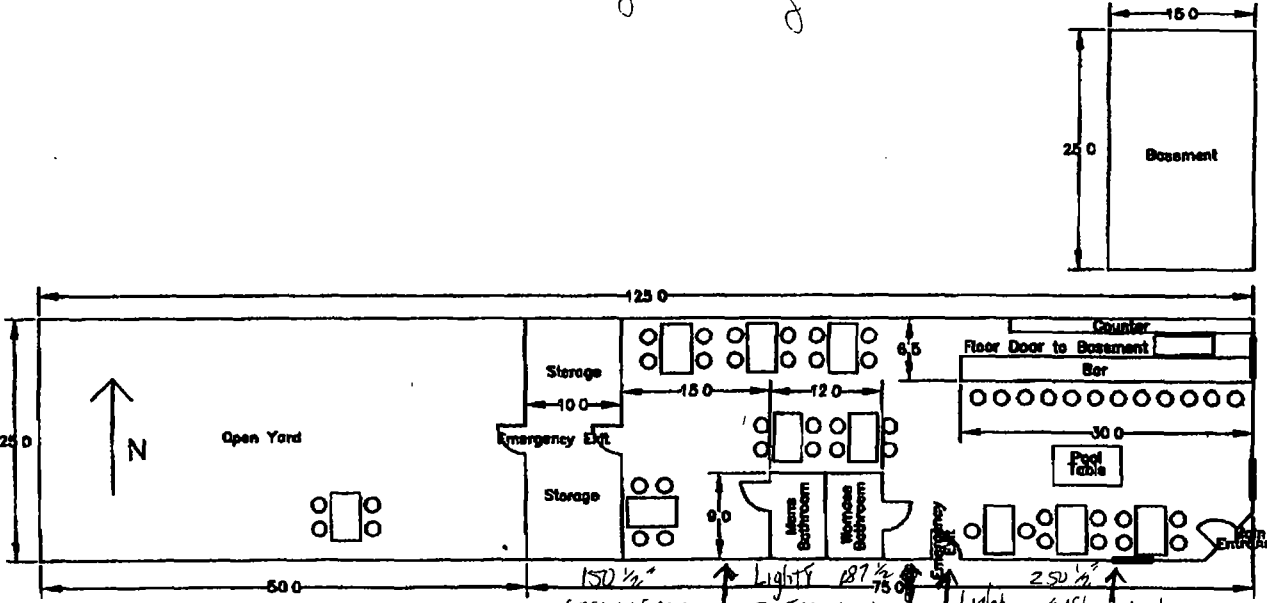
