## ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No.5-1 in the area bounded by

North Milwaukee Avenue; a line 119 feet southeast of and parallel to North Prindiville Street; a line 121.82 feet southwest of and parallel to North Milwaukee Avenue; a line 75 feet southeast of and parallel to North Prindiville Street; a line 117.93 feet southwest of and parallel to North Milwaukee Avenue; and North Prindiville Street,

to those of a C1-5 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

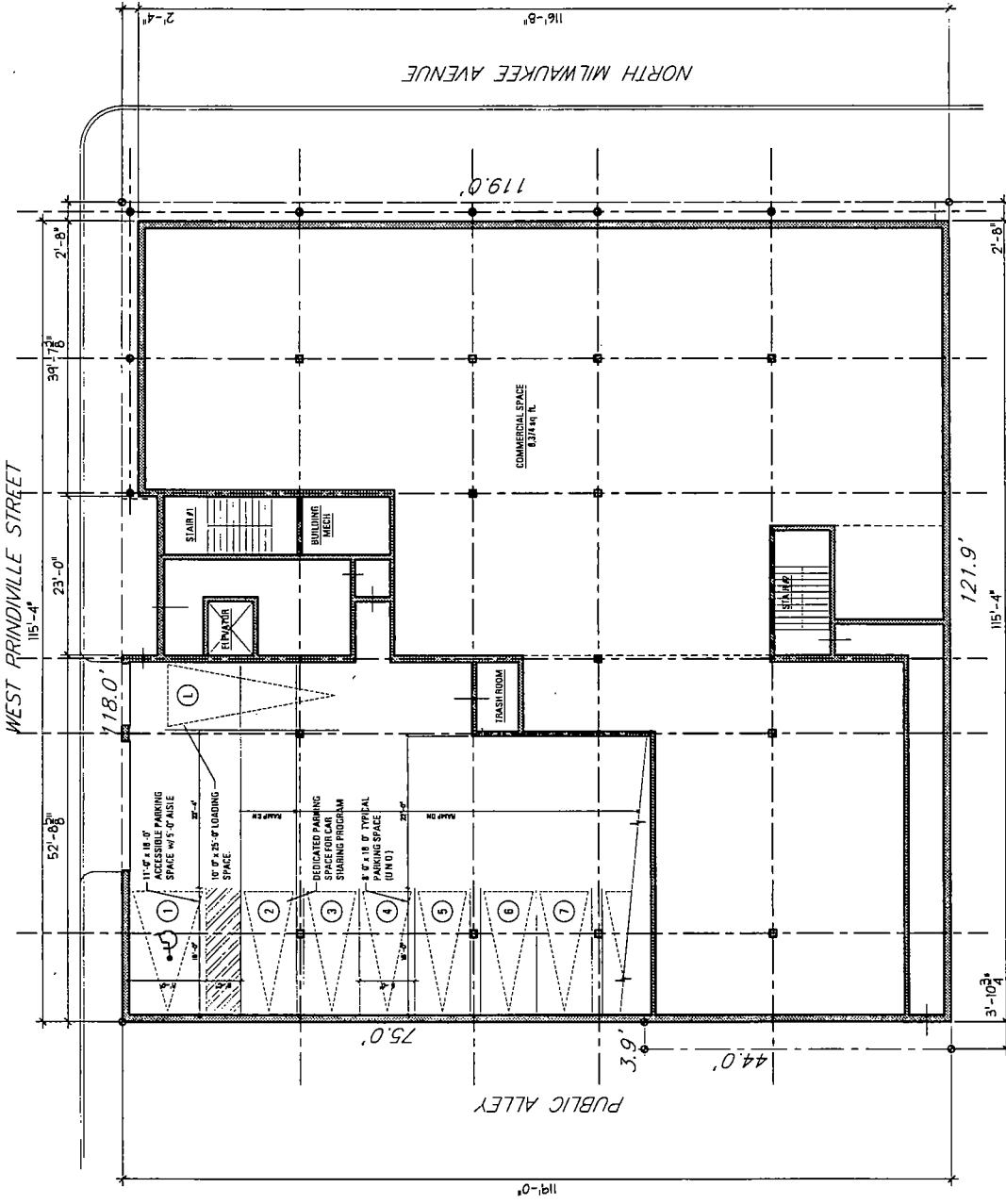
BASEMENT PLAN - 10,693 sq. ft.

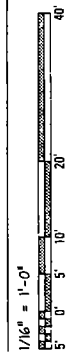

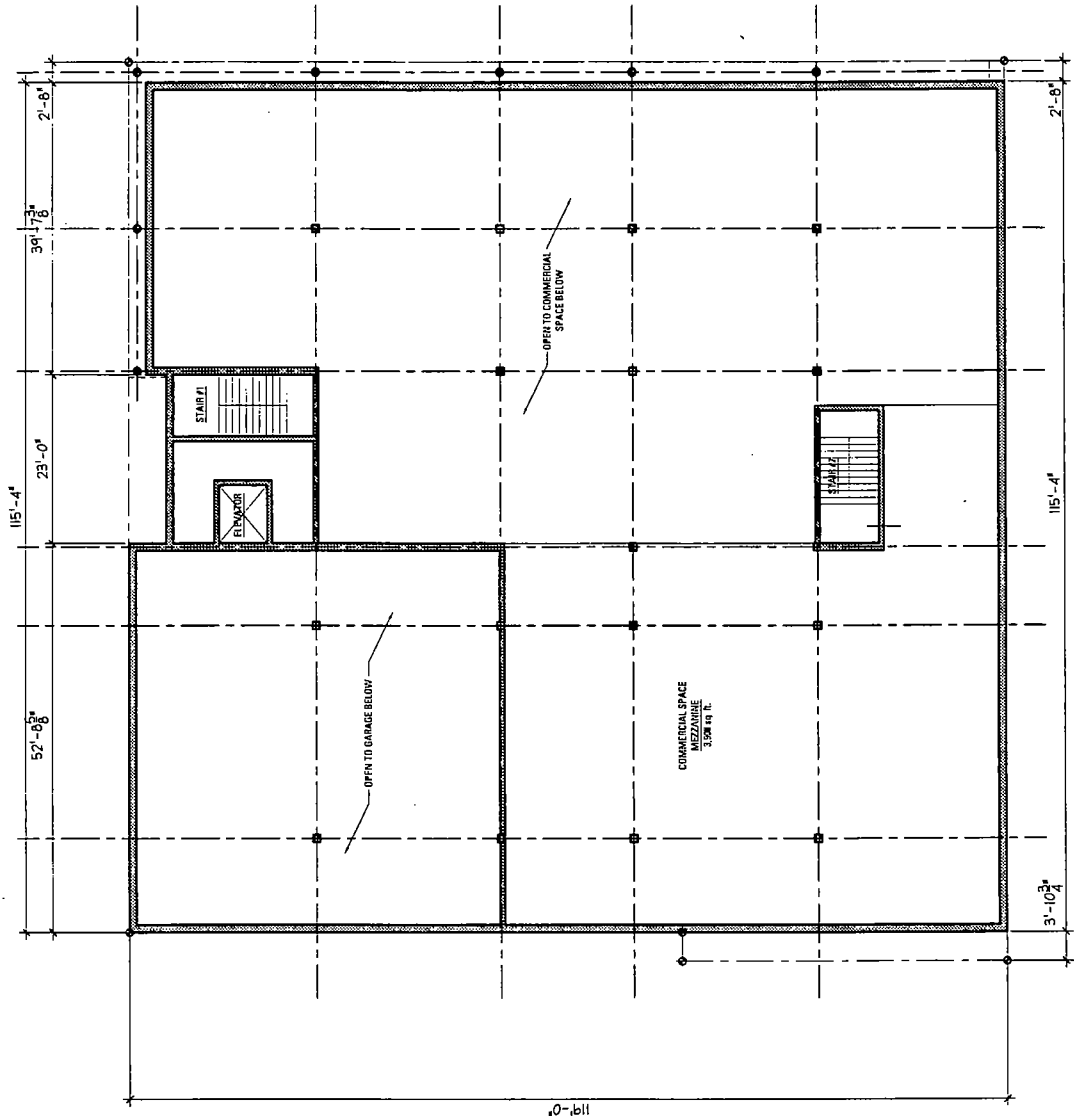


FIRST FLOOR PLAN - 9,739 Sq. ft.

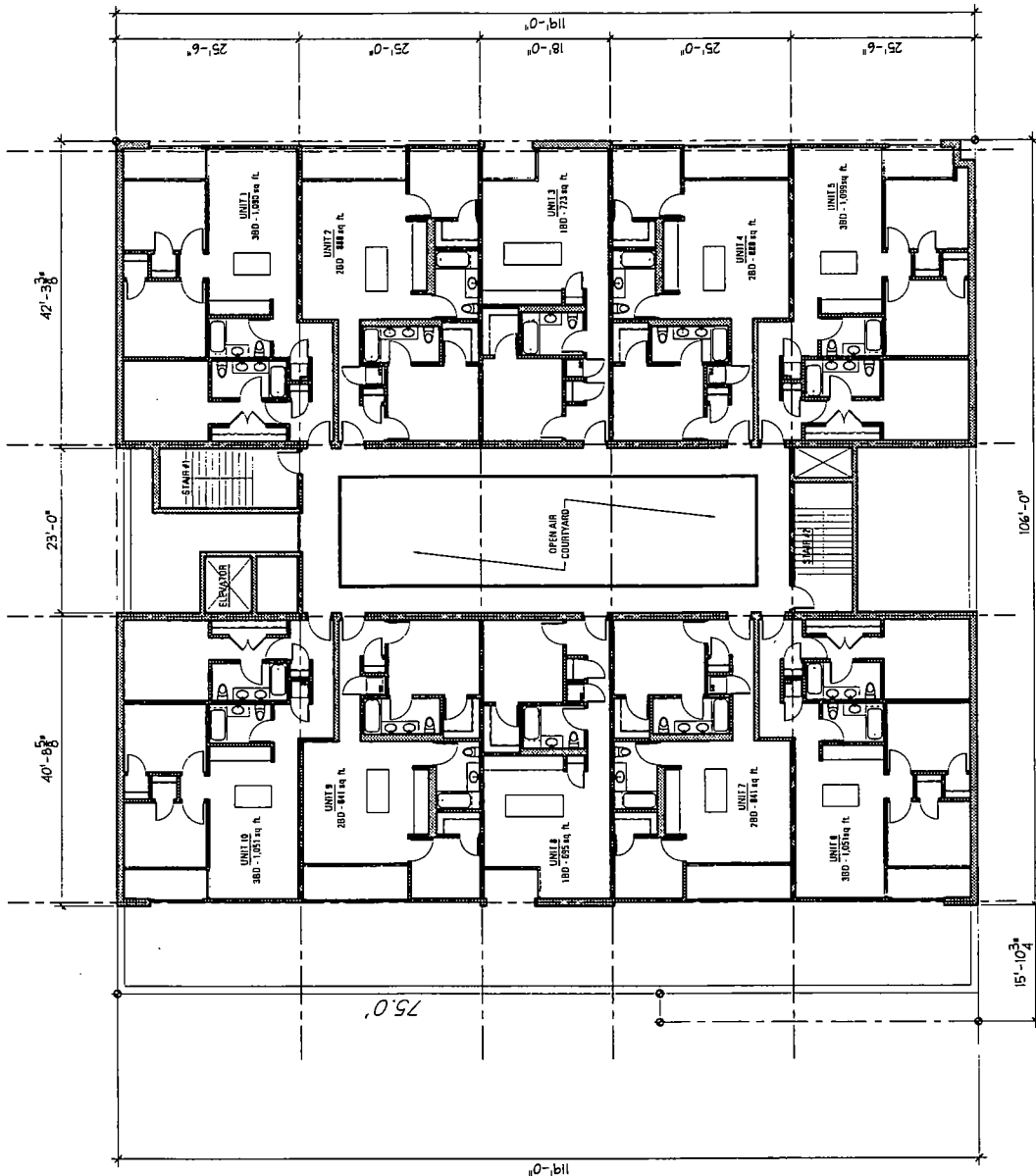

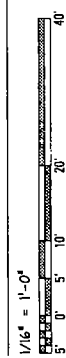

SECOND FLOOR PLAN - 10,394 sq. ft.

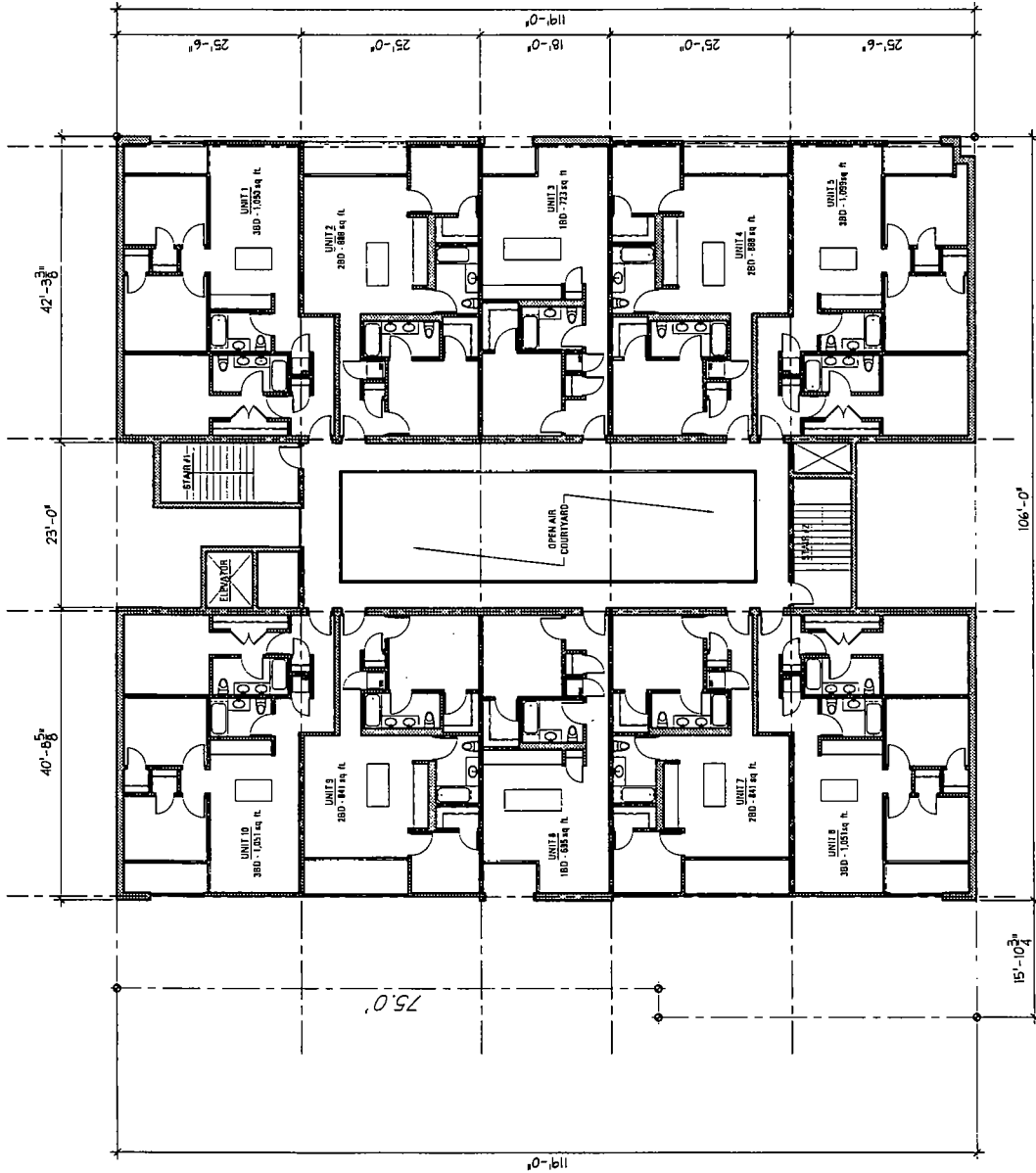

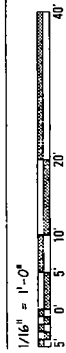

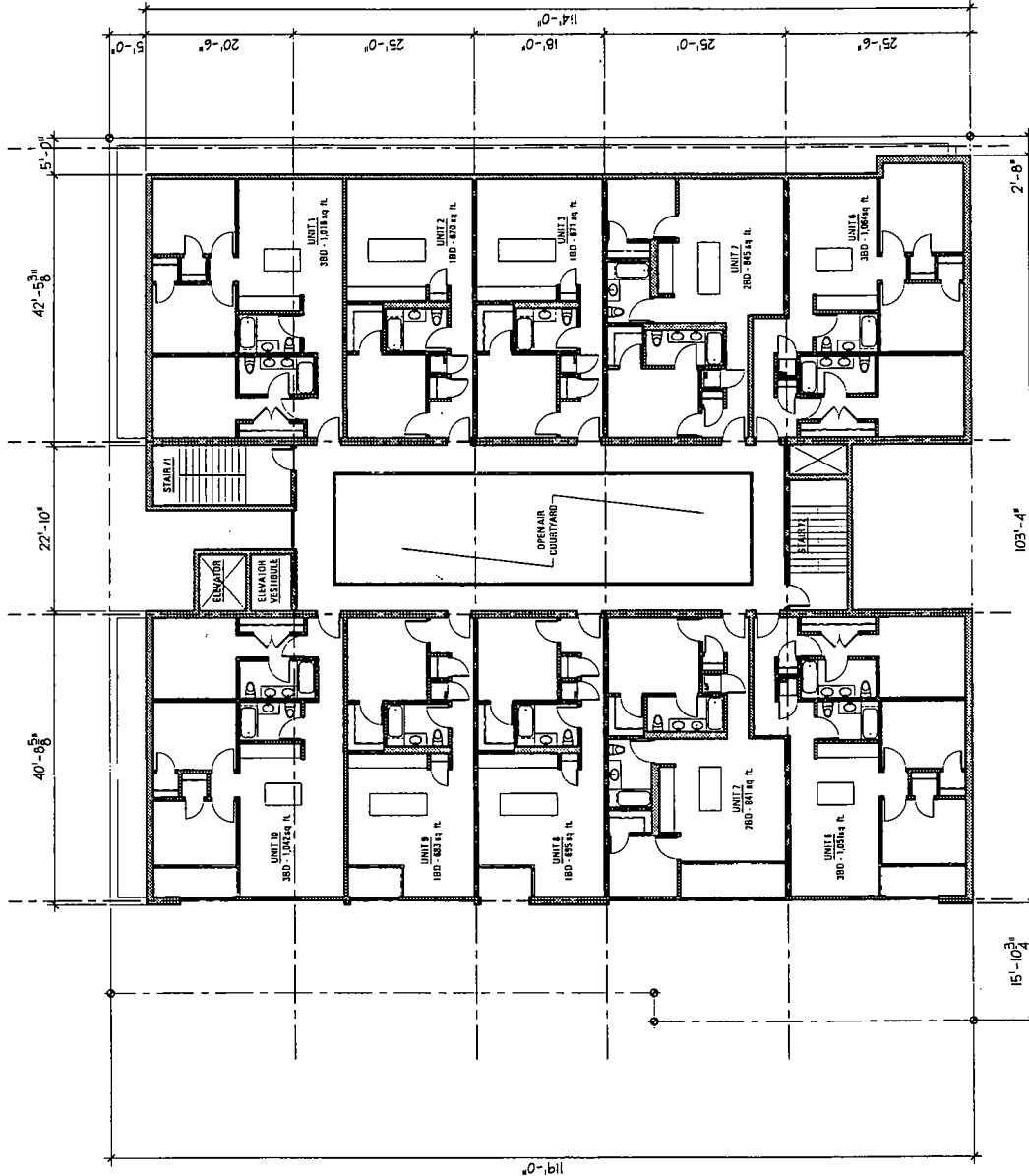
THIRD & FOURTH FLOOR PLAN - 10,394 sq. ft.

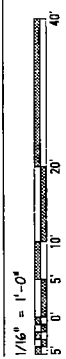

FIFTH FLOOR PLAN - 9,794 sq. ft.

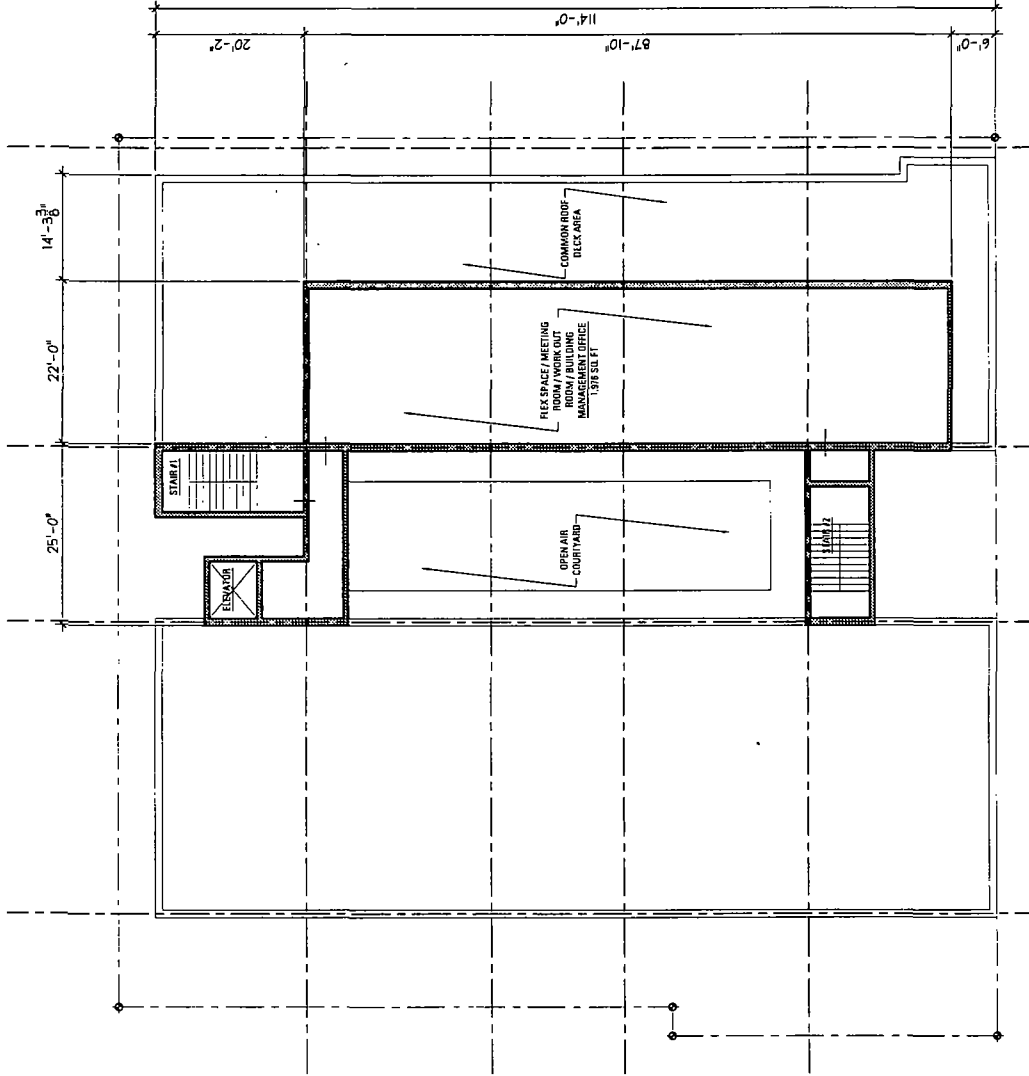

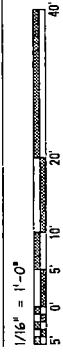

PENTHOUSE / SIXTH FLOOR PLAN - 2,719 sq. ft.

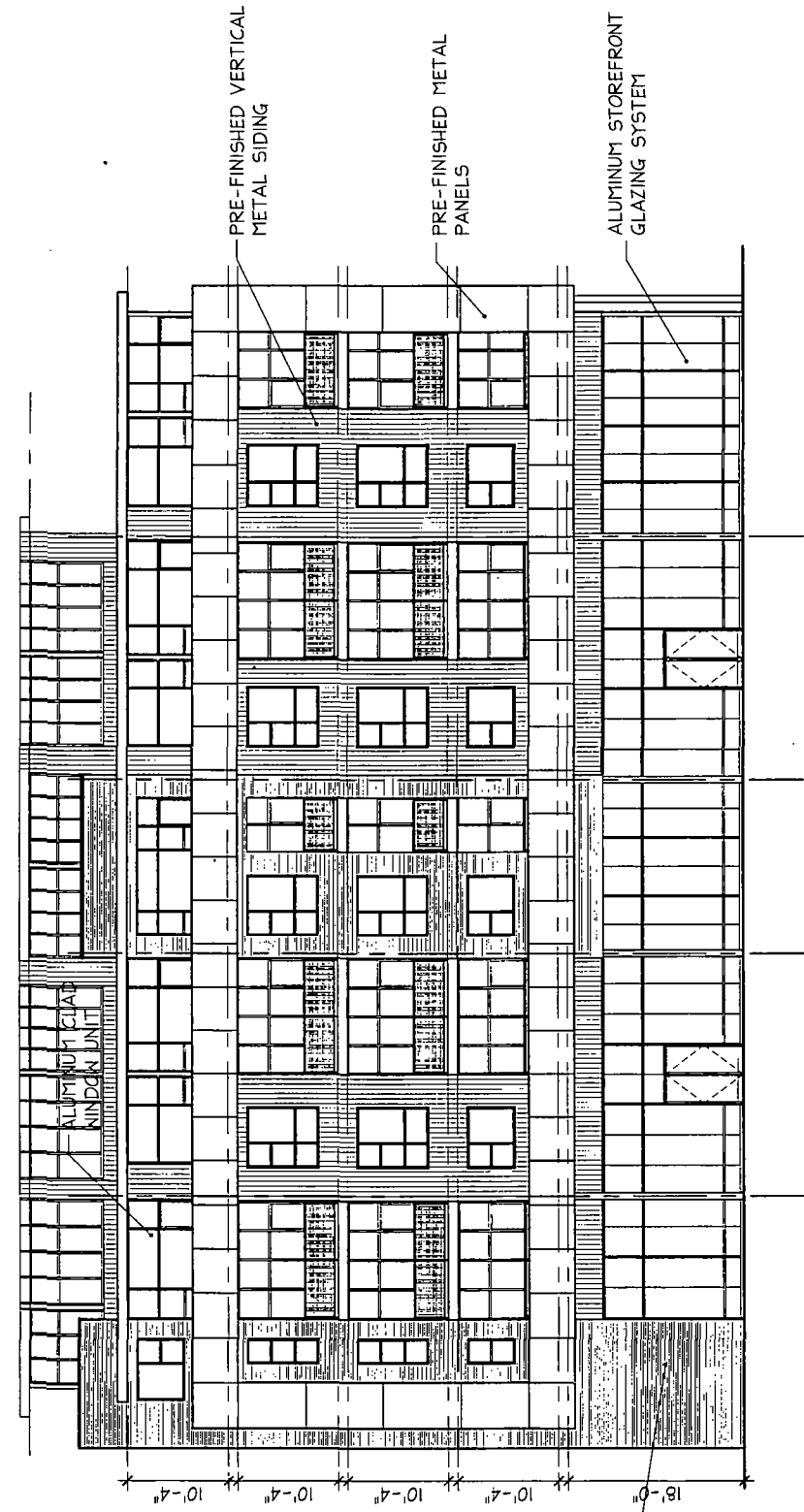
