**ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the B3-2 Community Shopping District and RT4 Residential Two-Flat Townhouse and Multi-Unit District symbols and indications as shown on Map No.15-I in the area bounded by

West Devon Avenue; North Whipple Street; a line 239 feet south of and parallel to West Devon Avenue; the alley next west of and parallel to North Whipple Street; the alley next south of and parallel to West Devon Avenue; and a line 157 feet west of and parallel to North Whipple Street;

to those of a B3-2 Community Shopping District is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and publication.
