WHEREAS, Susan L. Conley is an avid dog lover who dotes on her beloved Shaggy, Seamus and Stuie; and


WHEREAS, Susan L. Conley is known for her "Sue-isms" which reflect her colorful nature and directness, and add levity to even the most serious of inquiries; and
