#### **ORDINANCE**

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1 — Pursuant to Title 9, Chapter 64, Section 090 of the Municipal Code of Chicago, portions of the below named streets are hereby designated as residential parking zone for the following locations:

And that the ordinances heretofore passed by the City Council establishing a single, consolidated Residential Parking Zones in the area with boundaries North Claremont Avenue to the west, North Hamilton Avenue to the east, West Devon Avenue on the north and West Granville Avenue on the south, in addition to a portion of West Rosemont Avenue,
