ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 17-I in the area bound by

a line 101.1 feet south of and parallel to West North Shore Avenue; the alley next east of and parallel to North Maplewood Avenue; a line 134.1 feet south of and parallel to West North Shore Avenue; and North Maplewood Avenue

to those of a RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

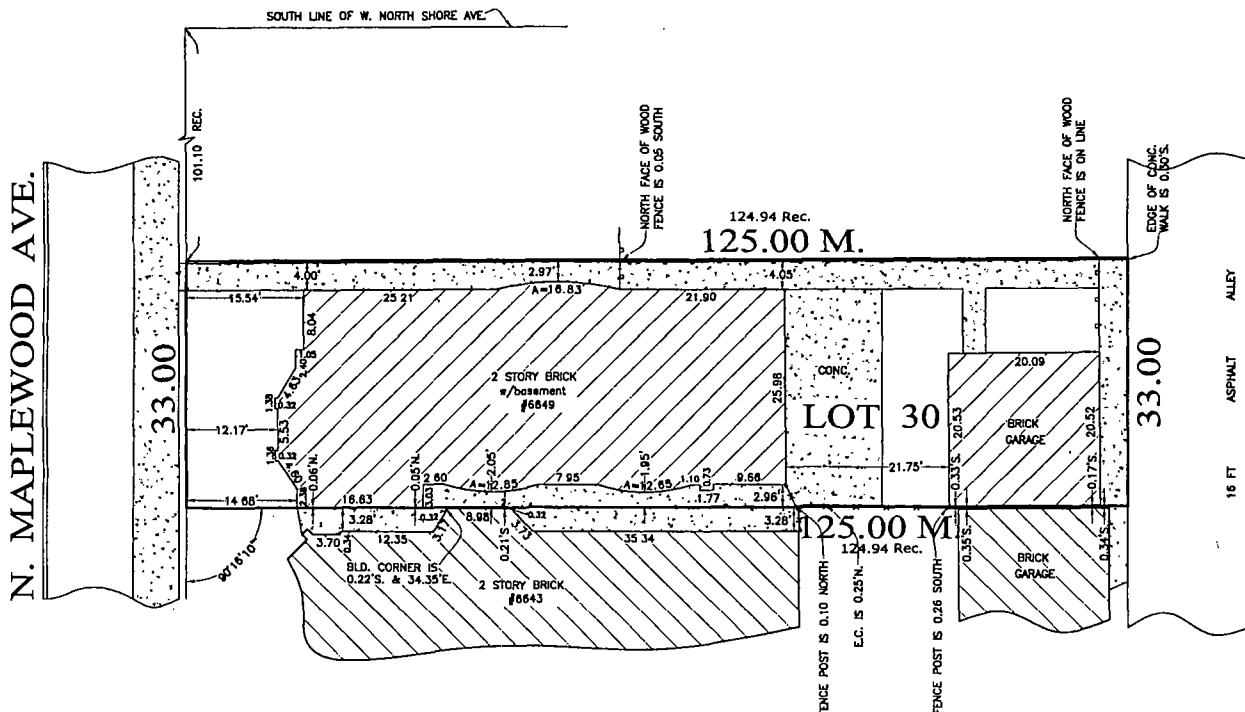
