ORDINANCE GIBSONS L.L.C. Acct. No. 64192 - 4 Permit No. 1115634

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GIBSONS L.L.C., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1028 N. Rush St..

Said Awning(s) at N. RUSH measure(s):

One (1) at five (5) feet in length, and three (3) feet in width for a total of fifteen (15) square feet.

Said Awning(s) at N. RUSH measure(s):

One (1) at nineteen point six (19.6) feet in length, and six (6) feet in width for a total of one hundred seventeen point six (117.6) square feet.

Said Awning(s) at N. RUSH measure(s):

One (1) at seventeen point two (17.2) feet in length, and five point eight (5.8) feet in width for a total of ninety-nine point seven six (99.76) square feet.

Said Awning(s) at e. bellevue pl measure(s):

One (1) at sixty-five point three (65.3) feet in length, and three point five (3.5) feet in width for a total of two hundred twenty-eight point five (228.55) square feet.

Said Awning(s) at n. state measure(s):

One (1) at four point nine (4.9) feet in length, and three (3) feet in width for a total of fourteen point seven (14.7) square feet.

Said Awning(s) at n. state measure(s):

One (1) at four point one (4.1) feet in length, and three (3) feet in width for a total of twelve point three (12.3) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1115634 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 11/15/2014.
