BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the C1-3 Neighborhood Commercial) District symbols and indications as shown on Map No. 5-H in the area bounded by

The alley next north of and parallel to West North Avenue; a line 52.23 feet east of and parallel to North Damen Avenue; West North Avenue; and North Damen Avenue,

to those of a C1-3 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

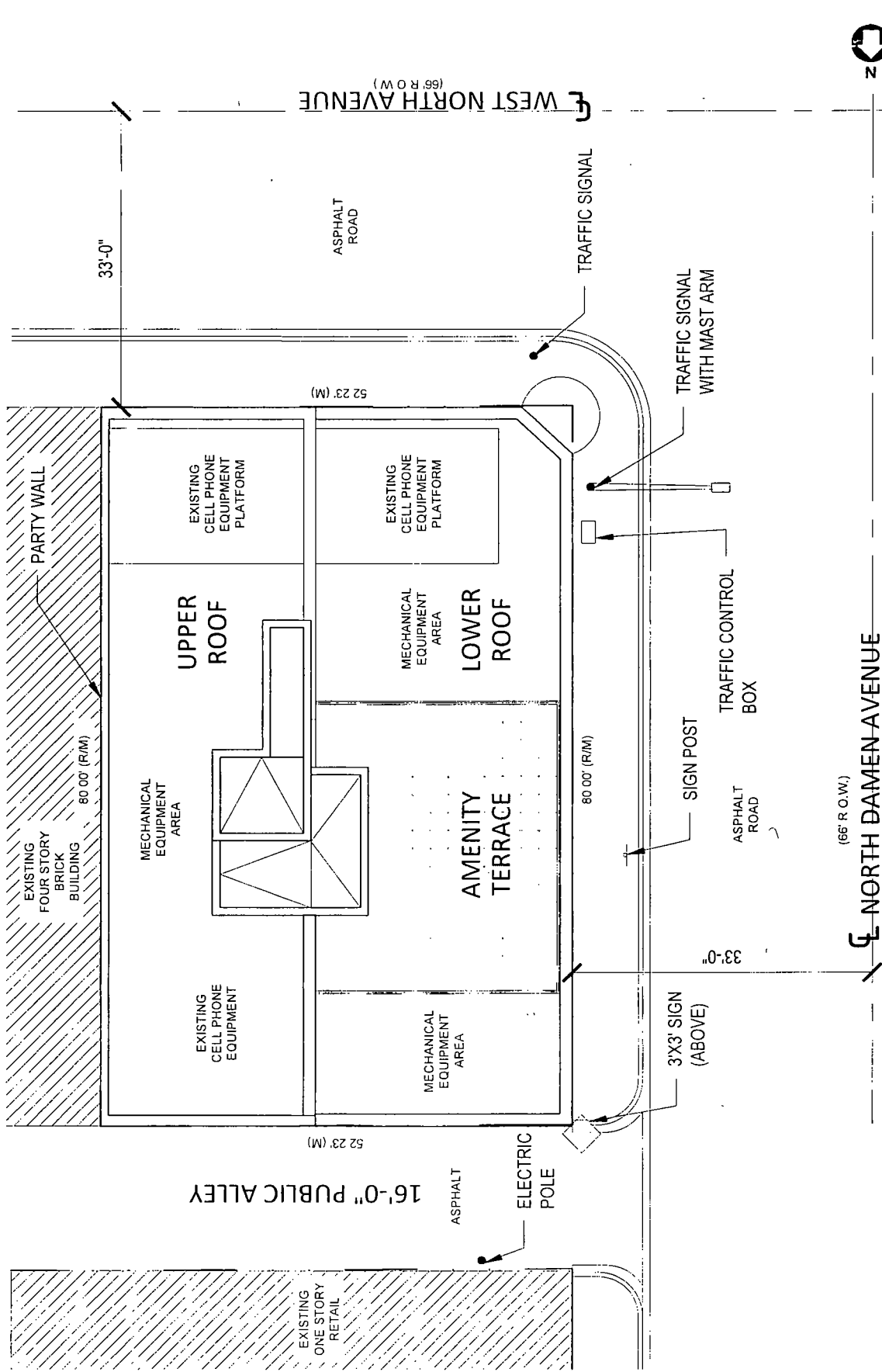
Proposed Land Use: The Applicant is proposing an adaptive reuse and additions to the existing three and four-story multi-unit building. The building will contain approximately 2,910 sq. ft. of retail space at grade and a total of nine (9) residential units above. The building will measure approximately 56 ft.-9 inches in height measured to the rooftop terrace, and approximately 63 ft.-6 inches in height measured to the top of the elevator override. The subject property is a contributing building in the Milwaukee Avenue Historic District. The subject property is also a Transit Served Location because it is located within approximately 250 ft. of the Damen Ave. CTA Station. Off-street parking is not currently provided at the subject property. No new off-street parking will be provided for this project.
