ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No.15-G in the area bounded by

West Devon Avenue; a line 69.50 feet east of and parallel to North Magnolia Avenue; a line 90 feet south of and parallel to West Devon Avenue; the alley next east of and parallel to North Magnolia Avenue; a line 100 feet south of and parallel to West Devon Avenue; and North Magnolia Avenue,

to those of a B3-2 Community Shopping District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
