**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

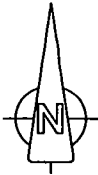
**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 4-H in the area bounded by:**

**West 17<sup>th</sup> Street; a line 120.50 feet West of and parallel to South Wood Street; the public alley next South of and parallel to West 17th Street; a line 144.50 feet West of and parallel to South Wood Street.**

**To those of a B2-2, Neighborhood Mixed-Use District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**
