BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit
(Detached House) District symbols as shown on Map No. 3 - I
in the area bounded by:

A line 266 feet south of and parallel to West North Avenue; the public alley next east of and parallel to North Maplewood Avenue; a line 291 feet south of and parallel to West North Avenue; North Maplewood Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about February 21, 2018 the undersigned will file an Application for a change in zoning from an RS3 Residential Single–Unit (Detached House) District to an RM4.5 Residential Multi-Unit District on behalf of the Applicant, Virage LLC, for the property located at 1531 North Maplewood Ave., Chicago, Illinois.

The subject property is currently vacant. The Applicant intends to build a new 3-story three dwelling unit residential building. The Applicant needs a zoning change in order to comply with the minimum lot area and the maximum floor area requirements of the Zoning Ordinance.
